1.0 PURPOSE OF THE REPORT

1.1 To review the Programme of Work for 2012/13.

2.0 BACKGROUND

2.1 The original Annual Work Programme for 2012/13 was based on four meetings per annum plus one (in June) to consider the draft Statement of Final Accounts (SOFA).
