#### RESIGNATION OF HENRY CRONIN FROM THE COMMITTEE

Report of the Assistant Chief Executive (Legal and Democratic Services)

# 1.0 PURPOSE OF THE REPORT

1.1 To advise the Committee of the resignation of Henry Cronin from the Committee and to recommend that no action be taken, prior to the County Council elections in May 2013, to fill the resultant casual vacancy.

#### 2.0 **RESIGNATION**

2.1 Henry Cronin has resigned from 1 of the 3 positions of External Member on this Committee. The text of his resignation is appended. Had Henry Cronin not resigned, his term of appointment would have concluded on 2 May 2014.

# 3.0 RESULTANT CASUAL VACANCY

- 3.1 Previously it has taken approximately 4 months to recruit and appoint External Members to serve on this Committee.
- 3.2 If recruitment started immediately, to fill the casual vacancy which has resulted from Henry Cronin's resignation, it is likely that an appointment would be made at the County Council meeting on 20 February 2013. However, the term of that appointment would be relatively short, ie 15 months, to coincide with the end of the term of appointment of James Daglish and David Portlock.
- 3.3 Immediately after the County Council elections on 2 May 2013, each County Council committee, whose membership includes External/Co-opted Members, is scheduled to consider how many of such seats there should be on that Committee in future. This Committee is due, in June 2013, to consider how many External Members there should be on this Committee for the period from 3 May 2014. Subsequently, between June 2013 and May 2014, a recruitment and appointment process will be undertaken to fill that number of seats.
- 3.4 In the circumstances, it is suggested that no action should be taken, prior to the County Council elections on 2 May 2013, to fill the casual vacancy resulting from Henry Cronin's resignation.

# 4.0 **RECOMMENDATION**

- (a) That Henry Cronin's resignation from this Committee be noted.
- (b) That no action be taken, prior to the County Council elections in May 2013, to fill the casual vacancy resulting from Henry Cronin's resignation.
