## Allerton Waste Recovery Park Landscape and Cultural Heritage Fund

## Report of the Assistant Director - Transport, Waste and Countryside Services

## 1.0 Purpose of Report:

- 1.1 To report to the Corporate Director Business and Environmental Services (BES) and to the BES Executive Members on the expenditure profile for the Allerton Waste Recovery Park (AWRP) Landscape and Cultural Heritage Fund.
- 1.2 To seek approval from the Corporate Director BES for release of funding for projects highlighted in Appendix A of this report.

#### 2.0 Background

- 2.1 The Section 106 Agreement for AWRP was signed on 14 February 2013 and included the requirement for the Council to establish a Landscape and Cultural Heritage Fund (LCHF).
- 2.2 The LCHF is to be used towards reducing the visual and landscape impacts of the development and the delivery of enhancement and strengthening of the local landscape character, biodiversity and/or features of cultural heritage prioritised within a 3.5km radius of the Site. It is informed by the Landscape Management Strategy developed by AmeyCespa and approved by the Planning Authority which includes a Conservation Management Plan and Outline Habitat Management Plan. The value of the LCHF is £839,500
- 2.3 On 18 September 2015, a report was approved by BES Executive Members to enter into a five year contract with Two Ridings Community Foundation (TRCF) to manage distribution of the LCHF on behalf of the County Council. The contract began on 23 November 2015.
- 2.4 The small grants fund (£100 to £1,000) was launched in October 2015, the large grants fund (£10,001 to £50,000) was opened in December 2015 and the medium grants fund (£1,001 to £10,000) was opened in early 2017.
- 2.5 The large grant element of the Fund has been oversubscribed and the Fund has consequently been suspended for large grants. The large grant fund could be reopened depending upon the small and medium fund future take up.
- 2.6 Funding for small grants can be released by TRCF providing that the projects meet the necessary requirements set out in the guidance information and application process.
- 2.7 Applications for the medium grant fund are normally assessed at an independent panel meeting. The panel is made up of NYCC and HBC Councillors, the local community, technical advisors and TRCF. Two meetings are held per year to maximise scope for delivery of projects taking into account planting and seasonal activities.

2.8 Authority was delegated by the Corporate Director Business and Environmental Services (BES) in consultation with the BES Executive Members on 27 January 2017 to enable TRCF to decide some medium grant fund applications through a fast track process.

## 3.0 Outcome of Panel Meeting (Medium Grants)

3.1 The sixth panel meeting took place on 31 July 2018 and considered six projects. Five of the six projects were awarded funding. One of the five projects was identified as more suitable to be processed under the small grants scheme. Details of the projects and Panel recommendations are summarised in the table below. More detailed information on the four projects awarded funding under the medium grants scheme can be found in the Panel sheets in appendix B.

Panel agreed contribution of 50% subject to the group raising the other 50% within 12 months.

## 4.0 Small Grants Update

4.1 The small project grants (£100 to £1,000) are being managed by Two Ridings. Since the launch of the fund in October 2015, twenty six awards have been made. Below summarises the awards made since the last update to BES Executive Members on 2 March 2018:

## 5.0 Progress update

- 5.1 Appendix A provides details of project spend to date and a progress update on the various projects. End of grant reports have been received for the majority of the completed projects.
- 5.2 A press release of the new paths and planting which took place in St. Bartholomew's Parish Churchyard in Arkendale, which received over £30,000, was issued in May 2018 to promote the success of the fund so far. This generated media coverage in the Harrogate Advertiser. TRCF will be arranging further photo opportunities which will be issued with a press release to promote the success of the fund.
- 5.3 The second annual contract review meeting took place on 28 March 2018 with officers from both TRCF and NYCC. It was agreed to publicise the small grants scheme further. This will be done using various promotional methods including distributing seed packets at community events which contain a seed mix to increase pollinating insects in the area. 500 packets will be produced on bespoke printed packets providing details of the fund. In addition to this a voucher to the value of £15 will be sent home with local school children (over 300 children at the 4 local schools) whom they can spend on bird boxes, bat boxes and bug hotels.
- 5.4 An annual report produced by TRCF was submitted to the NYCC Waste Planning Authority outlining the progress made towards fulfilling the purposes of the LCHF. This is the second annual report submitted to date.
- 5.5 To date £19,808.73 has been returned from three large grant projects and one small grant project. All three of the large grant projects were supported by Groundworks who helped individuals/groups develop their project documentation. Part of this process included estimating various amounts for works which have subsequently all come in under budget and the money has been returned to the fund. There was also a minor underspend to one small grant project.

#### 6.0 Legal Implications

- In accordance with the previous report, funding release for large and medium projects will be subject to the standard NYCC Terms and Conditions.
- 6.2 Claw back provisions are included as part of the grant agreements which will protect the longevity of the funds impacts and projects undertaken.

## 7.0 Financial Implications

- 7.1 The fund was launched in October 2015 and to date 49 projects have received funding comprising of 26 small grants (£23,669), 8 medium grants (£64,646) and 15 large grants (£476,809). A total of £565,124. If the funds are approved for release at this meeting then the total funding for projects awarded will be £588,235.50.
- 7.2 NYCC has a contract with TRCF to deliver the fund for four years with an option to extend for one further year. A budget has been allocated for the LCHF and no additional funding will be required.

## 8.0 Equalities Implications

- 8.1 TRCF has a robust equalities policy in place which is used as part of the fund assessment process. The equalities information is collected through the application forms for the medium and large grants fund and proportional information is collected in relation to the small grants fund. Information about funding awards to date is used to inform specific targeted marketing/outreach activities to ensure that the LCHF process is accessible to the widest audience given the parameters on the fund set by the planning process.
- 8.2 During the annual contract review meetings it has been identified that TRCF should focus promotion in the west of the fund area as less spending has taken place there. To address this TRCF are targeting the west of the fund area with the bespoke seed packets and school wildlife box promotion.
- 8.3 Following the annual contract review meeting an Equalities Impact Assessment (EIA) has been completed by TRCF on the LCHF. The outcome is no adverse impact and therefore no change needed. Information on the TRCF equalities policy has also been provided to NYCC.
- 8.4 An Equality Impact Assessment screening form has been completed by NYCC and it concludes a full EIA is not relevant or proportionate. The completed form is in appendix C.

#### 9.0 Recommendations

- 9.1 That the Corporate Director (BES) approve the release of funding for the project(s) highlighted in appendix A LCHF project spend to date.
- 9.2 Subject to such approval, that the AD WACs releases project funding to Two Ridings Community Foundation to manage awards to these successful projects in line with the conditions set by the panel.

#### Organisation aims & main activities:

The primary object of our Parochial Church Council is the promotion of the Gospel according to the doctrines and practices of the Church of England. The Parochial Church Council co-operates with the minister in promoting in the parish the whole mission of the Church, pastoral, evangelistic, social and ecumenical.

## **Grants Officer Comments:**

This is a cultural heritage project which will ensure that the church clock keeps time for the local residents as it has done for many years. Currently the clock is wound manually on a weekly basis by a local volunteer who is not a member of the church congregation but simply has an interest in the clock (and a head for heights). It is a laborious process and also a health and safety risk as it involves climbing up into the church tower by means of a ladder. The electrification of the clock will remove the need for manual winding and restore the hourly chimes that no longer work due to the current complexity of managing the mechanism.

The PCC have consulted with local residents via a parish council meeting where it was voted that the reinstatement of the hourly chimes was desirable for the local community.

Quotes have been provided so it is unclear why they need contingencies for this project although the quote from their preferred supplier is a year old. The £500 raised so far has not been included in the amount requested so probably relates to contingencies and therefore may or may not be used. It doesn't seem unreasonable that the PCC might be expected to make a contribution especially having received funding previously so I would recommend removing the contingencies and also reducing any offer by a further £500 to £5143.00.

It is also likely that faculty approval will be required.

Part of the scheme is about preserving local cultural heritage in the area which is invested not only in buildings and landscape restoration but sometimes less tangible things that enhance 'a sense of place', this of course can be quite subjective and debateable but on balance I feel that this project could reasonably be funded through the scheme if the panel consider it a priority.

If funding is offered, the following conditions are suggested:-

- Contingencies for this project cannot be supported and confirmation must be provided that any balance needed to complete the project as outlined in the application are in place prior to draw down of funds.
- Confirmation of faculty approval and any other necessary permissions are in place prior to draw down of grant.

## **Grants Officer Comments:**

This application is very similar to others funded previously for Marton Cum Grafton primary school and also for Kirk Hammerton primary school in its ambition to create a wildlife area at the school complete with outdoor learning facility. The group are very enthusiastic and have the full support of the school and a knowledgeable school gardener to guide them. Much of the work will be undertaken by volunteers with support from the school gardener. The Friends group are also planning to run a regular after school gardening club to help with maintaining the area and this will be run by volunteers. The application is well planned and thought through in terms of the suggested planting (although honeysuckle and dog rose are not recommended) and has the added interest of getting the children involved with an enterprise project of harvesting their apples to make and sell juice. The project is straightforward and a good fit with the aims of the scheme in terms of both planting to increase biodiversity and the cultural heritage & educational aspect of outdoor learning and harvesting of produce.

This project is about documenting and thereby preserving the local cultural heritage of the Hay a Park area which sits on the western edge of the LCHF boundary with the majority of the area sitting within the 3.5km priority area. The applicant lives in the area and is a historic buildings surveyor/architectural historian by profession however this project has been developed as a result of a personal interest in the area in which she lives. Jen is semi-retired and will be putting in a substantial amount of time at no cost, there are no costs included for research time as she describes it as her 'personal obsession'. She is hugely passionate about the area and the project and will also be securing professional geologist services at no cost as this will be undertaken by her brother. Jen is experienced at working with volunteers having undertaken similar projects funded by HBC, Historic England and the National Trust which has involved working with and teaching local history groups. In a similar way, this project will involve a core of local volunteers and dissemination of information to the local community.

There are no public roads through the Hay a Park area but there are a number of footpaths and walking routes but no information about the local landscape and its significance in local cultural heritage.

The project is supported by the archaeologists at NYCC who advised that little is known about the area and the project will be of benefit to them, they are keen to work with Jen to get the information input directly into their archives and this will form part of the project.

The majority of the costs are for the capital equipment needed to support the work, laptop, projector, printer and consumables together with the cost of publication of a book documenting the research. Quotes have been provided for all of these costs and any proceeds from the sale of the book will be donated to a local charity or community group.

There is a huge amount of added value to this project in terms of Jen's time and expertise and volunteer engagement. There will also be a long lasting legacy as information is documented and archived and the potential for a local history group to continue with the interpretation to bring it to the wider public.

Funding is recommended subject to the following conditions:-

Proceeds from the sale of books to be donated to a local charity/community group to be agreed with TRCF to be in keeping with the aims of the fund in relation to supporting the area of benefit. Information also to be published online.

Capital assets, laptop, projector etc to be passed into the ownership of a local charity/ community group on completion of the project to be agreed with TRCF

Revised breakdown of costs to be submitted to reflect the maximum award available of £10k

Staged payments to be made and peer review of book draft to be undertaken prior to publishing to confirm the integrity of the research and findings.

#### **Grants Officer Comments:**

This is a project with two aspects, clearing an extensive amount of Himalayan Balsam upstream of the Fishpond bridge area of the Ouse Gill Beck and also creating a wildlife area on a small piece of land next to the allotments owned by the parish council which is currently overgrown and unmanaged.

The creation of the wildlife area will involve controlling the overgrowth, planting a variety of nectar rich plants for insects, moths and butterflies and also creating a small pond for amphibians.

TCV have the agreement of two private land owners where the Himalayan Balsam is a problem and will undertake a two year programme of removal to prevent seed dispersal downstream.

TCV will provide 20 work days with up to 10 volunteers each day and also aim to attract local volunteers to get involved so that they can impart the skills needed for ongoing management particularly in relation to the balsam removal and are aiming to get as many people involved as possible to maximise the impact.

The project plan appears to be well thought through and is supported by the Management Information System that TCV use to monitor the success of their projects. This allows them to keep records of each day's work including the exact location of the work party, the amount of balsam removed, number of volunteers etc They will also record the quantity of balsam removed so they can demonstrate the effect of preventing seed dispersal from year 1 to year 2.

The costs appear to be high but if they are successful in bringing in a good number of volunteers in addition to their core of 10 it could demonstrate good value for money.
