Blue badge parking bay, Oxcliff, Scarborough – Proposed Changes to Traffic Regulation Orders

Report of the Assistant Director – Highways and Transportation

1.0 Purpose Of Report

1.1 To enable the Corporate Director - Business and Environmental Services (BES) and the BES Executive Members to consider objections and comments received following public consultation and statutory advertisement carried out in July/August 2020 for proposed changes to traffic regulation orders at Oxcliff, Scarborough.

2.0 Background

- 2.1 Oxcliff is a residential street at the northern end of the central part of Scarborough. It has junctions with Wreyfield Drive at its northern end and Barrowcliffe Road at its southern end. The proposal is located in the section between Wreyfield Drive and Bracken Hill. There are no parking restrictions and no existing blue badge parking bays on the street.
- 2.2 In total approximately 59 properties have a frontage on Oxcliff but there are 34 frontages in this section. On-street parking is primarily residential.

3.0 Proposals

3.1 The resident of No. 52 Oxcliff has submitted an application for an on-street blue badge parking bay outside the property.

4.0 Consultation

- 4.1 The proposals have been the subject of consultation and public advertisement in accordance with the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996. The attached drawing indicates the extent of the proposals as advertised. Please refer to Appendix A. The Traffic Regulation Order was advertised on site and in the press on 31 July 2020. Any person could make objections and representations until 24 August 2020.
- 4.2 At the conclusion of the advertising stage approximately 34 letters were delivered and seven responses were received. Six responses were objections to the proposal and one was in support. No comment was given with the supporting response and all of the objections were accompanied by comments. The respondent's comments are summarised in Appendix B, together with Officers comments.
- 4.3 Local County Councillor comments:

 This proposal has the support of the local County Councillor.

5.0 Equalities

5.1 Consideration has been given to the potential for any equality impacts arising from the recommendation. It is the view of officers that the recommendation does not have a significant adverse impact on any of the protected characteristics identified in the Equalities Act 2010 and a copy of the Equalities Impact Assessment screening form is attached as Appendix C.

6.0 Finance

On the basis of the recommendations, the financial implications are in the region of £2000 including consultation, legal advertising, and the necessary lining and signing which will be funded from the local highways Area 3 (Signs, Lines and TROs) budget.

7.0 Legal

- 7.1 A new process for the consideration of objections to traffic regulation orders was approved by the Executive on 29 April 2014 and County Council on 21 May 2014. The consideration of objections to Traffic Regulation Orders (TROs) is now a matter for the Executive and the role of the Area Constituency Committee is changed to a consultative role on wide area impact TROs. The consideration of objections has been delegated by the Executive to the Corporate Director of Business and Environmental Services (BES) in consultation with BES Executive Members. The new decision making process relates to the provision and regulation of parking places both off and on the highway where an objection is received from any person or body entitled under the relevant statue. A wide area impact TRO is classed as a proposal satisfying all of the three criteria set out below:
 - The proposal affects more than one street or road and,
 - The proposal affects more than one community and,
 - The proposal is located within the ward of more than one County Councillor.
- 7.2 As the proposal is wholly within the County Council Electoral Division of Woodlands, this would not be classed as a wide area impact TRO.
- 7.3 Officers consider that, should it be resolved that some or all of the proposed amendments are to be made, the changes will enable the County Council to comply with its duty under Section 122(1) of the Road Traffic Regulation Act 1984, which provides that it shall be the duty of every local authority upon whom functions are conferred by or under the 1984 Act so to exercise those functions as to secure the expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians) and the provision of suitable and adequate parking facilities on and off the highway.
- 7.4 In the event that the changes to the traffic regulation orders described in this report are approved, then to accord with the relevant statutory regulations, the County Council will be required to make and advertise the traffic regulation order concerned before it comes into operation. The County Council will also be required to notify the objectors of its decision.
- 7.5 Where an Order has been made (sealed), if any person wishes to question the validity of the Order or any of its provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of the 1984 Act or of any instrument made under the 1984 Act has not

been complied with, they may apply to the High Court within six weeks from the date on which the Order is made.

8.0 Climate Change Assessment

8.1 Consideration has been given to any potential Climate Change impacts arising from the recommendation. A copy of the Climate Change Impact Assessment is attached as Appendix D.

9.0 Recommendations

- 9.1 On the basis of the consultation responses, it is recommended that the Corporate Director, BES, in consultation with the BES Executive Members, over-rule the objections to the proposed blue badge parking bay and approve the changes and
- 9.2 That the Assistant Chief Executive (Legal and Democratic Services) be authorised to make and seal the relevant Traffic Regulation Orders.
- 9.3 That the respondents are notified of the decision within 14 days of the Order being made.

CONSULTATION - Installation of an on street blue badge parking bay on Oxcliff, Scarborough.

The County Council, as Highway Authority for the area, has been asked to implement the following traffic control measures at the above location:-

Proposed measures	To install an on street blue badge parking bay adjacent to 52 Oxcliff, Scarborough.
Reasons	To facilitate available parking for blue badge holders.

The Council is required to consult those directly affected by the proposal or who may have an interest. The purpose of this letter is to provide you with details of the proposal and allow you the opportunity to express your views.

Attached is a plan showing the location of the section of Oxcliff where we are proposing to install a designated blue badge parking space. However, if objections are raised which are not resolved or withdrawn, it will be necessary to report them to a meeting of the County Council's Business and Environmental Services (BES) Executive Members overseeing the responsibilities of Corporate Director, BES, David Bowe, to decide whether the objections should be upheld or overruled.

The date and venue of any meeting together with conditions regarding public access will be advised if applicable.

I trust this is satisfactory and look forward to receiving your comments.



PROPOSED AMENDMENTS TO WAITING RESTRICTIONS IN SCARBOROUGH

STATEMENT OF THE COUNCIL'S REASONS FOR PROPOSING TO MAKE THE ORDER

LEGAL POWERS AND DUTIES

Under Section 1(1) of the Road Traffic Regulation Act 1984 the County Council, as traffic authority for North Yorkshire, has powers to make a Traffic Regulation Order (TRO) where it appears expedient to make it on one or more of the following grounds:

- (a) For avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- (b) For preventing damage to the road or to any building on or near the road, or
- (c) For facilitating the passage on the road or any other road of any class of traffic (including pedestrians), or
- (d) For preventing the use of the road by vehicular traffic of a kind which, or its use by vehicular traffic in a manner which, is unsuitable having regard to the existing character of the road or adjoining property, or
- (e) (Without prejudice to the generality of paragraph (d) above) for preserving the character of the road in a case where it is specially suitable for use by persons on horseback or on foot, or
- (f) For preserving or improving the amenities of the area through which the road runs, or
- (g) For any of the purposes specified in paragraphs (a) to (c) of subsection (1) of Section 87 of the Environment Act 1995 (air quality).

Section 122(1) of the Road Traffic Regulation Act 1984 also provides that it shall be the duty of every local authority upon whom functions are conferred by or under the 1984 Act so to exercise those functions as to secure the expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians) and the provision of suitable and adequate parking facilities on and off the highway.

REASONS FOR MAKING THE ORDER

The County Council considers that it is expedient to make this TRO on grounds (c) and (f) above, having taken into account its duty under Section 122(1) of the 1984 Act.

CONSIDERATION OF OBJECTIONS

Under the County Council's Constitution, the consideration of objections to a proposed TRO is delegated to the Corporate Director - Business and Environmental Services (BES) in consultation with the BES Executive Members. For each TRO where there are objections, it will be necessary to bring a report to

the Corporate Director - BES and the BES Executive Members seeking a decision on the consideration of the objections.

The report will include the views of the relevant local member who will also be invited to the meeting that considers the report. The Corporate Director - BES may wish to refer the matter to the Council's Executive for a final decision.

A report to the relevant Area Committee will only be necessary when there are objections to a wide area impact TRO.

A wide area impact TRO is defined as a proposal satisfying all the three criteria set out below:

- The proposal affects more than one street or road and,
- The proposal affects more than one community and,
- The proposal is located within the ward of more than one County Councillor.

The report will seek the views of the Area Committee and these views will then be included in a report to the Corporate Director - BES and the BES Executive Members seeking a decision on the consideration of the objections. The Corporate Director - BES may wish to refer the matter to the Executive for a final decision.

The existing arrangements for members of the public wishing to attend or speak at committee meetings will apply and it may be appropriate for the Corporate Director - BES to have his decision making meetings open to the public, so that the public and in particular those with objections, have the opportunity to put their views across directly.

N.B. The Corporate Director - BES has delegated powers to make decisions on TROs where there are no objections.
