1.0 Purpose of Report

1.1 To introduce a presentation on Reablement

2.0 **Introduction**

- 2.1 Reablement is characterised by support from trained staff spending more time with people in the early stages after an illness or accident to explore their motivation and goals and to see whether their earlier independence can be restored. It can be described as an approach which aims to help people 'do things for themselves' rather than 'having things done for them'.
- 2.2 You believed that development of a Reablement service could well be pivotal to managing service change in North Yorkshire. For this reason, but more because it plays such an important role in the way people are supported in living independently, is why the Committee expressed a wish to scrutinise these services as they are developed, to ensure they are addressing individual needs.
- 2.3 We start this topic with a briefing at the Committee by Beverley Maybury Assistant Director Adult Social Care. I have included the briefing and draft project plan considered and agreed at the recent Mid Cycle Briefing.

Reablement Briefing

DEFINITION

" A process aiming to restore personal autonomy in those aspects of daily living considered most relevant by patients or service users and their family carers" 1

"Services for people with poor physical or mental health to help them accommodate their illness by learning or re-learning the skills necessary for daily living" ²

OBJECTIVES

- to maximise users long-term independence, choice and quality of life
- to appropriately minimise ongoing support required
- and, thereby, minimise the whole life-cost of care

WHAT IS IT

Spending much more time with people in the early stages after an illness or accident, to explore their motivation and goals and to see whether their earlier independence can be restored. 3

Reablement can be described as an "approach" or a philosophy within home case services – one which aims to help people "do things for themselves", rather than "having things done for them".

Home care reablement services provide personal care, help with activities of daily living and other practical tasks for a time-limited period, in such a way as to enable users to develop both the confidence and practical skills to carry out these activities themselves.⁴ For example, a client may set their outcome target as "being able to get out of bed, get dressed by self and prepare breakfast". The role of the home carer in this situation would be to support the client in re-learning these life-skills. The service would usually be provided for a defined maximum period of time, often six weeks.

Like all Intermediate Care Services reablement aims to assist people at transitional points in their life and to help confidence and functioning. What distinguishes it from other models is that it tends to emphasise a "Social Model" by focussing on social interaction and daily living skills, and it tends to be delivered by un-qualified (but well-trained) staff operating under the guidance and supervision of professional staff.⁵
