WORK PROGRAMME REPORT

1.0 Purpose of Report

- 1.1. The Committee has agreed the attached work programme
- 1.2. The report gives members the opportunity to be updated on work programme items and review the shape of the work ahead.

2.0 Background

- 2.1 The scope of this Committee is defined as:

'The needs of vulnerable adults and older people and people whose independence needs to be supported by intervention from the public or voluntary sector.'

3.0 Joint North Yorkshire Carer's Strategy

- 3.1 During consideration of the Local Account last year, the previous Committee flagged up an intention to review the support the Council gives to carers, particularly how the Council and its partners help them engage and participate in planning services. The Committee therefore readily accepted the invitation to be involved in the refresh of the Joint North Yorkshire Carers' Strategy.
- 3.2 The Carer's Strategy was recently signed off jointly by the Directorate and the new CCGs. At their recent Mid-Cycle Briefing, Group Spokespersons agreed that the resulting action plan should be the subject of consideration at your meeting today.
- 3.3 The importance of carers was one of the general themes Group Spokespersons discussed at their meeting. Carers, families and communities can play a bigger role in supporting themselves, with the care and support they need helping them to retain or regain dignity and involvement. They should increasingly influence the development and delivery of innovative care and support arrangements. For this reason, it has been agreed that consideration of carers issues be scheduled for two out of the four meetings held during the year, starting in October when the Chair of the North Yorkshire Carer's Forum be invited to address your meeting.

4.0 Extra Care

- 4.1 The Committee has periodically received reports on the delivery of extra care housing schemes across the County. The Directorate has recently prepared a procurement process to identify a partner or partners to develop, manage and operate up to 30 extra care housing schemes across the County by April 2020. This will be considered at the Executive meeting on 9 July 2013. In addition to being kept abreast of progress on this, your Group Spokespersons have agreed that at least one visit be arranged to an extra care facility in the County.

5.0 Charging for Care Services

- 5.1 Some two years ago, the Committee was involved in the consultation on a revised charging scheme for social care services and subsequently monitored the impact on service users. Group Spokespersons learned that further proposals on charging are under consideration and may be subject to further consultation later in the year. This topic has been provisionally scheduled for Committee consideration at the October meeting; if however, this does not dovetail with the Directorate's timetabling, a separate meeting may be necessary.

6.0 Re-ablement

- 6.1 Many people will need support to regain some abilities or to maintain their wellbeing and level of independence. The Directorate's Start Service (the Short Term Assessment and Re-ablement Team) offers a period of support to help people with a disability to remain as independent as possible. It also helps people regain their independence and get back in control of their life after an accident or period of ill health.
- 6.2 Group Spokespersons have recommended that the Directorate update the Committee on this in-house service at a meeting in the New Year.

7.0 Fair Access to Care

- 7.1 The government provides criteria to help councils decide who is eligible for support. This ensures that councils reach a decision in a fair, consistent and open way about who is in need of help. This criteria is called Fair Access to Care Services, where an individual's area of need is identified as either:

- Critical
- Substantial

- Moderate
- Low

7.2 By identifying the level of need at assessment, people with needs in the critical, substantial and moderate bands are currently offered support by county councils. Consideration of the North Yorkshire County Council position on fair access to care has been included in the draft work programme.

8.0 Recommendations

8.1 The Committee is recommended to consider the attached work programme and determine whether any further amendments should be made at this stage.
