Care settings and outbreak management

- Care settings were at the forefront of outbreak management during lockdown
- NY defined care settings as residential homes, nursing homes and extra care - 235 locations in the County
- As lockdown has eased, outbreak management has extended to include all 7 themes in the Contain Framework - in particular, workplaces
- Testing and PPE supply are core components of any response to outbreaks
- Now we are seeing a new rise in infection rates and cases









PHE Reported Outbreaks


13 August: 1 further outbreak. Total = 118



Care Settings Outbreaks







A number of settings have had multiple/ continuous outbreaks over the last few months.

Deep dives have been carried out in a small number of homes to identify further support needed

North Yorkshire County Council

Support for care providers

- 7 day/week support from the start, building on existing County Council support
- 197 additional beds commissioned
- Safer discharge pathways
- 5% premium paid on planned activity (reviewed monthly), in addition to up to 4% 2020/21 uplift
- Expanded hardship scheme for providers
- Sharing of North Yorkshire's share of the national £600m Infection Control Fund with all providers
- PPE training and emergency panel



Care Home Resilience Model




Support for care providers



Care Home Testing

- Widespread national testing ended as cases accelerated
- North Yorkshire and York Care Home Testing Framework
 - Ahead of national policy
 - Under 65s as well as older people
 - Extra care and other settings, as well as refuges and other supported accommodation
- Bradford supply route
- Scarborough and Harrogate Pseudo-Satellite Testing
- National roll-out of weekly staff and monthly resident testing



Outbreak Management





Test and Trace: Contain

- Contain Framework (including "local lockdown" powers)
- July Sept: Regular, small outbreaks, addressed rapidly
 - Care settings
 - Food plants
 - Pubs
 - Retail

- Working collaboratively with PHE and district councils and the NHS to trace contacts and manage outbreaks
- Currently stress-testing different scenarios
- Anticipating devolution of contact tracing

Our learning – key successes

- Multi-agency representation approach has been crucial
- Having a "flying squad" (NYCC Quality Improvement Team, NHS clinical experts, etc) to help struggling care providers is a valuable asset
- Risk stratification has helped us to respond to the numbers of outbreaks
- Developing our local approach to testing
- Use of provider bulletins and webinars to share messages widely

Latest position





September

- Quadrupling of cases
- NHS111 on the up and some hospital admissions
- Community transmission plus settings-related outbreaks
- Areas of Concern status
- Care Home Visiting Restrictions, pausing day services and expanding daily calls
- National challenges with lab capacity
- National Adult Social Care Plan and additional Infection Control funding announced

Looking ahead

- Need for even safer discharge pathway from hospital to care homes
- 7/7 infection control services required
- Testing programmes go hand in hand with outbreak management –
 NY has been pro-active but national systems are still too complicated and subject to delays
- PPE distribution systems
- Be aware of emerging risk factors: low paid factory jobs; some sectors rely heavily on migrant labour; HMOs; schools re-opening; the Contain Framework powers may not be the answer
- "Living with Covid" this could be until May 2021 and there will be future viruses
