## 1 Purpose of the Report

1.1 To invite the Committee to consider the work programme.

### 2 Scope of the Committee

2.1 Under the Council's constitution the scope of this Committee is defined as:

"the Council's corporate organisation and structure, resource allocation, asset management, procurement policy, people strategy, equality and diversity, performance management, communications and access to services.

Partnership working, community development, community engagement, community strategies and community safety (the designated Crime and Disorder Committee)".

#### 4 Updates

#### 4.1 One Council

4.1.1 The One Council Members Task Group met with the Chief Executive in July to get his insight into how the One Council programme is progressing and the areas that he believes the organisation needs to focus upon in the life of this Council and beyond. It was noted that if initial reports of the anticipated budget settlements for councils under the next CSR are anything to go by, the required level of savings will go far beyond the savings being realised by the One Council programme and other service changes to date. Difficult decisions will need to be made soon into the life of the next Council about which services the County Council will no longer continue to provide. To help inform this process the group suggested that Members in the current administration could do some 'blueskythinking' about what services the Council should deliver after 2014/15. The Chief Executive and the Leader are looking at taking this forward.

- 4.1.2 The task group met again in August to scrutinise the first of the monthly highlight reports, including the risk register. The group suggested that a list of mitigating actions to be undertaken against each of the risks should be included in future versions of the risk register. The updated risk register will be presented to the group later this year.
- 4.1.3 The task group will be meeting after today's Committee meeting to receive a progress report on the Customer Access Workstream and an update on the Behaviour & Skills Framework and 'The Role of the Manager' under the Management and Supervision workstream.

## 4.2 Community Right to Challenge

- 4.2.1 The community right to challenge (CRC) was introduced by the Localism Act 2011. Charity, voluntary/community groups, parish councils and groups of County Council employees have the right to submit an expression of interest (EOI) in running specified County Council services, where they believe that they can do so differently and better. The CRC applies to all county council services (except personalised budgets), although there are some temporary exceptions where services are in specified ways linked to NHS services. There are limited grounds for rejection of an EOI.
- 4.2.2 Groupspokespersons were circulated the draft Executive report on the County Council's proposed approach to the CRC. Subsequently the recommendations in the report were approved by the Executive in July, subject to a reduction in the length of time that people will be able to submit an expression of interest each year from eight to six weeks (18<sup>th</sup> February to 31<sup>st</sup> March, commencing 2013).
- 4.2.3 The County Council has produced a webpage outlining its approach for inviting and considering expressions of interest www.northyorks.gov.uk/crc.

#### 5 Emerging areas of work

#### 5.1 Localisation of Council Tax Benefit

- 5.1.1 From next year local government will take on the responsibility for the council tax benefit system, along with a 10% reduction in government grant on the current council tax benefit bill.
- 5.1.2 Billing authorities (district councils in two tier areas) will be required to develop localised schemes, deciding the extent to which they will pass the 10% cut on to benefit claimants. The local schemes, however, will need to take account of the Government's intention for some 'vulnerable' groups to have their benefits protected.
- 5.1.3 In North Yorkshire the district councils will be required to consult the major precepting authorities (the County Council, the Fire & Rescue Authority and the Police & Crime Commissioner) on the design of local schemes and how the funding reduction is to be managed.

5.1.4 A report on the localisation of Council Tax Benefit in North Yorkshire will be brought to the Committee's November meeting.

## 6 Recommendations

6.1 That Members review the Committee's work programme, taking into account issues highlighted in this report, the outcome of discussions on previous agenda items and any other relevant developments taking place in the county.
