#### 3. CHANGES IN CHARGES FOR 2020-21

3.1 Traditional uplift of charges is an exercise carried out annually and the new charges are implemented in April to coincide with the benefit uplift awarded by DWP (6<sup>th</sup> April 2020 for 2020-21). The proposed new rates for services which are not subject to the means tested financial assessment are outlined in Table 1.

- 3.2 Transport charges are currently £5 per journey (with a cap of £30 per week) and this will remain the charge until April 2021, then the price will increase to £7.50 (with a cap of £40 per week). This was agreed by The Corporate Director Health and Adult Services, in consultation with the Executive Member for Adult Social Care and Health Integration in May 2019.
- 3.2 Table 2 below details the proposed charges for those services being directly provided by NYCC and which are subject to a financial assessment.
