Humber, Coast and Vale Integrated Care System

Report of the Corporate Director, Health and Adult Services

1.0 Purpose of the report

1.1 The purpose of this report is to seek the views of Executive Members, on the Corporate Director of Health and Adult Services decision to support the application of the Humber, Coast and Vale Care Partnership to become an Integrated Care System (ICS).

2.0 Background

- 2.1 The Humber, Coast and Vale Health and Care Partnership was established in 2016, to enable 28 organisations from the NHS, local authorities, other health and care providers and the community and voluntary sector to work together more effectively, to address the challenges facing the NHS and wider health and care sector.
- 2.2 The Partnership covers 1.4 million people and the partners have worked together to identify key priorities and to work together to meet the requirements in the NHS Plan. North Yorkshire County Council is an active partner in this partnership.
- 2.3 The 10 Year NHS Plan published in 2019 requires NHS organisations to work collaboratively with partners to create Integrated Care Systems (ICS). ICSs build upon Sustainability and Transformation Partnerships.

3.0 Humber, Coast and Vale Integrated Care System Application

- 3.1 Integrated Care Systems have two core roles:
 - Plan and coordinate the transformation of health and care across settings at the place and neighbourhood level including workforce planning, population health management and quality improvement; and

- Collectively manage system performance including health outcomes, quality of care, operational and financial performance in relation to specifically NHS organisations.
- 3.2 The vision for the HCV ICS is 'helping local people to: start well, live well and age well. The ICS wants to become a 'health system improver rather than an ill-health treating system'. The focus of the work will be on prevention and supporting people to manage health and wellbeing at home so they can live happy and fulfilling lives. The primary purpose of the partnership is to improve and sustain the health and wellbeing of the population across Humber, Coast and Vale.
- 3.3 The HCV ICS plan has four priorities:
 - Helping people to look after themselves and to stay well.
 - Providing services that are joined-up across all aspects of health and care.
 - Improving the care we provide in key areas (e.g. cancer and mental health).
 - Making the most of our resources (e.g. people, technology, buildings and money).
- 3.4 The HCV ICS has identified collaborative programmes to underpin the priorities including:
 - Cancer
 - Mental Health
 - Population Health
 - People / workforce
 - Estates and capital investment
 - Digital
- 3.5 The HCV ICS has developed an Operating Framework to govern the work. There is a Partnership Executive that meets monthly with Chief Executive level representatives from across partners organisations. There is also a Partnership and Oversight Assurance Group meeting monthly and a Partnership Assembly meeting on a quarterly basis.
- 3.6 The partnership will operate a distributed leadership model collaborating at place; collaborating at the sub-system level of North Yorkshire and York and collaborating at scale through the ICS.
- 3.7 The ICS will also consider streamlining commissioning functions and commissioning plans, working with Clinical Commissioning Groups.

3.8 The partners across Humber, Coast and Vale have submitted an application to NHS England to become an Integrated Care System from 1st April 2020.

4.0 Recommendation(s)

4.1 Members are asked to note that the Corporate Director of Health and Adult Services has made the decision to support the application for Humber, Coast and Vale Partnership to become an Integrated Care System.
