She informed the Council that the citation had read "Twice he behaved with extraordinary gallantry, but his single-handed action on the second occasion, although wounded, to push on against a superior enemy force, stands out as a premeditated act of inspirational leadership and supreme valour". In response to a proposal from Members of the Council, the Chairman of the Council agreed to write Corporal Budd's widow.

County Councillor Peter Sowray, the Executive Member for Environmental Services – planning, roads and traffic, and archaeology, presented his statement, a summary of the key points of which had been previously circulated and which appears in the Minute Book (pages 3053-4 together with a supplementary statement about the LTP Capital Settlement). He responded to questions,

County Councillor Clare Wood, the Executive Member for Environmental Services, public rights of way, conservation, waste disposal and public passenger transport, presented her statement, a summary of the key points of which had been previously circulated and which appears in the Minute Book (pages 3055-7). She responded to questions,

The Chairman adjourned the meeting at 1.10 pm.

The meeting re-convened at 2.35 pm.

County Councillor Carl Les, the Executive Member for Corporate Services – corporate affairs, performance management, procurement, asset management and finance presented his statement, a summary of the key points of which had been previously circulated and which appears in the Minute Book (pages 3059-63). He responded to questions, including an assurance that he would respond to County Councillor Bill Hoult about procurement processes for distribution of NY Times.

The written statements of the Chairmen of the Scrutiny Board and the Overview and Scrutiny Committees having previously been circulated (pages 3065-92), County Councillor John Blackie, Chairman of the Scrutiny Board and of the Scrutiny of Health Committee, made additional oral statements and responded to questions.

COUNCIL PROCEDURE RULE 10 QUESTIONS

In response to a question from County Councillor Stuart Parsons relating to the difficulties encountered by the public in seeking to contact the Police, County Councillor Jane Kenyon, the Chairman of the North Yorkshire Police Authority, assured Members of the Council that the Police Force and the Police Authority were very aware of the difficulties being experienced and steps were being taken to address these. She stressed that the 0845 number should be used for non emergency calls only and that if calls were being made about emergency issues they should use the 999 number.

MOTION – POST OFFICES AND SUB-POST OFFICES IN URBAN AND RURAL AREAS

It was formally moved by County Councillor Gordon Charlton and seconded by County Councillor Bernard A Bateman MBE:-

"North Yorkshire County Council:

Condemns the failure of HM Government to support Post Offices and sub-Post Offices within urban and rural areas in their provision of valuable local services;

Opposes any further closures in the county;

Believes that Post Office closures cause great distress and inconvenience to many residents, including many vulnerable members of society, and

Undertakes to write to the Government Minister concerned urging them to take steps to retain and improve the post office network in the UK."

The Chairman said that, in view of the Government's announcement of a public consultation period on the future of post offices for the three months to 8 March, 2007, she did not believe that there were grounds for debating the motion on the day. The Chairman ruled, therefore, that, having been formally moved and seconded, the motion should stand referred to the Care and Independence Overview and Scrutiny Committee and then the Executive for consideration and report back to the Council in February.
