## MINUTES

## RESOLVED -

#### CHAIRMAN'S ANNOUNCEMENTS

The Chairman announced the death of a former Member of the Council, Bill Chapman, who was County Councillor for the Flaxton No. 2, later Ryedale Rawcliffe, electoral division from 1977 to 1989.

The Council stood in silence as a mark of respect.

The Chairman reported that another former Member of the Council, Roy Wilson, had been awarded the MBE in the Queen's Birthday Honours List for services to local government and to the community in Selby. 3970

The Chairman informed the Council that, prior to the meeting, he had received a petition from Riccall Parish Council concerning the withdrawal of the Riccall A19 roundabout from the highways work programme and that Parish Councillor John Duggan was to make a statement under item 5 on the agenda. He said that he would pass the petition to the appropriate officers.

#### RESOLVED -

**136.** North Yorkshire County Council supports the need for energy efficiency, both as a way of reducing carbon emissions and also in reducing fuel poverty (nearly one in four households in North Yorkshire are subject to fuel poverty).

- 1. It therefore calls on the Government to fund a range of grants to enable every household in the UK to insulate their homes to current UK building standards.
- 2. Council asks that support for this policy is also sought from the Local Government Association and Regional Government as a way of tackling fuel poverty and carbon emissions.
- 3. This Council supports a low carbon sustainable energy strategy, based on energy demand reduction, greater energy efficiency, the use of economic instruments, combined heat and power and micro-generation and community-based forms of generation and a mix of renewable energy sources that include bio-mass, wind, wave, tidal and solar, within a more fully liberalised EU energy market.

#### STATEMENTS OF EXECUTIVE MEMBERS AND CHAIRMEN OF OVERVIEW AND SCRUTINY COMMITTEES

County Councillor Helen Swiers, Executive Member for Community Services (community planning, community safety, cultural services, economic development, public protection, trading standards and post16 lifelong learning) presented her statement, a summary of the key points of which had previously been circulated and which appears in the minute book (pages 3915-8). She responded to questions, including agreeing to investigate a suggestion that consultation on the site for the Seamer Horse Fair had not been adequate.

County Councillor John Fort BEM, Executive Member for Environmental Services (planning, roads and traffic and archaeology) presented his statement, a summary of the key points of which had previously been circulated and which appears in the minute book (pages 3919-21). He added to his statement by referring to work that had been undertaken in response to recent flooding incidents and asked the Chairman of the Council to write to the staff involved to thank them for their contribution. He responded to questions.

County Councillor Clare Wood, Executive Member for Environmental Services (public rights of way, conservation, waste disposal and public transport) presented her statement, a summary of the key points which had previously been circulated and which appears in the minute book (pages 3923-6) and responded to questions.

County Councillor Carl Les, Executive Member for Corporate Services (corporate affairs, performance management, procurement, asset management and finance, e-government and communications) presented his statement, a summary of the key points of which had previously been circulated and which appears in the minute book (pages 3927-8) and responded to questions.

County Councillor Caroline Patmore, Executive Member for Childrens Services (childrens services issues, special educational needs, special schools, youth service and youth offending team) presented her statement, a summary of the key points of which had previously been circulated and which appears in the minute book (pages 3929-32). She responded to questions and agreed to try to arrange for an executive summary of the Care Matters White Paper to be circulated to all Members.

County Councillor John Watson OBE, Executive Member for Childrens Services (early years education and all school related education issues and advisory services) presented his statement, a summary of the key points of which had previously been circulated and which appears in the minute book (pages 3933-6). He responded to questions, including written questions from County Councillor Bill Hoult relating to digital finger print technology.

County Councillor Chris Metcalfe, Executive Member for Community Services (adult social services, library and information services) presented his statement, a summary of the key points of which had previously been circulated and which appears in the minute book (pages 3937-40). He responded to questions.

The written statements of the Chairmen of the Scrutiny Board and the Overview and Scrutiny Committees having previously been circulated (pages 3941-67), additional statements were made by County Councillors Paul Richardson, John Blackie and Shelagh Marshall.

County Councillor Jane Kenyon declared a personal interest as non executive Director of the Scarborough and North East Yorkshire Health Care Acute Trust in respect of the statement made by County Councillor John Blackie.

#### COUNCIL PROCEDURE RULE 10 QUESTIONS.

County Councillor Bill Hoult asked County Councillor Jane Kenyon, as Chairman of the North Yorkshire Police Authority, about the recent introduction of charges by the Police for services to events run by voluntary fund raising bodies, where those services had previously been provided free. In response, the Chairman of the Police Authority said that the Authority had raised this matter with the former Chief Constable; that she believed the issue was primarily one of the level of charges being made and she anticipated a further report being brought to the Police Authority.

County Councillor Rob Broadley asked County Councillor Jane Kenyon, as Chairman of the North Yorkshire Police Authority, about the whereabouts of records relating to the maintenance of CCTV cameras located in Whitby from a period before those cameras were taken over by Scarborough Borough Council. In response, the Chairman of the North Yorkshire Police Authority said that the question raised important issues about the whereabouts and availability of information relating to those cameras which needed to be investigated. She said that County Councillor Broadley would receive a response, either from her or from an officer, in due course.

### **MOTION – FLOODING IN RIPON**

County Councillor Bernard Bateman MBE moved and County Councillor David Lloyd-Williams seconded:-

"in view of the recent experience of serious flooding for the second time in seven years within the Ripon area, and the enormous distress and cost caused to residents and businesses, North Yorkshire County Council urges DEFRA and the Environment Agency to take immediate action to reinstate the flood defence project that was postponed, due to lack of funding, for Ripon."

It was moved and seconded as an amendment:-

That the word "was" be deleted and the words "has been" be inserted in its place; and

That the word "Ripon" at the end of the motion be deleted and the words "the County" be inserted in its place.
