13. MOTION - ECONOMIC CRISIS

County Councillor Bill Hoult to move and County Councillor M-A de Courcey-Bayley to second:-

"This Council recognises the depth of the economic crisis facing the citizens of North Yorkshire and is committed to supporting small businesses in the County.

Accordingly it resolves to bring forward an element of planned future expenditure on County Council projects such as:-

- Highway Maintenance and repair
- Expenditure on upgrading, maintenance of schools
- The removal of asbestos in key County Council properties
- Replacement of concrete lampposts
- Repair and maintenance of County Farms

In addition it is resolved to meet the Government target to pay businesses within 10 days of the submission of a receipt.

Such works to be financed from the windfall increases from Treasury Management due to unexpected high interest rates and from Council reserves subject to repayment from future County Council receipts and or revenue income."
