In response County Councillor Chris Metcalfe said that Mr Hardy's points were well made but the County Council currently had no plans for the site. He suggested that when a planning application came before Richmondshire District Council for future use of the site Mr Hardy would have an opportunity to comment.

County Councillor Melva Steckles, speaking in her role as a member of Richmondshire District Council, invited Mr Hardy to raise his concerns and proposals with that Council.
