#### **Chairman's Announcements**

The Chairman formally announced to the Council the deaths of two former Members of the Council: David Murkett, who was County Councillor for Thirsk electoral division from 1989 to 1993 and 1997 to 2001, and John Parfect MBE, who was County Councillor for Stillington electoral division from 1981 to 1992. Members of the Council stood in their memory.

# Statement by the Leader of the Council
