5. Harrogate Adult Community Services Health and Social Care Integration - Report of the Corporate Director - Health and Adult Services

Recommendations:

The Executive asked to

- (a) approve the Programme Final Business Case (Appendix A).
- (b) delegate to the Corporate Director Strategic Resources, Corporate Director Health and Adult Services and Assistant Chief Executive (Legal and Democratic Services), in consultation with the relevant executive members, the consultation on, and completion of a Section 75 Agreement and any other alliance and partnership agreements that may be necessary to underpin the programme.
- (c) approve that, prior to implementing any further developments beyond the milestones for Year One, further business case(s) will be brought back to the Executive for review.
- 6. Alternative Investments Year 1 Review Report of the Corporate Director Strategic Resources

Recommendations:

It is recommended that the Executive:

- i) Note the progress to date and the future actions proposed
- ii) Approve an increase in the total amount available for alternative investment from £50m to £60m;
- iii) Approve the revised thresholds set out at Appendix C;
- Approve the extension of the delegations to the Commercial Investment Board (formally through the Corporate Director Strategic Resources) to a limit of £2.5m (from £1m) per investment and up to a total of £10m (from £5m) in any one financial year.

Recommendations:

The Council's Executive is asked to agree:

- a. That the Council continues to use the principles of the DfE's National Funding Formula, including the various transitional arrangements, and a Minimum Funding Guarantee of -1.5%, as a basis for funding schools in 2019-20; and
- b. That, subject to approval being received by the Secretary of State, 1% of the Schools Block will be used to support High Needs costs in 2019-20. In the event of the 1% transfer request

being refused by the Secretary of State, that 0.5% of the Schools Block will be used to support High Needs costs in 2019-20, as agreed by the North Yorkshire Schools Forum; and

- c. That the Council will continue to push for a fairer and more equitable funding settlement for schools in North Yorkshire. We will also continue to lobby for a fairer settlement of High Needs resources.

- To implement a new banding system for allocating top-up funding based on the funding proposal and rates identified in the consultation.
- To finalise the full implementation plan so that the new system can be implemented from April 2019.
- 9. Pupil Referral Service and Alternative Provision (PRS/AP) Budget and Fund Modelling - Report of the Corporate Director - Children and Young People's Service

Recommendations:

That Executive approves the amended recommendations below which have taken into account the key areas raised as part of the consultation process

- Acknowledges that this proposal is part of a reshaping of the full continuum of education for children and young people with SEMH and additional needs as detailed in the Strategic Plan for SEND provision as agreed by the Executive in September 2018.
- Proceed with the development of a revised model of AP in localities in collaboration with secondary and PRS Head teachers and to finalise the new model and associated funding by September 2019
- Implement the new models of AP from September 2020 rather than the original timescale of September 2019 to allow for a longer transition period
- Proceed with the principle of funding on a place basis to ensure equity and transparency of funding and expectations of delivery
- Remove 50% of discretionary funding from PRS/AP budgets from April 2019 until September 2020 to reduce the impact of the budget changes on the PRS/AP provision and provide greater organisational stability whilst the new model is finalised.
- Continue to fund AP places at £19K until September 2019 when the revised rate will apply of £18,000 in line with national average rather than £17,000 as detailed in the original proposal
- Commission medical in reach places at £10,000 per place as originally proposed up to September 2020
- Continues with the current model of home and in reach medical tuition until September 2020
- Subject to approval for permission to consult, changes proposed to medical tuition will be subject to a separate public consultation in April 2019
- Introduce a revised Service Level Agreement and monitoring framework for commissioned PRS/AP provision from April 2019.

10. Changes to Funding Arrangements for Post 16/19 placements for Young People with Education, Health and Care Plans - Report of the Corporate Director - Children and Young People's Service

Recommendations:

That Executive approves:

- To fund mainstream School Sixth Forms in line with FE colleges and to fund 600 hours of education per year for young people with EHC Plans and to implement this change from April 2019
- To continue to fund special school sixth forms for 25 hours of provision
- From September 2019, where a young person has a five day package, for the majority of young people to jointly fund across Adult Social Care and Education to reflect the 40%:60% contribution to funding respectively. Individual negotiations across Adult Social Care and Education will still be held for individual cases where funding allocations need to be varied from this norm.
- That the Local Authority accepts responsibility for the EHCP and its statutory responsibilities under the Children and Families Act 2014 and the Care Act 2014 and would ensure that assessed needs and provision over five days were supported by appropriate funding regardless of the source of the funding.
- That this additional budget pressure to HAS will be addressed from additional proposed contingency budget (core Council funds) underpinning SEN so that there is a net nil impact to the HAS budget. This will be implemented in the Revenue Budget / MTFS report scheduled for 29 January 2018 should this proposal be approved.
- That implementation work continues with HAS (Health and Adult Services) over coming months to ensure the Local Authority remains compliant both with the Children and Families Act and the Care Act in ensuring we work together to ensure well planned and co-ordinated packages and transitions for this group of young people

Fire

The fire evacuation alarm is a continuous Klaxon. On hearing this you should leave the building by the nearest safe fire exit.
