The subject of the decision:

The Head of Regulatory Services asked the Panel to consider whether to grant a Premises Licence in respect of an application made under the Licensing Act 2003.

Alternative options considered:

Not to grant the Premises Licence.

The reason for the decision:

Having taken into account the relevant representations of the parties, the Licensing Act 2003, the Council's Statement of Licensing Policy, the guidance issued under Section 182 of the Licensing Act 2003 and the four Licensing Objectives, the Panel decided that the application for the Premises Licence should be granted, subject to a reduction in the hours of operation, which the Panel considered necessary to address the issue of public nuisance arising as a result of noise from the premises.

That the further conditions agreed between the Applicant and the Council's Environmental Health Department be varied so they comply with the amended operating schedule.
