## LOCATION:

Land Comprising Part Of Flaxby Covert Flaxby Knaresborough North Yorkshire

#### PROPOSAL:

Retention of use of land for paintballing, retention of quad bike track, siting of portakabins and caravans, and installation of mesh fencing between trees.

**APPLICANT:** HPC Outdoor Pursuits

APPROVED subject to the following conditions:-

- Within one month of the date of this permission a plan for the management of the woodland, including measures to mitigate any adverse ecological impacts, shall be submitted for the written approval of the Local Planning Authority and thereafter implemented in accordance with the approved details. The management plan shall identify those areas in which the paint balling and quad bike activities take place avoiding ecologically sensitive areas.
- Within 3 months of the date of this permission a minimum of 25 parking spaces (min size 4.8m x 2.4m) shall be laid out, hard surfaced, drained, marked out and made available for use. Once created these shall be maintained clear of obstruction and retained for their intended use at all times.
- 3 HW32 PUBLIC RIGHTS OF WAY
- 4 Details of the models of the quad bikes shall be submitted for the written approval of the Local Planning Authority and thereafter no other models of bikes shall be used unless otherwise approved in writing by the Local Planning Authority.
- Unless within 3 months of the date of this permission, the green protective netting is replaced with black protective netting, the use hereby permitted shall cease until such time as such replacement has been fully carried out. Thereafter all protective netting used shall be black.

- 5 In the interests of visual amenity.

# JUSTIFICATION FOR GRANTING CONSENT:
