Thank you for consulting the Heritage Section upon this application.

The site of proposed development lies within the historic core of Knaresborough, with potential for the survival of remains of medieval and earlier settlement and activity. Knaresborough was an important, defended medieval town, with a castle established in the early 12th century. The line of the town defences is believed to have run along the rear of the properties on this side of the High Street. There is potential, therefore, for the development site to preserve evidence relating to former settlement, industry and trade within the medieval and later town.

In accordance with the guidance of PPG 16 on Archaeology and Planning, a scheme of archaeological evaluation should, therefore, be undertaken to clarify the precise nature and extent of surviving archaeological remains within the application site and thus to assess the archaeological impact of the proposed development. This should comprise a programme of archaeological trial trenching.

This evaluation should be requested in advance of a decision being taken on the current application under Regulation 4 of the Town and Country Planning (Applications) Regulations, 1988. This is in accordance with Policy HD4 of the Harrogate District Local Plan, which advises that applicants should provide detailed archaeological information in support of their application.
