Members added that, although the proposed site of the new facility might be in another constituency area, the facility would be very important for the people of the Harrogate area who are likely to find it more convenient to travel to a meeting of this Area Constituency Committee to hear about the consultation, rather than to a meeting of another Area Constituency Committee or of the Scrutiny of Health Committee.
Community and rural transport	If so invited, to feed in local issues to a countywide scrutiny which is being undertaken by TEE O&S in April/May 2019.
Patient transport	The Committee may wish to comment on proposals relating to patient transport.
Delayed Transfers of Care	To feed in any local concerns to a countywide scrutiny being undertaken by Care and Independence OSC.
SEND Transport Changes – One Year On	To feed in any local concerns to a countywide scrutiny being undertaken by TEE OSC.
