Key Decision: (Title of item and description of the matter and why it is considered a key decision)</p> <p>Yorkshire Forward Rural Capitals Programme 2009–2014: Prioritisation of Projects</p> <p>Yorkshire Forward have recently confirmed that Knaresborough is a Priority 1 town within their Rural Capitals Programme for 2009-2014, and that Boroughbridge and Pateley Bridge are Priority 2 towns. This provides an opportunity for Knaresborough to bid for significant funding via the new 5-year Renaissance Market Town (RMT) Programme, and for Boroughbridge and Pateley Bridge to bid for up to £30,000 per annum for 3 years via a new 'Delegated Fund'.</p> <p>Cabinet will be asked to consider a prioritised list of projects for development via the Knaresborough RMT Delivery Plan, as well as being asked to discuss if and how Harrogate Borough Council resources could be used to support the Rural Capitals Programme in the priority towns within the Harrogate district (to include a relevant recommendation to Council if deemed appropriate).</p> <p>Wards affected: Knaresborough King James, Knaresborough Scriven Park, Knaresborough East.
