


These ground rules are about Team North Yorkshire Health and Wellbeing Board and should apply within and outside of Board meetings. They were adopted by Board members in June 2015.

76. Welcome – Andrew Pippin

The Chair welcomed Andrew Pippin to this, his first meeting of the Board. Andrew had been nominated as the representative of the Emergency Services.

77. Apologies for Absence

78. Minutes

Resolved -

79. Review of actions taken at the last meeting

Considered -

An Action Sheet produced by the representative of the Assistant Chief Executive (Legal and Democratic Services), who confirmed that the actions had been implemented, or were in the process of being.

Resolved -

80. Declarations of Interest

There were no declarations of interest.

81. Public Questions of Statements

There were no questions or statements from members of the public.

82. Housing and Health Theme

Considered -

The presentation by Janet Waggott, Chief Executive of Selby District Council and Assistant Chief Executive, North Yorkshire County Council. Janet represents North Yorkshire District Councils Chief Executives on the Board.

Her presentation outlined progress on this Theme and especially the rationale for improving joint working between Housing and Health and the key priorities for partners.

In addition, the Board was appraised as to what had been done so far. This included:-

- Janet Waggott agreeing to be the link between the Strategic Housing Board and the Health and Wellbeing Board;
- partners working more closely together to identify supported housing/living needs through structured needs assessment and examining housing stock;
- a Workshop to develop an outcome-focused specification by the County Council and District Councils, in partnership, following a Homelessness Prevention Review; and
- implementation of a new Assistive Technology Service

The following points were also made as part of the presentation:-

- Each of the barriers needed to be unpicked. For instance, with rurality we need to be clear who are our key workers.
- There needs to be greater alignment between District and County Plans and planning processes.
- With regard to supported living, a number of bespoke meetings had been held with the District Councils to ensure housing needs could be met in the best way. District Council colleagues had been very supportive.

Next steps would include:-

- health service input into District Councils Plans;
- efforts to integrate planning;
- a Policy Statement on Health;
- supporting affordable housing and quality standards; and
- feeding back progress to the Board.

Dale Owens, Assistant Director, Care and Support, said that this was a two-stage process – firstly to identify people's needs and the accommodation required and, secondly, a wider consultation. Previously, we had not been identifying the need aspect sufficiently.

The Voluntary Sector would be included in these discussions.

Phil Mettam, Accountable Officer at NHS Vale of York CCG, said that he would be happy to assist in progressing things if that would help.

Richard Webb, Corporate Director of Health and Adult Services, felt that developments would result in different types of accommodation being available to what is currently on offer - linked into District Councils and incorporating closer links to primary and secondary care.

Resolved -

That the presentation be noted.

83. Digital Theme - Digital Innovation Challenge

Considered -

The presentation by Louise Wallace, Assistant Director of Health and Integration, which, following the discussion at the last meeting, outlined a suggested proposition and process for the Digital Innovation Challenge.

Louise Wallace advised that she had liaised with Robert Ling, Assistant Director of Technology and Change, about this and was making the presentation on his behalf.

The County Council had a budget of £50,000 for this. The proposition was that:-

- depending on the bid ideas submitted, that either two grants of £25,000, or four grants of £12,500 be awarded to fund innovative ideas to address challenges in respect of better connecting rural communities and supporting mental health and wellbeing by reducing loneliness for people who are digitally excluded;
- the County Council would lead the administrative process for the Digital Innovation Challenge but Board partners will be integral to the process.

In terms of process, it was proposed that an Engagement Team be formed to engage with digital providers to articulate the challenge, with providers submitting their ideas by the end of February 2019. Providers would be shortlisted against a number of criteria, as outlined in the report, including whether the proposal was scaleable and realistic.

Members would be welcome to be part of the afore-mentioned Engagement Team. Louise Wallace confirmed that Members could nominate someone else from their organisation. Richard Webb added that consideration should be given to officers who had comprised the Reference Group for the development of the Digital Strategy also being on the Engagement Team.

Shortlisted providers would then be invited to present their ideas to the Board in March 2019, following which the Engagement Team would consider all of the feedback and award the grants.

Richard Flinton, Chief Executive of North Yorkshire County Council, commented that whilst this initiative was very positive, it was also hugely ambitious in terms of timescale. Louise Wallace advised that the timescales had been set to meet the ambition of the Board. Richard Flinton felt that there needed to be some flexibility with the timescales so as not to run the risk of hampering the ideas for improvement. It also should be made clear to providers that, if their ideas were successful, further work would be required.

Richard Webb agreed that the timescales appeared tight and was relaxed about this not happening until the May or July meetings of the Board. However, there was no reason why the feedback from the engagement process could not be reported back to the meeting of the Board on 22nd March. He also stressed that the total grants available were *up to* £50,000.

Amanda Bloor, Accountable Officer at NHS Hambleton, Richmondshire and Whitby, NHS Harrogate & Rural District and NHS Scarborough and Ryedale Clinical Commissioning Groups, mentioned that rural isolation was an issue that had been identified in NHS England's Long Term Plan. If, as a result of this process, there was something that could be tested out and, potentially, extended across the county, that would be a good outcome.

Resolved -

- a) That the process suggested in the report be approved principally, that grants totalling up to £50,000 be awarded to fund innovative ideas to address the following challenges:-
 - How do we better connect people in rural areas to improve wellbeing and reduce pressure on the health and social care systems while improving service efficiency?
 - How can we support mental health and wellbeing by reducing loneliness for people, who are currently digitally excluded, using technology that is inclusive, accessible and intuitive?
- b) That providers be scored against the criteria stated in the report and that those providers shortlisted be invited to come to the Board to present their ideas on 22nd March 2019, potentially.
- c) That should officers consider that the timescale in b), above, is too ambitious, this aspect be deferred until the meeting in May, or July 2019.
- d) That partner organisations advise Louise Wallace if they wish to be part of the Engagement Team (NOTE: This does not have to be Board Members themselves; they can nominate people from their organisation).

84. Multi-Agency Forum on End of Life Care

Considered -

The report of Gill Collinson, Executive Nurse, Hambleton, Richmondshire and Whitby CCG, which updated the Board on the work of the Multi-Agency Forum on End of Life Care and sought the Board's support on work in connection with Dying Matters Awareness Week.

Patrick Duffy, Senior Democratic Services Officer at North Yorkshire County Council, presented the report and highlighted the following aspects:-

- The Forum had been established by the Board in 2017, following the report of the Scrutiny of Health Committee into end of life care in the county.
- The report outlined what had occurred thus far. The headline was that, rather than, say, developing a Charter on End of Life Care, the Forum considered that it would be of greater benefit to attempt to make a really practical difference to people coming towards the end of their life and their families and carers. For example, by encouraging people to have Lasting Power of Attorney arrangements in place.

- The view of the Forum was that a good opportunity to make a practical difference would be to get involved in Dying Matters Awareness Week, an annual awareness raising week that aims to help people talk more openly about dying and make plans for their death.
- This year the Awareness Week, the themes for which were outlined in the report, would be from 13th to 19th May.
- There were a number of ways in which the County Council, as a major employer and other partners could contribute. The County Council could, for instance, use its weekly Key Messages Bulletin, which is sent to all staff, to publicise the Week.
- A Co-ordinating Group had met on 16th January and felt that a database should be set up outlining the events that are planned. This could be underpinned by a single communications strategy.

Richard Webb commented that it would be helpful to have more detail about what had been done in response to the original recommendations of the Scrutiny of Health Committee.

Ros Tolcher, Chief Executive of Harrogate and District NHS Foundation Trust noted that the report did not refer to the Co-ordinating Group including representation from the Acute Sector and wondered if this was an oversight as she had provided a nomination. Patrick Duffy said he would check this.

Resolved -

a) That the work being undertaken in respect of Dying Matters Awareness Week 2019 be supported by partners in the form of raising awareness of the Week in their own organisations by, for example, encouraging people to sign a pledge and supporting local initiatives, where appropriate. Report of the Assistant Chief Executive (Legal and Democratic Services)

North Yorkshire Health and Wellbeing Board - Membership

1. Purpose of Report

1.1 To seek the Board's approval to its membership being extended to include, as Coopted Members, one representative from Primary Care and one representative from Care Providers.

2. Background

- 2.1 As mentioned in the previous report on Membership, considered by the Board on 23rd November 2018, because of the size of the County and the number of potential participants, the Board comprises *representative* categories of membership, in addition to the prescribed statutory membership. For example, there is currently one Chief Executive representing the four main Acute and Community Hospital Trusts in the Board's area.
- 2.2 At present, there is no representation from either Primary Care or Care Providers. It is suggested that the Board would benefit from extending its membership by one representative from each of these areas.
- 2.3 Primary Care plays a key role in helping to deliver the Board's objectives particularly on prevention initiatives. The recent Workshop that the Board facilitated on the Care Market, highlighted the contribution that a representative from Care Providers could make to the work of the Board.
- 2.4 The recently published revised GP contract describes the development and roll-out of Primary Care Networks across existing GP practices nationally. In North Yorkshire we have been working in partnership with practices and the Local Medical Committee to include primary care in our work to integrate and co-locate services around natural local populations. This national development supports our Health and Wellbeing Board's stated ambition of integrated primary and community care services provided locally, through groups of practices and services working together. Having our primary care partners around the table is recognition of the important and changing role that primary care will play as we move forward. It will be important to be able to articulate a North Yorkshire wide ambition and strategic approach that can be delivered locally through the networks and which aligns with our overall strategy.

- 2.5 Should Members be agreeable to this suggestion, it is proposed that the three CCG Accountable Officers discuss Primary Care representation and make a nomination and that the Independent Care Group be asked to submit a nomination in respect of Care Providers. In both cases, a designated substitute should also be nominated.
- 2.6 The Board has previously decided that Co-opted Members should have voting rights. It should though be noted that, in reality, the Board operates by consensus and a formal vote is rarely taken.
- 2.7 In accordance with the decision of the Board when it last extended its Membership, by the appointment of a representative from the Emergency Services in November 2018 (Andrew Pippin, from the Yorkshire Ambulance Service), the appointments will be until the County Council Elections in 2021.

3. Recommendations

- 3.1 That the Board consider whether it wishes to extend its membership to include, as Co-opted Members, with voting rights, one representative from Primary Care and one representative from Care Providers, subject to the approval of the County Council.
- 3.2 That, if the Board does agree to extend its membership:
 - a) the three CCG Accountable Officers discuss and agree a nomination and designated substitute for Primary Care; and
 - b) the Independent Care Group be asked to nominate a representative and designated substitute from among Care Providers.
- 3.3 That it be noted the appointments will be until the County Council Elections in 2021.

Report of the Assistant Chief Executive (Legal and Democratic Services)

Theme updates 2018/19 and themes for 2019/20

1. Purpose of Report

- 1.1 Firstly, to update the Board on the progress against themes in 2018/19.
- 1.2 Secondly, to seek Members views as to how the themed approach has worked during its first year and its thoughts on the consideration of themes for 2019/20 (i.e. with effect from the May 2019 meeting of the Board.)

2. Background

- 2.1 Last year the Board agreed to change the way that it conducts its business, moving away from an approach that was primarily transacting formal business towards a Workshop type approach, whereby the Board and invited stakeholders aim to find collaborative solutions to matters that transcend sector and affect county and district authorities.
- 2.2 The themes that were chosen were *Digital*, *Mental Health* and *Housing and Health*.
- 2.3 An update on each of the themes has been provided at recent meetings and a further brief update will be provided by theme leads as part of this report.

THEME UPDATES - 2018/19

2.4 In outline, good progress has been made against each of the themes. For example:-

Digital (Robert Ling)

- 2.5 Gartner IT Consultants facilitated a Workshop in March 2018 which helped the Board shape its thinking on this issue. In addition to Board Members, it was attended by representatives of Care Providers, Hospices and Airedale NHS Foundation Trust.
- 2.6 The theme is led by Robert Ling, Assistant Director, Technology and Change and has been progressed by a draft Digital Strategy, *My Health, My Tech*, considered by the Board in November 2018, which is currently out for consultation.
- 2.7 Funding of £50,000 from existing budgets has been agreed to fund, depending on the bid ideas submitted, either two grants in the region of £25,000, or four grants in the region of £12,500, to develop innovative ideas to address challenges of better

- connecting rural communities and supporting mental health and wellbeing by reducing loneliness for people who are digitally excluded.
- 2.8 The Board will hold a Dragons Den type Event on 24th May 2019 the Digital Innovation Challenge at which shortlisted providers will be invited to make a pitch to the Board on their ideas.

Mental Health (Amanda Bloor and Richard Webb)

- 2.9 This theme is led by Amanda Bloor, Accountable Officer for Hambleton, Richmondshire & Whitby; Harrogate and Rural District and Scarborough and Ryedale Clinical Commissioning Groups and Richard Webb, Corporate Director for Health and Adult Services.
- 2.10 It was launched by a Mental Health Summit, Mental Health Moving in the Right Direction ~ MHRD, in May 2018. The Summit focused on mental health and wellbeing across North Yorkshire and was attended by almost 100 people working in the statutory, community and voluntary sector, as well as people accessing services or with a special interest in mental health from the public, private and voluntary/community sector and people who use services.
- 2.11 From this, an Action Plan has been produced, as reported to the Board in November 2018. Implementation is on-going and progress will be reported to the Board regularly.
- 2.12 In addition, several initiatives are in the pipeline. These include:-
 - submitting a partnership application for North Yorkshire to be a time change hub;
 - delivering a series of events to promote the refreshed self-harm pathway across the county; and
 - agreeing opportunities for additional investment over the long term, through the NHS Ten Year Plan

Housing and Health (Janet Waggott)

- 2.13 The Board facilitated a Workshop in September 2018 which was attended by Housing Associations, Extra Care Providers and District Councils.
- 2.14 Janet Waggott, Chief Executive of Selby District Council and Assistant Chief Executive, North Yorkshire County Council, is leading on this theme. Janet represents North Yorkshire District Councils Chief Executives on the Board.
- 2.15 At its meeting in January 2019 the Board were updated on progress so far, which includes:-
 - Janet Waggott agreeing to be the link between the Strategic Housing Board and the Health and Wellbeing Board;
 - partners working more closely together to identify supported housing/living needs through structured needs assessment and examining housing stock;

- a workshop to develop an outcome-focused specification by the County Council and District Councils, in partnership, following a Homelessness Prevention Review; and
- implementation of a new Assistive Technology Service

Care Market (Dale Owens)

2.16 Whilst there are no plans to expand the themes chosen until further progress is made, given the pressures on the Care Market, a workshop was held in January 2019. Dale Owens, Assistant Director for Care and Support, is leading a group that will agree on the next steps and will report back to the Board further, as part of his update at today's meeting.

CONSIDERATION OF THEMES FOR 2019/20

- 2.17 The views of Members are sought on the themed approach. How do people feel the approach has worked; what has gone well and what could we look to improve or do differently?
- 2.18 The proposal is that the existing themes be continued into 2019//20. The rationale for this is that, whilst some good progress has been made, more tangible outcomes are required before work starts on other themes. In addition, in terms of doing justice to the themes being considered, the current number of themes is, realistically, about the maximum number that can be accommodated. Members views are sought on this suggestion. It is also worth noting that work could arise from a potential Integrated Care Partnership (ICP) Work Programme.

3. Recommendations

- 3.1 Members are asked to note the progress against the existing themes and to agree that the four existing themes continue. This recommendation is made on the basis that:-
 - whilst good progress, has been made across each theme, more tangible outcomes should be achieved before consideration is given to other themes;
 - four themes would seem to be about the maximum that can reasonably be sustained at one time in order to do justice to each and achieve positive results; and
 - it is possible that further work could arise from a potential ICP Work Programme.
- 3.2 Members are also asked to share their thoughts as to how the themed approach has worked during the past year what has gone well and what could be improved or undertaken differently?

1. Purpose of Report

1.1 To seek approval to a draft Protocol between this Board and the Scrutiny Committees referred to in the title of this report.

2. Background

- 2.1 As part of the Yorkshire and Humber Association of Directors of Adult Social Services (ADASS) Regional Peer Challenge Programme (which is run with the Local Government Association), an authority can invite an Inspection Team to review its services.
- 2.2 The programme is not a regime of Inspection and seeks to offer a supportive approach undertaken by 'critical friends'. It is designed to help an authority and its partners assess current achievements and areas for development within the agreed scope of the review.
- 1.2 The Health and Adult Services Directorate at North Yorkshire County Council invited an Inspection of its Service, with a particular emphasis on *use of resources*.
- 2.3 The Inspection was undertaken in June 2018 and the feedback from the Inspection Team was extremely positive. One of the suggestions, however, was that it would be helpful to have a Protocol between Scrutiny and the Health and Wellbeing Board.
- 2.3 The enclosed, self-explanatory, draft Protocol has been discussed with the Chairs and Vice-Chairs concerned. Its intention is to be brief and simple; a case of *less is more*.
