Rights of Way Improvement Plan Progress Report

1.0 PURPOSE OF REPORT

1.1 To provide a progress report with regard to the Rights of Way Improvement Plan for North Yorkshire.

2.0 BACKGROUND

- 2.1 Local access forums are required to provide input into the production of Rights of Way Improvement Plans (RoWIPs). There are three local access forums in North Yorkshire, one for North Yorkshire outside the National Park Authority areas and one each for both the North York Moors National Park and Yorkshire Dales National Park.
- 2.2 One Rights of Way Improvement Plan is being prepared for the whole of the County which will be gradually merged into the Local Transport Plan for North Yorkshire. This is a progress report regarding the preparation of the RoWIP.

3.0 CURRENT POSITION

3.1 The technical team (composed of officers from North Yorkshire County Council, the North York Moors National Park and the Yorkshire Dales National Park) meets each month to review progress with regard to the preparation of the RoWIP. The table below outlines key dates which need to be met in order to deliver the plan before the statutory deadline. The project plan is tight. It only allows for 2 months slippage.

- 3.2 An internal consultation is being carried out upon the initial draft RoWIP before the draft goes out for statutory public consultation in early 2007. The plan is therefore being circulated within the County Council, two National Park Authorities and to members of the steering group which includes the seven District Councils and three Areas of Outstanding Natural Beauty.
- 3.3 All members of the three local access fora in North Yorkshire should have received a hard copy of the draft RoWIP together with supporting technical summaries which are contained on an accompanying CD.
- 3.4 LAF members have been invited to respond to the draft plan. Local Access Fora have also been asked to nominate six members to attend a joint LAF event which is being held on the 22nd November 2006. This more informal event is being held to discuss the draft plan in more detail with Officers from the Technical Work Group.
- 3.5 A RoWIP steering group meeting is being held on the 28th November. This has been attended in the past by two members from each LAF, that is the chairperson and one other member. The steering group includes members from the seven District Councils, Area of Outstanding Natural Beauty, Technical Work Group and Highways North Yorkshire.

4.0 <u>RECOMMENDATION</u>

It is recommended that:

- a) This report is received for information.
- b) Members provide responses to the draft plan either individually by writing/e-mailing the RoWIP Officer or to members who have been nominated to attend the joint LAF event on the 22nd of November 2006.
- c) The names of the two members who will attend the RoWIP steering group meeting on the 28th November are confirmed to the RoWIP Officer.
- d) Any initial comments which members wish to make which will be held on public record are welcome at this meeting however the plan is not yet in the public domain.
