# PUBLIC RIGHTS OF WAY DEFINITIVE MAP MODIFICATION ORDER AND DIVERSION ORDER APPLICATIONS - AN UPDATE

- 1.0 PURPOSE OF REPORT
- 1.1 To provide an update to members on progress with processing Definitive Map Modification Order and Diversion Order applications since November 2009. The cases referred to are listed in the attached schedules.
- 2.0 RECENT DMMO AND PUBLIC PATH ORDER DETERMINATIONS
- 2.1 Since November 2009` 19 applications have been fully completed:-
  - Creation Agreements 3
    Diversion Orders 6
    DMMOs 9
    Extinguisment Order 1

These Orders are detailed in Appendix 1.

#### 3.0 CREATION AGREEMENTS

3 Creation Agreements have been completed, one following a request from South Stainley Parish Council who had liaised with the landowner, for Lavender Walk, one was undertaken in conjunction with an Extinguishment Order in Colton to provide an alternative footpath and the third one was undertaken with the Highways Agency to provide a bridleway crossing and adjacent to the new A1 junction west of Lumby.

#### 4.0 DMMOs

- 4.1 The application for a footpath across the school grounds at Harrogate Grammar School was considered at a public inquiry in December. The Inspector's decision upheld the county council's view that the evidence did not support 20 years unhindered use of one particular path across the site. The order was not confirmed.
- 4.2 A further DMMO application was considered at a public inquiry in early March. This was for the downgrading of a section of bridleway near the Applegarth Farms in Richmond and Marske. The Inspector's decision was that the Order should not be confirmed. Now that the 3 month period allowed for appeals to be

made has expired, contractors have been engaged to provide gate in place of the stiles that had obstructed the bridleway for more than 60 years.

- 4.3 The application made by Brompton by Sawdon Parish Council for a footpath off Hungate in the middle of the village has also been confirmed.
- 4.4 7 applications have been rejected due to insufficient evidence to satisfy the required criteria.
- 4.5 DMMOs In Progress -\_There are 38 further DMMO applications which are in progress at various stages. Within these falls the application submitted by the British Horse Society for a bridleway to be added to the Definitive Map at the site of the former Skewkirk Bridge between Kirk Hammerton and Tockwith. The matter has now been reported to the Planning and Regulatory Functions Sub-Committee, who have accepted the recommendation, and have resolved that a DMMO should be made. The Order has been drafted and will be advertised shortly. At the same Committee meeting the Committee also resolved that an DMMO should be made for the footpath between Quaker Terrace and Black Bull Yard at Masham.
- 4.6 New DMMO Applications -

7 new applications for a DMMO have been received since November 2009.
