5.0 PLOUGHING AND CROPPING

5.1 The process of bi annual surveys continues into its fifth year with the spring survey currently underway. Volunteers continue to

undertake the initial survey with follow up by Rangers where failures are identified.

5.2 The following table summarises the position we had in Autumn 2011:

- 5.3 The total in brackets represents the routes found to be satisfactory, 105 in total with 66 found to be unsatisfactory.
- 5.4 Of the 66 fails all were contacted again and most restored satisfactorily, with 3 requiring further action.
- 5.5 The following table shows the position at the commencement of the spring 2012 survey.

- 5.6 Fewer incidents are being reported of Ploughing and Cropping hence the first time survey figure is decreasing.
- 5.7 There are a greater number being surveyed for the third time however it should be noted that up to 20 routes will be dropped from the system should this inspection show a positive result.

6.0 PROJECTS

6.1 A number of significant projects were also completed during the year.

- 6.2 Following successful landowner negotiations, the Settle Riverside cycleway was extended to link the riverside area with a substantial housing development, again the majority of the required funding (in the region of £150000) was secured from external sources.
- 6.3 In pursuance of meeting our statutory duty to signpost all routes from the roadside, a project was completed to install over 300 signposts.

7.0 ANALYSIS
