NOTES

(a) Interests

The Local Access Forums (England) Regulations 2007 state:-

(7) "A member of a Local Access Forum who is directly or indirectly interested in any matter brought up for consideration at a meeting of the Forum shall disclose the nature of his interest to the meeting".

Those members of the Local Access Forum who are County Councillors are also bound by the North Yorkshire County Council Members' Code of Conduct, as they serve on the Forum as County Councillors. County Councillors must, therefore, declare any interest they may have in any matter considered at a meeting and, if that interest is financial, must declare it and leave the meeting during consideration of that item.

(b) Emergency Procedures for Meetings

Fire

The fire evacuation alarm is a continuous Klaxon. On hearing this you should leave the building by the nearest safe fire exit. From the **Grand Meeting Room** this is the main entrance stairway. If the main stairway is unsafe use either of the staircases at the end of the corridor. Once outside the building please proceed to the fire assembly point outside the main entrance

There are alarm points at each end of the Meeting Room corridor and at the main stairway.

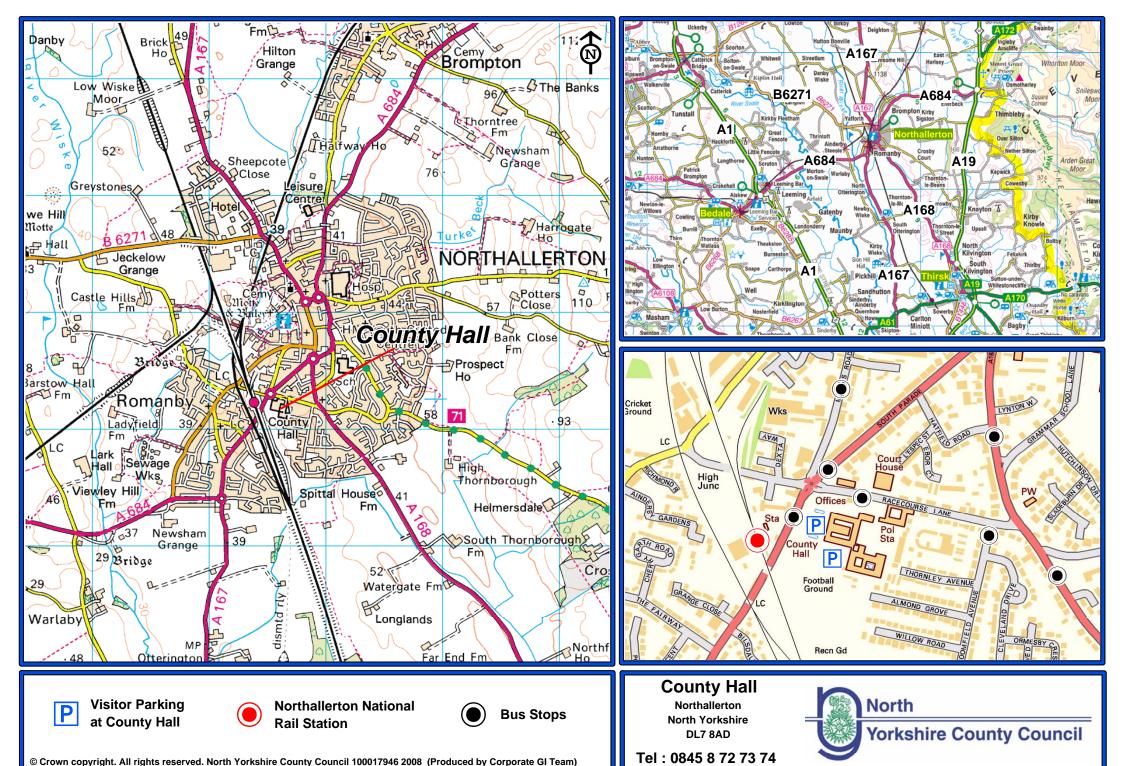

Minutes of the meeting held in The Grand Meeting Room, County Hall, Northallerton on 11 February 2015, commencing at 10 am.

The Chairman paid tribute to Chris Clarke who had died suddenly in January.

85. Apologies for absence

Apologies for absence were received from Doug Cartwright and County Councillors John Fort BEM and David Jeffels and Iain Burgess (NYCC Countryside Services).

86. Minutes

Resolved -

That the Minutes of the meeting held on 19 November 2014, be agreed as a correct record and be signed by the Chairman subject to the following:-

<u>Min No 78 – Meeting with David Bowe – NYCC Corporate Director – Business & Environmental Services.</u>

5th paragraph - delete the word 'not'.

Meeting with Penny Noake & Iain Burgess - NYCC ROW Priorities

8th paragraph, second sentence be amended to read 'Not all Members favoured resources being diverted into PROW from other services such as education and social care and were supportive in principle of the PROW network being maintained at a minimum standard'.

87. Public Questions or Statements

There were no questions or statements from members of the public.

88. Matters Arising

Review of Waste & Countryside Services

Consultation on the proposed new staffing structure had now concluded. Responses were in the process of being collated and it was anticipated that the final structure would be announced before the date of the next meeting.

Lickber Lane, Melmerby, Richmondshire

Responses to two letters written by the Chairman to Barrie Mason (NYCC Assistant Director Highway) were outstanding. The Chairman asked for her disappointment to be recorded.

A response from NYCC Highways was also outstanding in respect of a letter sent by the Forum regarding the Scotch Corner Retail development.

89. Schools and Education Project

Considered -

The Forum received for information a report from Roma Haigh on progress of a project aimed at promoting outdoor access for school children that had been agreed at the previous meeting.

Members looked forward to receiving further updates in due course.

Resolved -

That the content of the report be noted.

90. Achievement of Minimum Statutory Standard

Considered -

A report of the Forum's Sub-Group asking the Forum to endorse its advice and recommendations to the County Council on how best to achieve minimum statutory standards for the rights of way network in North Yorkshire.

The Forum was advised that an initial draft of the report had been presented to lan Fielding (NYCC Assistant Director Waste & Countryside Services). Ian Fielding had welcomed the advice in respect of maintenance priorities but had commented that he would appreciate more clarity on what the Forum thought the priorities should be for the Definitive Map Team.

A Member asked if the priority outlined in Section 4.1 of the report (ensuring that all ROWs were included on the Definitive Map by the 2026 deadline) was intended to take precedence over production of a new Definitive Map. It was suggested that protection of routes should take precedence, but it was acknowledged there was little point recording routes that were not capable of being used.

Members said that until the content of the Deregulation Bill was known it would be very difficult for them to recommend priorities for the Definitive Map Team due to the technical issues involved. A Member commented he was surprised that the County Council was seeking to make long term decisions about staffing in advance of publication of the Bill and this was at variance with other organisations.

Members discussed paragraph 4.2 of the report

"The Forum urges NYCC to recognise that statutory consultees and Parishes have a role in alerting the Planning Authority if there are any ROW issues".

The Chairman pointed out that planning application forms had recently been changed. Previously, applicants were required to specify if ROW would be affected by proposed developments. This was no longer the case. Declarations about ROW were now at the discretion of the Applicant. The Chairman said she had asked for this issue to be discussed at the forthcoming LAF Regional meeting and was seeking

their support to recommend that the wording on new planning application form was amended.

Members expressed overwhelming support for the Forum to adopt the content of the sub-group's report and called for a formal response from the County Council. It was agreed that a relevant NYCC officer would be invited to attend the next meeting and for the matter to be listed as a separate specific item on the agenda. Members further requested that NYCC be asked to provide their response in writing in advance of the meeting (to be circulated with the agenda).

Resolved -

- (a) That the Forum endorses and adopts the recommendations in the report of the sub-group on how to best achieve minimum statutory standards for the rights of way network in North Yorkshire.
- (b) That North Yorkshire County Council notes that the NYLAF wish to be consulted on the development by the County Council of its strategy to prioritise ROW resources.
- (c) That the County Council be requested to provide a written response to the sub-group report and for an NYCC Officer to attend the next meeting when the matter will be listed for discussion on the agenda.

91. Public Rights of Way Definitive Map Orders and Processes - An Update

Considered -

The report of NYCC Definitive Map Team Leader updating Members on progress processing Definitive Map Modification Order and Public Path Order applications since September 2014.

A Member asked what was happening regarding an amended management and maintenance proposal raised at a previous meeting that involved the PROW Service and a transfer of maintenance and management arrangements for urban PROW. In response it was agreed that a report on this would be referred to the next meeting.

Resolved -

That the report be noted.

That a progress report on a management and maintenance proposal involving the PROW Service and a transfer of maintenance and management arrangements for urban PROW be added to the work programme and considered at the next meeting.

92. Minerals and Waste Joint Plan - Supplementary Sites Consultation

Edward Dennison declared an interest in two of the additional minerals and waste sites.

Considered -

The report of the Definitive Map Officer advising the Forum of the current Supplementary Revised Sites Consultation. The report invited Members to submit a response in respect of the identified minerals and waste sites. Attached to the report was a copy of the letter inviting comments.

The Chairman said that maps of the additional sites did not show access provision clearly. The situation was compounded by the new planning application forms (referred to earlier in the meeting) which did not require Applicants to disclose if ROW would be affected by proposed developments. The Chairman said she had spoken to NYCC Planning Officers who had agreed to provide her with the necessary information by the end of the week. Upon receipt, the Chairman said she intended to look at each site individually with a view to submitting comments. Any offers of assistance were welcomed.

A Member highlighted the national problem of site restoration. Enforcement of planning conditions was often ineffective due to the organisations responsible being difficult to trace. County Councillor Robert Heseltine stated that based on his experience as a Member of the County Council's Planning and Regulatory Functions Committee, North Yorkshire had a good track record with regard to site restoration. Members asked if it would be possible for North Yorkshire to ask for a bond to cover the cost of site restoration. The Forum was advised that this would require a change in the National Planning Regulations.

The Chairman said that any response submitted on behalf of the Forum would highlight concerns around the enforcement of site restoration schemes and call upon the planning authority to take whatever steps were available to ensure planning conditions were adhered to.

Resolved -

That the Supplementary Revised Sites Consultation be noted.

That the Chairman together with Roma Haigh and Tom Halstead draft responses on behalf of the North Yorkshire Local Access Forum to the consultation on additional waste and minerals sites.

93. Highway Asset Management Database - Symology

Considered -

The report of the NYCC Senior Ranger on use of the Highway Asset Management Database - Symology.

Members were advised that further updates would be provided in due course.

Resolved -

That the report be noted.

94. North York Moors National Park Local Access Forum

Considered -

The Forum received for information the Minutes of a meeting held on 2 December 2014.

A Member referred to the item on 'England Coastal Path' and proposed that the Forum should submit a formal response to the consultation in respect of the small section of the path that was within North Yorkshire boundaries between Scalby and Filey.

The Chairman agreed to contact the National Park with a view to ascertaining if members of the North Yorkshire Forum could attend the national park sub-group meeting when the proposals were discussed following publication of the consultation.

Resolved -

That the Minutes of the meeting held on 2 December 2014 be noted.

95. Yorkshire Dales National Park Local Access Forum

Considered -

The Forum received for information the draft Minutes of a meeting held on 30 September 2014.

Resolved -

That the draft Minutes of a meeting held on 30 September 2014 be noted.

Considered -

The report of the Public Rights of Way Team Leader setting out possible future agenda items. Members were requested to forward any requests they had for future agenda items to the Secretary.

It was agreed that the Chairman together with Roma Haigh and Paul Sherwood would attend the meeting of the Regional Local Access Forum on 6 March 2015.

Penny Noake advised that she had been contacted by the LAF Co-ordinator at the Yorkshire Dales National Park asking if Members would be interested in attending a joint training event hosted by the National Park. The Chairman agreed to circulate Members with further information about the event following the meeting.

Members asked what was happening with regard to recruitment in light of what lan Fielding had said at the September meeting about a possible reduction to the frequency of meetings and membership size. Members pointed out that their current term of office was about to draw to an end.

Members were not in favour of a merger of North Yorkshire Local Access Forums and considered that any reductions to the size of the membership and frequency of meetings would be detrimental to geographical representation.

The Chairman agreed to draft a letter setting out the Forum's position for Members to approve prior to posting.

Resolved -

That the content of the Forward Plan be noted and approved and the suggestions made during the meeting and recorded in the Minutes incorporated.

Report of the Secretary

1.0 Purpose of the Report

1.1 To advise members of the current consultation on the North Yorkshire Local Transport Plan and to invite the Forum to consider whether it wishes to respond to the consultation.

2.0 Background

- 2.1 The local transport plan is a set of documents that the government requires all local transport authorities to produce. The documents set out plans and strategies for maintaining and improving all aspects of the local transport system over a set period of time.
- 2.2 As the highway authority, North Yorkshire County Council is responsible for all adopted roads and footways within North Yorkshire (excluding trunk roads and motorways) and for the management, maintenance and improvement of the highway network. The highway network consists of approximately 9,200km of road, 4,000km of footway, 47,000 streetlights and 2,000 bridges.
- 2.3 North Yorkshire County Council is currently working on a new local transport plan which will set out the council's priorities, plans and strategies for managing, maintaining and improving all aspects of the local transport system for the next 30 years.
- 2.4 Consultation on the draft plan is taking place until 30 November 2015. The consultation can be viewed here:

2.0 Background

- 2.1 North Yorkshire County Council, City of York Council and the North York Moors National Park Authority are producing a minerals and waste joint plan which will cover the period up to 2030.
- 2.2 Preferred options is an important stage of the development of the minerals and waste joint plan. It takes forward the selected options from the issues and options consultation and develops them into preferred options which, if found suitable, will form the basis of the final draft policies before submission of the plan for examination in public by an independent inspector.
- 2.3 Following assessment, using the procedures identified in the site identification and assessment document, a selection of sites have been identified as suitable to enable the delivery of relevant preferred policies in the plan.
- 2.4 The preferred options for both policies and sites are presented in the preferred options consultation documents. A leaflet summarising the consultation is attached as Appendix 1.



About the Minerals and Waste Joint Plan

As mineral and waste planning authorities, North Yorkshire County Council (NYCC), City of York Council (CYC) and the North York Moors National Park Authority (NYMNPA) are working together to prepare a Joint Minerals and Waste Plan. When finalised, this will be a long term plan to help take decisions about matters such as where, when and how minerals, including gas, and waste developments should take place up to 2030.

Progress so far

Work on the Joint Plan started in May 2013 when we sought views on what the Plan should contain. We used these responses to help identify the key issues facing the area and identified possible policy options on how to deal with them.

The Issues and Options consultation in February 2014 set out a number of possible options for new policies to deal with the key issues. It also included a number of sites for minerals or waste development which had been submitted for consideration for inclusion in the plan.

As a result of additional sites coming forward, a second round of consultation was carried out in the form of the Supplementary Sites consultation, which commenced in January 2015.

We have looked at the responses received to our earlier consultations, together with other available evidence, and are now seeking your further views on the preferred policy approach.

We would like to know what you think about the preferred policies, and sites that we have identified, the draft vision and objectives and the policy options contained in the full **Preferred Options Consultation**.

Next Steps

A further consultation on a final draft version of the Plan will take place in 2016.

Minerals - Policies and Sites

The Plan area is a significant producer of minerals with over 50 active quarries. The Preferred Options consultation set out draft policies to respond to the key issues, some of which are identified below:

- Ensuring continued availability of important minerals;
- Maintaining the required supply of sand and gravel, crushed rock, silica sand and clay in line with national planning policy
- Considering the potential positive and negative impacts of developing unconventional hydrocarbons resources such as shale gas, as well as planning for conventional forms of energy minerals;
- Encouraging the use of more sustainable alternatives to supply of aggregate minerals;
- Safeguarding important minerals resources and infrastructure for the

future:

- Minimising the local impacts of minerals extraction on communities, the environment and other important matters;
- Providing for a range of benefits through reclamation of workings.

In addition to the draft policies the consultation identifies a number of sites that are considered suitable in principle, subject to necessary planning permission, for future quarrying and related development.



Waste - Policies and Sites

Waste is produced by a wide range of domestic, commercial and industrial activities, sometimes in large quantities. The Preferred Options consultation sets out draft policies to respond to the key issues facing the area in relation to waste.

The key issues covered within the Plan include:

- Promoting more sustainable management of waste such as through more recycling and less landfill;
- Supporting the provision of the additional waste management capacity expected to be required to meet future needs;
- Providing flexibility to help deal with uncertainty resulting from rapid changes to waste technologies and practise;
- Identifying the right types of locations for waste management facilities;

- Minimising the impacts of waste management on communities, the environment and other important matters; and
- Safeguarding strategically important waste management infrastructure for the future.

In addition to the draft policies, the consultation identifies a number of sites which are considered suitable in principle for waste development.



Countryside Access Service Review

Report of the Corporate Director - Business and Environmental Services

1.0 Purpose of Report

1.1 To inform members of the LAF of the current review of NYCC's Countryside Access Service, and to suggest how LAF members might provide practical advice and support within that review.

2.0 Background

- 2.1 The Countryside Access Service went through a restructure process in 2015/16 as part of the council's 2020 change programme. New staffing structures for both the Public Rights of Way team and the Definitive Map team went live on 1st October 2015.
- 2.2 The service is now undertaking a full service review to ensure that it delivers an appropriate and sustainable service that meets the county's statutory duties in respect of the Public Rights of Way network.

3.0 Countryside Access Service Review

- 3.1 The comprehensive service review process is considering the following aspects of the service:
 - Service objectives and policies,
 - Detailed working processes and procedures, including IT systems used by the service.
 - Public documentation and communications,
 - Approach to prioritising the PRoW network,
 - Approach to prioritisation of maintenance and improvement works,
 - Approach to enforcing landowner responsibilities,
 - Defining service standards.
 - Providing more opportunity for volunteers and other interested groups to support the maintenance of the network,
- 3.2 The review process is intended to be a fundamental and comprehensive reworking of how the service operates. Outline timescales are that we intend to have agreed a new policy framework and prioritisation model by April 2016. Follow up work to define our service standards will follow on as a second key piece of work, with the intention that clear service standards are published by June 2016.

3.3 The immediate priority within the programme is to develop detailed proposals on our proposed service objectives and policy framework, our guidance to the public over the approach they can expect from us, and our proposals over how we will prioritise routes and issues reported to us. These proposals will need to be set out in a public consultation document.

4.0 Potential role for Local Access Forum

- 4.1 The service would welcome the advice and guidance of the LAF in this development process. Given the timescales and the need for detailed consideration of (for example) complex prioritisation models, it may be more practical for the service to engage a smaller sub-group of interested LAF members in January. This would ensure that the LAF had input into the proposals to go forward for public consultation in February and March of 2016.
- 4.2 If the LAF found this approach useful, we would seek to take the same approach to developing proposals around service standards which is the other element that will need a period for public consultation.

5.0 Legal Implications

5.1 Consideration has been given to the potential for any legal implications arising from the recommendations included in this report. It is the view of officers that there are no legal implications.

6.0 Financial Implications

6.1 Consideration has been given to the potential for any financial implications arising from the recommendations included in this report. It is the view of officers that there are no financial implications upon the County Council.

7.0 Equalities Implications

7.1 There are no equality implications of this report given its very simple recommendations. A robust equality impact assessment is being undertaken as part of the service review.

8.0 Recommendations

- 8.1 It is recommended that:
 - i) LAF members take note of the report.
 - ii) LAF consider setting up a smaller working group to advise the service on its consultation documents.

1.0 Purpose of the Report

- 3.3 The Forum is expected to prepare an annual report on its activity and this will need to be scheduled into the forward plan at an appropriate time in the year.
- 3.4 Rachel Connolly, former Chair of the Forum, has provided the attached summary of recent relevant activity (Appendix 1). Members may find this useful in identifying potential items for the forward plan. She has also raised the Schools and Education Project as a potential future item of business.
- 3.5 Members may also want to consider how they wish to manage their business between formal meetings. For example, the previous agenda item proposed the establishment of a small working group in relation to the Countryside Access Service Review.

Around and About during the LAF lapse

David Barraclough was contacted about the Scotch Corner Retail plan which was called in by the SoS, and gave advice.

Roma Haigh was contacted by Ryedale and Scarborough about their local plans, and has got tabs on them

Rachel Connolly asked Rishi Sunak, Richmond MP, to support the Outdoor Recreation Bill and explained the importance of diversification to the rural economy. However, it turned out to be a Westminster Hall debate, not new legislation, but Mr. Sunak responded positively with a clear understanding.

Hambleton District Council has had many large planning applications in which Rachel Connolly has been involved, but was required to give a statement on the North Northallerton plan in a personal capacity because, as NYCC was anxious to point out, the LAF was not in existence at the time of her advice.

Rachel has been to a small safety site meeting and three general meetings since April for NMU issues on the A1 upgrade. However, there is a lack of joined up thinking between the construction team and Highways England, and a sense of frustration at the lack of fair or sympathetic attitude to NMU needs from all parties, even NYCC.

There was a regional meeting of the LAFs, but we were not eligible to attend. However, the minutes are available if anyone would like to see them afterwards. The next regional meeting is in February in Hull.

National Rail are planning to replace many of their pedestrian crossings with bridges including steps, so we are informed. This is of concern to LAFs as it will disadvantage those with pushchairs, pushing cycles or in wheelchairs. Inquiries are being made as to the proposals for our area, but pinning someone down for an answer is proving hard.
