# 3.0 Sub-Regional Housing Board – Report of Wallace Sampson (Chief Executive, Harrogate Borough Council)

Enhanced two tier project title: Affordable Housing

Project Description: Working together to increase the number of affordable housing units

## 3.1 Progress to date/update

- (a) The Housing Partnership has established links with the newly established Health and Wellbeing Board via regular updates on how housing can contribute to health and wellbeing outcomes. Colin Dales (Richmondshire) and Wyn Ashton (Craven) have given a presentation to the Board, outlining the links between housing and health and wellbeing, welcoming joint initiatives with health colleagues.
- (b) North Yorkshire Home Choice (choice based lettings) is currently undergoing a review following its first year of operation. Several factors are feeding into this review including feedback from waiting list applicants, research by Joseph Rowntree Trust and Birmingham University, implications of the Localism Act and experience of partners during the first year of operation. A set of proposed changes are currently being discussed between partners and a further update will be given in due course.
- (c) A new initiative to tackle social housing fraud across North Yorkshire is seeking Government funding and is likely to involve the majority of social landlords in York and North Yorkshire. The bid is being led by Veritau with City of York being the fund holding body should the bid be successful. An

earlier project undertaken in York proved very successful, hence the proposal to role the approach out to North Yorkshire landlords.

- (d) The Yorkshire Energy Partnership have been successful in bidding for Government funding to support three work streams all aimed at improving energy efficiency and reducing fuel poverty. The Housing Partnership is working closely with YEP in order to maximise the benefits of these work streams which can be summarised as follows
  - Green Deal Pioneer removing obstacles to improving energy efficiency in rural homes
  - Fuel Poverty Fund replacing inefficient gas boilers in targeted areas
  - Collective Switching delivering a local energy tariff which provides best value for residents
- (e) The LG NY & York Housing Board has considered how to make the links stronger between housing, spatial planning, economic development and transport across the county. There is some appetite among partners to strengthen these links but a lack of clarity on how this can be achieved without diluting the focus and delivery record of the Housing Board. To this end the Board recommended a conference in the new year in order to explore how links can be made stronger. The conference has been put on hold following a report recently considered by the Local Enterprise Partnership. The report considered a 5 Year Growth Strategy in response to the Autumn Statement and proposes that it incorporates housing, skills, transport and worklessness. James Farrar has been invited to the LG NY and York Housing Board in order to outline the draft proposals and explore how the LEP and the Board would work together if housing is to be included in a new strategy. Further updates will be given.
- (f) The North Yorkshire Housing Strategy post, currently funded by Local Authorities, has been reviewed and the LG NY & York Housing Board has agreed that the post will continue to be supported beyond 31st March 2013. A work programme for 2013/14 has been approved.
- 3.2 Barriers to progressing the project over the next period
  - (a) The main barrier continues to relate to current housing market conditions which are hindering the contribution that the planning system can make to affordable homes delivery.
  - (b) Lack of suitable land continues to be a barrier to the delivery of affordable housing.
  - (c) Homes and Communities Agency funding has been cut as part of CSR by approximately 70% which has created a great deal of uncertainty in terms of future outputs. Funding is based on a new affordable housing model whereby rents are up to 80% of market levels. This will impact differently across the county depending on housing benefit levels and the strength of the private rental market.
  - (d) Private sector housing improvement funding ceased from 1 April 2011 as a direct result of CSR. Local Authorities still have the freedom to fund private sector housing renewal from their own funds, but current feedback from Local Authority colleagues is that this area of activity has stopped with Disabled Facilities Grants being the core business.

# 4.0 Sub-Regional Spatial Planning and Transport Board – Report of Ian Stokes (Development Officer (Transport Strategy), City of York Council)

- 4.1 The last meeting of the Spatial Planning and Transport Board took place on 2 August 2012. Since then two meetings of the SP & T Technical Officer Group have taken place.
- 4.2 At the last of these, on 29 November 2012, items for inclusion on a forward programme for the Board and TOG were proposed. However, on preparing the forward programme it was considered that the scope and scale of the work for this programme requires resourcing. Therefore, a report setting out options for how this could be achieved will be submitted to a future TOG meeting after the next meeting of the TOG due to take place on 6 March 2013.
- 4.3 It is expected that this report will then be presented to the Board (at a future meeting for which the date is yet to be determined) for its consideration.

## 5.0 York and North Yorkshire Local Enterprise Partnership

# 6.0 LGYH Council – Report of Councillor Tom Fox (Vice-Chair of LGYH Council) (Scarborough Borough Council)

- 6.1 LGYH last met on Thursday, 13 December 2012 Wakefield.
- 6.2 Leeds Children's Heart Surgery Unit Closure Decision Y&H Joint Health Overview and Scrutiny Inquiry:
  - We were bought up to date with regards to the Leeds Children's Heart Surgery Unit Closure Decision – Y&H Joint Health Overview and Scrutiny Inquiry.
  - We received an update paper from Cllr John Illingworth, Chair, Y&H Joint Health Overview and Scrutiny Committee (JHOSC), on the latest position in relation to the proposed future delivery of Children's Congenital Heart Services in England and the work of the JHOSC.
  - A copy of a recent letter from the Secretary of State for Health to Cllr Illingworth was also circulated and noted. Cllr James Lewis, Leeds CC, informed Members that the Secretary of State for Health had accepted the Independent Reconfiguration Panel's (IRP) advice to include the JHOSC's referral within the scope of its full review currently underway; extending the period of the review to account for the additional referral. Plans for JHOSC input into the IRP review had now started and the JHOSC was due to be invited to identify any specific stakeholder groups it believes the IRP should speak to. It was suggested that LGYH Council Members could be formally consulted as one of the stakeholder consultative groups and suggested that any Members close to the issues may wish to participate.

- It was agreed that any individual LGYH Council Members interested in being part of the IRP stakeholder consultative group make contact direct with LGYH or Cllr John Illingworth direct.
- 6.3 European Funding Programme 2014-2020 Opportunities for Yorkshire and Humber:
  - Isobel Mills (Director, BIS Y&H and North East), Kevin Richardson (EU Structural Fund Practitioner, BIS) and Heather Waddington (Chair, European Officers Network & Kirklees Council) informed the meeting of the process and progress to date of Government involving local government in shaping the new EU funding programmes from 2014-2020.
  - In the context of the proposals giving a key role for LEPs as the building blocks underpinning the new programme, the following key issues were highlighted:
    - LEPs and their partners were being encouraged to now start planning a staged approach to proposals in the run up to the new Programme expected to commence in May 2014.
    - It was seen as important to make the most of opportunities for LEPs to work across boundaries and collaboratively to develop a Y&H-wide position to articulate local authority views and shared priorities.
    - Ensuring the region's local economies are not disadvantaged by the formula used to determine allocations was seen as vital for the LEPs to have and share a robust evidence base to demonstrate opportunities for "growth", rather than focus on "need".
    - Ensuring there is the right level of capacity and expertise in the system (in both LEPs and councils) to deliver the requirements during consultation, evidence gathering and delivery phases.
  - It was also stated that the Y&H European Officers' Network and Y&H Chief Executives' Group, as well as individual local authorities working in their LEP geographies, had been working behind the scenes in helping to shape and influence the initial development of the UK approach towards the new Programme.
  - It was agreed to continue to press the case to ensure Y&H receives its fair share and to propose to MPs that this should be included as a key priority for the APPG for Yorkshire and Northern Lincolnshire going forward. It was also agreed to support the preparations made locally to develop or broaden local strategies that can be turned into an Investment Prospectus for the new funds.
- 6.4 HM Treasury Autumn Statement/Local Government Finance Settlement:
  - A report detailing implications of the Government's Autumn Statement on 5 December, and the expectations surrounding the provisional Local Government Finance settlement (expected on 19 December), considering the impacts across Y&H was noted.

- Two main issues of concern raised by Members during discussion was the impact of the distribution formula and the consultation on changes to TUPE regulations, which should be picked up by LGYH and supporting officers/Networks going forward.
- 6.5 Police and Crime Commissioners (PCCs) Ongoing Engagement:
  - In the absence of Police and Crime Commissioner Member representatives at this meeting (apologies from each PCC had been received), Tricia Holder, Policy Director, Office of the West Yorkshire Police and Crime Commissioner, was invited to update Members on developments in West Yorkshire following the election of Cllr Mark Burns-Williamson.
  - She informed the meeting that Cllr Mark Burns-Williamson, as the newly elected PCC, would be visiting each of the five districts in West Yorkshire and conducting a series of consultation events over the coming months. An online 'Listening to You First' campaign had also been launched to ensure the views of communities were fully represented in the PCC Budget and Police and Crime Plan; with Mark Burns-Williamson recently confirming a decision to pass-port the Community Safety Fund back to local areas for 2013/14. She also informed Members that the PCC team planned to move offices to central Wakefield in order to be more visible and accessible to the public.
  - The meeting welcomed opportunities at future LGYH Council meetings to discuss with the newly appointed Police and Crime Commissioners in Y&H specific opportunities for collaboration on common issues and to be updated on early progress with regard to Budget and Police and Crime Plans etc. One option may be to invite PCCs to present on their local issues at future LGYH Council meetings.
- 6.6 Draft LGYH "Corporate Priorities Plan" & Mid Year Budget Update:
  - A draft three-year LGYH "Corporate Priorities Plan" and budget monitoring report was presented to Members.
  - It was agreed the LGYH "Corporate Priorities Plan" for the three year period (January 2013 to March 2015) and the mid year budget monitoring report was noted and agreed to transfer £88,600 from reserves to fund transitional costs incurred as a result of the LGYH restructure.
- 6.7 Asylum and Migration in Yorkshire and Humber:
  - Cllr Olivia Rowley, Chair of the Y&H Strategic Migration Group and David Brown, Manager, Migration Yorkshire updated Members on asylum and migration developments across the region, including transition in asylum delivery arrangements and changing migrant populations and pressures.
  - It was noted that a similar update had been provided to all local authority Chief Executives at their recent meeting where it had been proposed that LGYH Members receive a similar briefing.

- Cllr Rowley highlighted the importance of the Migration Board of local authorities in the region, which provides a forum for all local authorities to collectively discuss and take forward key strategic migration issues and oversee the work of Migration Yorkshire.
- She also informed Members of the concerns about G4S's ability to deliver the new asylum housing contract within the set timeframe and emphasised the issue of disproportionate housing in specific parts of the region.
- It was agreed to notify all Councils in Y&H, drawing attention to the briefing provided to Members and highlighting the potential benefits of working closely with Migration Yorkshire. It was also agreed that Migration Yorkshire should link and feed in more closely with the Association of Directors of Adult Social Services and Directors of Children's Services networks in the region.
- 6.8 All Party Parliamentary Group (APPG) for Yorkshire and Northern Lincolnshire:
  - An update on the work of the APPG for Yorkshire and Northern Lincolnshire and its recent session, 'Yorkshire's Energy Revolution: Delivering Greener Growth", held on 21 November, was noted by the meeting.
  - Members also noted the forthcoming sessions taking place in 2013 "Skills" on 29 January and "Manufacturing Growth" on 19 March.
  - It was also agreed to include the European Funding Programme as one of the priorities for the APPG going forward (as discussed and agreed at another item of business on the agenda).
- 6.9 Updates and Reports Back:
  - LGA Executive & Boards
    - An update report detailing key strategic policy issues recently debated at LGA meetings since the last LGYH Council meeting and the latest iteration of the draft LGA Business Plan for 2013/14 was also noted by Members.
    - The meeting was informed that Carolyn Downs, Chief Executive, LGA would be attending the next meeting of the Regional Chief Executives' Group meeting on 31 January 2013; and Sir Merrick Cockell would be attending the LGYH Council meeting on 23 May 2013.
  - Yorkshire and Humber Improvement and European Board Update Cllr Roger Stone, Chair, Y&H Improvement and European Board provided an update on recent activity of the Board. He highlighted that the new European funding programme, children's services, welfare reform and health were the board's main ongoing priorities.
  - Employers' Committee Cllr Mark Crane, Chair, Employers' Committee updated Members on workforce issues. Members in particular provided feedback to Cllr Crane on their latest expectations around local pay award budgeting for 2013/14; as well as provided views on local applications of the "Living Wage" principles in some local authority areas.

 Y&H Chief Executives' Group – The notes from the last meeting of the Y&H Chief Executives' Group were noted.

### 7.0 Yorkshire and Humberside European Regional Development Fund Performance Management Board for North East and West Yorkshire – Report of Councillor Derek Bastiman (Scarborough Borough Council)

- 7.1 The last ERDF meeting coincided with Scarborough Borough Council's Cabinet meeting and I was therefore unable to attend.

#### **1. Hambleton District Council**

Ron Kirk provided an insight into the issues being faced by Hambleton District Council in the current economic climate.

Positives: Unemployment 4.8% (Nationally 7.9% Business rate collection – 99% Managed workspace – 65% occupied Industrial Unit - 100% occupied Car Parking income – slightly higher than budget Negotiating the sale of land in Leeming Bar industrial park
Negatives: Businsses can not afford their current rents. No enquires are being made of the 7.5 acres of available land at Leeming Bar Housing benefit claims have increased by 15% Despite planning permission for 1036 new homes – little or no building taking place. Difficulty in engaging with small businesses A discussion was held around the impact of Community Infrastructure Levies and other Public Sector constraints placed on developers and the effect on progress in developing our approved development sites.
