14. Minutes

Resolved -

That the Minutes of the meeting held on 7 July 2017, having been printed and circulated, be taken as read and be confirmed and signed by the Chair as a correct record.

15. Welcome to Yorkshire - Update

Considered -

The oral report of Sir Gary Verity concerning the activities of Welcome to Yorkshire. He advised that:-

- 2017 had been another record year for tourism businesses and visitor numbers across North Yorkshire.
- Challenges for tourism included the staffing implications of Brexit, security issues, inflation, and the quality of some businesses which would benefit from investment.
- Welcome to Yorkshire was on plan in terms of its finances.
- Key work for Welcome to Yorkshire included:- a successful bid for £1M from the Discover England Fund around cycling; a plan to submit a further bid to the Discover England Fund in terms of food and drink; being the beneficiary of section 106 money around the North Yorkshire Moors National Park and Whitby; having a garden themed "The Dales" at the Chelsea Flower Show 2018 to promote gardens in Yorkshire; The Great Exhibition of the North 2018 at which many North Yorkshire businesses would be showcasing their design/engineering/ technology work; planning for the Great Yorkshire Show in 2018; and the 2018 Tour de Yorkshire cycle race in which North Yorkshire's roads would host just over half of the race.

Members expressed support for Welcome to Yorkshire's aim to do for Yorkshire food and drink what it had achieved for cycling.

Resolved -

That the report be noted.

16. UCI Road Cycling World Championships 2019

Considered -

- (a) The oral report of Sir Gary Verity (Chief Executive, Welcome to Yorkshire) introducing the presentation at (b). He advised that the UCI Road Cycling World Championship races were a huge global event and that Yorkshire would be hosting the races in September 2019 when the intention was to start races in all four corners of Yorkshire. The races would be a big boost for Yorkshire's economy, with television coverage on either BBC1 or BBC2 and globally to 180 or more countries. He advised that the routes would be announced publicly in September 2018 in Innsbruck.
- (b) The presentation by Chris Pilling (Chair, Yorkshire 2019 Ltd) and Andy Hindley (CEO, Yorkshire 2019 Ltd) outlining the governance arrangements, key goals,

strategies, funding and support, stakeholders, planning timelines, and risks and opportunities in respect of the UCI Road Cycling World Championships 2019.

Members commented that both the team and the organisation were impressive. During discussion, Members identified a need to explore, in particular, how people attending the races might be encouraged to stay in Yorkshire over the two weekends and to identify commercial opportunities which might be acceptable to the UCI. Richard Flinton (Chief Executive of North Yorkshire County Council and a member of the Board of Yorkshire 2019 Ltd) highlighted that the governance arrangements included a Local Authority Group comprising senior officers from all Councils who were involved and that Sir Gary Verity and Andy Hindley attended the Group's meetings. Richard Flinton also highlighted that there was an aspiration to deliver a cultural festival alongside the 2019 races.

Resolved -

That the report and presentation be noted.

17. York, North Yorkshire and East Riding Local Enterprise Partnership Update

Considered -

The report of James Farrar (Chief Operating Officer of York, North Yorkshire and East Riding LEP) providing an update on LEP performance, advising of a national review of LEPs, and reporting that the LEP was able to submit one bid to the Northern Cultural Regeneration Fund and the reasons why the project 'Constellations: Illuminating Yorkshire Coast' had been identified for submission.

Resolved -

- (a) That the LEP's performance to date, and key risks moving forward, be noted.
- (b) That James Farrar seek the nomination of a Member, who is not currently involved in LEP Boards, to become a member of an Annual LEP Overview and Scrutiny Committee.
- (c) That the selection of the project 'Constellations: Illuminating the Yorkshire Coast' as the LEP's bid to the Northern Cultural Regeneration Fund be noted.

18. 100% Business Rates Retention Pilot

Considered -

The report of Louise Branford-White (Chair of North Yorkshire Finance Officers (Director of Finance, Hambleton District Council)) advising that an application had been submitted to DCLG for a North Yorkshire 100% Business Rates Retention Pilot in 2018/19. The submission covered the existing members of the North Yorkshire Business Rates Pool (North Yorkshire County Council, Craven DC, Hambleton DC, Richmondshire DC, Ryedale DC and Scarborough BC) plus Selby DC and the East Riding of Yorkshire Council. The application identified Scarborough BC as the Lead Authority. The submission indicated that, in total, the proposed pool area would be circa £10M better off under the pilot arrangements. Approximately half would be top-sliced for a shared investment fund. The submission proposed the prioritisation of Broadband connectivity for the funding and, looking ahead, highlighted the benefits of shared investment in housing delivery that such a pilot could bring.

Resolved -

That the action taken be noted and, subject to a successful outcome, the proposals be supported within individual authorities.

19. Devolution

Leaders had a general discussion about the current situation regarding devolution.

20. 2017 Annual Report of the Director for Public Health for North Yorkshire

Considered -

The 2017 Annual Report of Dr Lincoln Sargeant (Director for Public Health for North Yorkshire) entitled "Healthy transitions: Growing old in North Yorkshire". The report was introduced at the meeting by Clare Beard (Public Health Consultant, North Yorkshire County Council) on behalf of Dr Lincoln Sargeant. She highlighted that the report described some of the challenges faced by individuals and communities as they aged. It examined services that helped and explored opportunities for improving systems across social care, health and wider determinants such as housing. It identified that the aspiration was that older people should be recognised as active citizens rather than passive recipients of services.

Richard Flinton (Chief Executive, North Yorkshire County Council) highlighted that housing provision for older people was a pertinent issue and that, whilst bungalows were more expensive in terms of land, they could free-up larger properties.

Resolved -

That the report be noted.

21. General Updates

TITLE OF PAPER: LEP Update

1.0 Summary

- 1.1 This paper provides an update on the performance of the York, North Yorkshire & East Riding Local Enterprise Partnership. It includes;
 - 2017/18 Delivery Update
 - o Business
 - o Skills
 - o Infrastructure
 - National Review of LEPs Governance
 - LEP Funding
 - Future Priorities

2.0 2017/18 Delivery Update

2.1 Business

- 2.1.1 The primary business support function in the Growth Hub, which is branded 'Hows Business' and targets the small and micro business market. It is again on track to exceed its target of 5059 businesses supported. At the end of December the number of businesses was 4088 (81% target)
- 2.1.2 The performance of the EU programmes have been mixed. In particular we have faced challenges in committing innovation and low carbon funds. There are a number of projects with strategic fit we would want to see happen in the region, however EU criteria is proving challenging.

Annex 1 summarises EU Funded Business Support Programmes

2.2 Skills

- 2.2.1 The LEP Skills investment has covered three areas, skills capital, careers and enterprise support with schools and EU funded programmes.
- 2.2.2 The LEP Skills Capital remains on track. An initial priority for the LEP was targeting colleges with poor estate so that students made choices based on the quality of courses rather than the quality of the building. Yorkshire Coast College (Now Scarborough TEC) and Harrogate were targeted as priorities and investment has been made into both.
- 2.2.3 Delivery in rural areas is also a challenge and investments in digital capabilities and remote delivery are underway. This includes
 - Augmented reality at Scarborough Tec specifically targeted at a social care skills shortage in rural areas
 - Future Farms at Bishop Burton Agricultural College
- 2.2.4 The Careers and Enterprise Programme has exceeded its target of 50 schools signed up to the Careers and Enterprise Programme. 56 schools are signed up, leaving only 4 not actively engaged. The driver going forward is to progress schools towards a vision for careers advice which embeds it in the schools and meets an accredited quality standard.

2.2.5 The EU programme has experienced significant performance issues. A fundamental concern is the projects are contracted directly from Skills Funding Agency and/or DWP and the LEP does not hold the contractual levers to project manage. This is a national issue with a national working group and more regionally, all Yorkshire EU Programme Board Chairs jointly writing to government outlining our concerns.

Annex 2 Summarises EU Funded Skills Programmes

2.3 Infrastructure

- 2.3.1 Annex 3 summarises all the LEP Local Growth Fund Investments to date.
- 2.3.2 In Summary, the York, North Yorkshire and East Riding Local Growth Fund has a total value of £146m. Of which £124m is directly managed by the LEP (£83m through LGF and £41m through retained DfT funding) and a further £22m allocated but dealt with directly by the Department of Transport (DfT) and Homes & Communities Agency (HCA). The Programme is to be delivered between April 2015 and March 2021.
- 2.3.3 Of the £124m directly in the LEP's control, £79m has been contracted with spend of £40m to date
- 2.3.4 The LEP has achieved target every year since the launch of its Growth Deal, however significant risks remain to deliver in 2017/18. These include:
 - £3m of Amber Risk
 - £2m which was de-allocated at the last LEP Board meeting from the Bioeconomy grants Programme – A range of alternative projects are currently in the system which will cover this shortfall but all these still need further work towards final agreement.
 - £1m Bridlington Harbour and Marina As a consequence of increased costs identified through feasibility work, alternatives to develop Bridlington Harbour area are being explored.
 - £m Flaxby Business Park. Negotiations continue with the land owner, however delivering in 2017/18 is challenging.
- 2.3.5 Projected spend for the remainder of the Programme beyond 2017/18 is good. 2018/19 looks likely to be the most difficult year but the pipeline of new projects is much stronger now. In 2019/20 the aim is to be ahead of profile so that we have some head room moving into 2020/21.
- 2.3.6 Working in partnership with Directors of Development, the LEP & LA Partners have secured £285,000 to support better collaboration around design and masterplanning and development of the off-site manufacturing opportunities.

3.0 Review of LEP's Governance

3.1 To ensure LEPs are fit for purpose, Mary Ney, a Non-Executive Director of DCLG has published a review of LEP transparency and accountability, whilst a Ministerial Review of LEPs is underway to ensure LEPs are correctly structured and consistent in their approach to support delivery of the Industrial Strategy

- 3.2 This has led to increased scrutiny of LEPs nationally, both formally and through Freedom of Information requests.
- 3.3 W/c 26 February, we were subject to a deep dive audit by Cities & Local Growth Unit. Whilst the formal report is awaited, informal feedback indicates
 - We are strong on governance and decision making, in particular citing the LEP Performance Sub-Group as good practise
 - The public-private relations and partnership are strong and working well
 - The LEP works well with NYCC as its accountable body with NYCC providing robust assurance, however allowing the LEP to operate and make decisions independently.
 - Our key areas for improvement are the website, where we are commissioning NYCC to build a structure similar to Local Authority sites to support easy publishing and access of data.
 - They supported our drive to improve the diversity of the LEP Board, recognising the challenge, but reflecting we are attempting to address the representation on the Board
- 3.4 **A key risk** is related to the Ministerial Review of LEPs, particularly around overlapping geographies. The hiatus whilst government decide which route to take on overlapping geographies could impact on our ability to become one of the first tranche of Local Industrial Strategies.

4.0 LEP Funding

- 4.1 Government have confirmed their commitment to providing £500k per annum funding for the next two years subject to LA's maintaining their match commitment.
- 4.2 In addition the LEP Board approved a capital revenue swap from the Local Growth Fund totalling 1.5% over 3 years. This will provide additional capacity to support delivery of the Local Growth Fund and enable key strategic priorities such Local Industrial Strategy.

5.0 Future Priorities

- 5.1 The National Industrial Strategy was clear that LEPs will co-ordinate regions to develop Local Industrial Strategies to complement the National Strategy. This will be a collaborative strategy developed by the region in partnership with Government.
- 5.2 The Industrial Strategy is based on the 5 foundations of productivity (New Ideas, People, Places, Infrastructure and Business Environment) alongside 4 Grand Challenges (Big Data, Clean Growth, Ageing Society and Future of Mobility).
- 5.3 The importance of place will be critical in North Yorkshire, where the world class environmental assets and natural capital are core to the economy. To stimulate this piece of work, the LEP commissioned a series of think pieces from industry leaders, considering the economy in the future.
- 5.5 A partnership and governance structure is in place to be ready to launch the local industrial strategy by December 2018. This will engage a broad range of regional partners ensuring it is a strategy for the region, co-ordinated by the LEP.
- 5.6 Within this the LEP is working to understand the threats and opportunities posed by Brexit and to capitalise on these. We have been leading some work with rural LEPs nationally and

- are seeking to position the region at the forefront of government thinking as they develop future rural policy.
- 5.7 At the heart of this will be the reform of the Common Agricultural Payments as UK leaves EU. Government have confirmed the amount of CAP will remain for 5 years from Brexit, however there will be a move to a results based payments. This should allow better targeting of payments to where they are most needed and can deliver greatest returns. Payments will also need to support governments 25 year environment plan which is due to be launched shortly.
- 5.8 The LEP have met with the team developing the Shared Prosperity Fund on the back of this rural work.
- 5.9 In summary the priorities for the LEP will be;
 - Maintaining the Local Growth Fund Performance
 - Maximising EU Funding
 - Developing the Local Industrial Strategy
 - Increased transparency
