National context

- Police budgets cut by 20%
- 20,000 fewer police officers
- Lowest number in 20 years
- 40% fewer PCSOs
- Recorded crime is up by 7% from last year (13% in NY)
- No change in 'actual' crime (Crime Survey of England & Wales, 2018)


"An increase in the number of crimes recorded by the police does not necessarily mean the level of crime has increased." (Source: ONS)

Government position

- £14bn 'investment' in policing, up £970m
- Largest since 2010, but assumes £24 PCC increase
- Includes Serious and Organised Crime uplift, as well as Counter Terrorism
- Expectation that PCCs will 'take advantage' of the increased flexibility
- And savings a pre-condition £120m ahead of the CSR
- Strenuous efforts to put policing's case forwards

Four years of investments, notwithstanding 6% (£5m) decrease in central funding

- Operational Mobile Working: £4.6m to £5.78m over 4 years
- Body worn video: £1.4m over 3 years
- Alverton Court: £12.7m
- MAUDS: £1.5m over 5 years
- Vulnerability investment: £3.2m
 - CSE, Sexual and Domestic abuse
 - Safeguarding
 - Digital Forensics / Cyber and Fraud
- Mental health services: £1.4m over 4 years
- Police officers: an increase of 81 officers from December 2017 levels





Our response

- •£11.50 precept rise in 2018/19
- Transform 2020
 - £7.5m additional savings, total of £10m by 2020/21
- Enable North Yorkshire
 - Goes live 1st April 2019
- Local co-location with NYFRS and other partners
- Staff recruitment freeze
- Overtime freeze





Budget pressures and risks

- Real £2.2m cut in government grant
- Factored in £12 increase in precept to balance budget
 - Would deliver a 'stand still' budget
- Increasing public worry and fear of crime
- Pressure on police pay Federation legal action and Scottish settlement – £1.1 - £1.8m or more
- ESN average of £1.3m a year
- Comprehensive spending review
- Funding formula £3.5 £4m from 2021





Public expectations

- Improve non-emergency 101 response
- Very clear and consistent ask to improve local, visible policing
- Improve service, especially 'quality of life' issues and local crime concerns such as street crime, burglary, anti-social road use, ASB and drugs
- Which means more police officers and more PCSOs
- However, officer numbers in *local* policing have reduced as NYP has prioritized 'high harm' demand





Policing Priorities Fund (last precept)

- Enabled recruitment plus 81 from December 2017 levels to 1,400 officers, plus 200 PCSOs
 - 1,390 officers by April, 200 PCSOs in place (average over year)
- FCR more people, extended training facilities, upgraded equipment
 - 101 from average of 4-6 minutes, to 1 min 30 secs (48% answered within 30 seconds)
 - 999 restored to less than 10 seconds
- Victim services
 - Increased services for Child Sexual Exploitation even more children supported
 - Commissioned York Pathways, supporting vulnerable with complex needs via personalised one-to-one support





Consultation findings

- 2,741 responses, 24% more than last year
- Telephone and online surveys
- 65% of telephone and 68% of online support an increase
- Average across the options is to pay £20.73
- Other areas which directly linked £24 increase to officer numbers received majority support
 - Surrey 75%
 - Devon & Cornwall 53.9%
 - Sussex 61%
 - Hampshire 75%





Our opportunity

- One-off opportunity to invest for the future
- Investment in local policing to 'redress' the balance
- Bakes £3.6m into the baseline budget
- Guarantees more police officers, PCSOs and prevention resources in local communities
 - Delivers 'Reinforcing the Frontline'
 - Delivers the public's number one priority
- Next and subsequent years inflationary rise only*
