

Professor Adams outlined the proposals which were being consulted on and particularly drew attention to the proposal which would allow new faith free schools to select up to 100% of pupils based on their faith, whilst ensuring they included pupils from different backgrounds. Members were advised that the consultation period closed on 12 December, 2016, hence the need for urgency and urged SACRE Members to respond, particularly to urge the Government not to remove the current 50% cap on admissions based on faith.	
	Members were advised that responding to consultation as SACRE was not within its formal Terms of Reference, however Members could respond as individuals.

72.	RE INSPIRE PROGRAMME AND LTLRE	
	Olivia Seymour informed Members that teachers were currently finishing their modules at the moment which were timed to end with the start of the Learn Teach Lead RE (LTLRE) project to which funding had been given for this to be expanded into the North of England. There was currently a project in the Chester area and one had just started for the Yorkshire and Humberside region.	
	All the regional SACREs were represented on a steering group and Olivia Seymour advised that a LTLRE project partnered with national research projects and initiatives to improve the quality of RE teaching and learning in schools and commented that two of the teachers who had undertaken the RE Inspire Project had applied for this.

73.	FEEDBACK ON DIVERSITY DAY	
	The Chairman described the events of the day and Rebecca Swift displayed photographs of the pupils who had attended the four workshops comprising Islam, Sikhism, Judaism and Buddhism workshops. Rebecca Swift reported that the workshops were very inter-active and the feedback from participants had been extremely positive. Members were informed that there were sufficient funds left from the Westhill Award to purchase another four artefact boxes from the £4,000 grant funding and that Nasr Emam was to produce DVDs and instructions on how to use the artefacts boxes. 74.	EXAMINATION OUTCOMES	
	Rebecca Swift advised Members that 46% of the cohort of students were entered for the GCSE full course in Religious Studies which had been an increase of 124 entries from 2015. 34 centres out of 46 entered pupils for full course GCSE with some schools entering their whole cohort whilst for other schools Religious Studies GCSE was offered as an option. The increase in entries for the full course GCSE paralleled the increase in A Level entries which were up by 6.8% in 2016 compared with 2015. 33 out of 41 secondary schools undertook Religious Education studies.	
	Attainment in full GCSE grades A* to C nationally was 71.6% with North Yorkshire at 70%.	
	203 students were entered for GCSE A2 Level Religious Studies which was 35 more than 2015. 99% of candidates entered achieved a grade A* to E. A2 Religious Studies was studied in 16 of North Yorkshire's secondary schools and the results showed an improvement in pupils achieving the higher grades which was very encouraging.

75.	GROWING UP IN NORTH YORKSHIRE SURVEY - FEEDBACK	
	Rebecca Swift drew Members' attention to the bi-annual survey where all schools including academy schools were invited to take part in the survey specifically relating to Year 2, Year 6, Year 8 and Year 10 students and there was now a pilot questionnaire for Year 12 students. 20,000 students had taken part in the survey this year. Attention was drawn to the fact that 21% of Year 10 boys implied that they found RE lessons not useful at all.	
	Members were informed that there were also reports on vulnerable groups, such as young carers and free school meal pupils and now contained a minority religious report.

76.	RE ANNUAL SURVEY	
	Members were advised by Rebecca Swift that 141 schools had completed the RE annual survey. One school had no provision at all at Key Stage 4 and nearly half of North Yorkshire schools provided none at Key Stage 5, which was of concern. 98 primary schools followed the North Yorkshire RE syllabus and the rest were church schools which eight church schools followed the Diocesan syllabus some followed both. It was commented that the special schools found it most difficult to access the RE syllabus. 97% were satisfied with the RE agreed syllabus and those that were not satisfied indicated a lack of specialist teachers and not sufficient time and resources for special educational needs. 66% were aware of the new guidance on collective worship and found it helpful and 78% of schools had a daily act of collective worship.
