1.0 Introduction

- 1.1 The Police and Justice Act 2006 introduced Crime and Disorder (Overview and Scrutiny) Regulations that came into force on 30 April 2009. It was agreed that Overview and Scrutiny Committee (External) would incorporate the role of the Crime & Disorder Committee for this authority.
- 1.2 The regulations state that "A Crime and Disorder Committee shall meet to review or scrutinise decisions made, or other action taken, in connection with the discharge by the responsible authorities of their crime and disorder functions, as the Committee considers appropriate but no less than once in every twelve months". The responsible authorities are the local crime and disorder reduction partnership partners.

1.3 Appendix 1: Richmondshire Crime by Ward

Supplied by North Yorkshire Police Performance Team. The attached statistics provide comparative ward-by-ward breakdowns of crime in Richmondshire. Crimes types are broken down into the following categories:

Туре	Meaning
Bicycle Theft	Includes the taking without consent or theft of a pedal cycle.
Burglary	Includes offences where a person enters a house or other building with the intention of stealing.
Criminal Damage and Arson	Includes damage to buildings and vehicles and deliberate damage by fire.
Drugs	Includes offences related to possession, supply and production.
Other Crime	Includes forgery, perjury and other miscellaneous crime.
Other Theft	Includes theft by an employee, blackmail and making off without payment.
Possession of Weapons	Includes possession of a weapon, such as a firearm or knife.
Public Order	Includes offences which cause fear, alarm or distress.
Robbery	Includes offences where a person uses force or threat of force to steal.
Shoplifting	Includes theft from shops or stalls.

Theft from the	Includes crimes that involve theft directly from the victim	
Person	(including handbag, wallet, cash, mobile phones) but without	
	the use or threat of physical force.	
Vehicle Crime	Includes theft from or of a vehicle or interference with a	
	vehicle.	
Violence and	Includes offences against the person such as common	
Sexual Offences	assaults, Grievous Bodily Harm and sexual offences.

ASB data is divided into Environmental, Nuisance and Personal categories – and sub-divided into alcohol related or non-alcohol related.
