My wife, Julia Mulligan, is the Police and Crime Commissioner for North Yorkshire. This office, being 'for gain' appears in my registration of interests form in the County Council's Register of Members' Interests and as such is a disclosable pecuniary interest in any matter to be considered or being considered at any meeting of the Council, Executive, Committee or Sub-Committee of the Council affecting the Police or the office of Police and Crime Commissioner.

#### Reasons for seeking a dispensation:

Since February 2013, I have been granted successive dispensations to allow me to fully participate in business relating to the Police and Police and Crime Commissioner where the business would not bring any personal advantage or disadvantage to me or my wife. These dispensations were granted as the dispensations were in the interests of persons living in the authority's area and it was appropriate to grant the dispensation. The latest dispensation, granted in June 2013, lapsed at the date of the local government elections earlier this year.

I appreciate that since the granting of the first dispensation to me, the Council's Corporate and Partnerships Overview and Scrutiny Committee and Executive have considered the current business case from the Police and Crime Commissioner to assume responsibility for the governance of the North Yorkshire Fire and Rescue Authority. In light of this, I am now seeking a dispensation in relation to Police issues only, and not in relation to matters relating to the Police and Crime Commissioner, to avoid giving any impression that my personal interests outweigh my objectivity.

I am therefore now seeking a dispensation to enable me to speak, vote and be included within the quorum at County Council, Executive, Committee and Sub-Committee meetings when the Council/Executive/Committee/Sub-Committee is considering business which may relate to the Police (where the impact of any decision by the Council/Executive/Committee/Sub-Committee on the item of business would not, in any event, bring any personal advantage or disadvantage to me or my wife), such dispensation to last until the date of the local government elections in 2021.

If the dispensation is not granted, I would have to declare my disclosable pecuniary interest in any such matter and leave the meeting room. My absence would mean that those I represent in my division would be without representation at the meeting and it is therefore my view that the granting of the dispensation is in the interests of persons living in the Authority's area and that it would be otherwise appropriate to grant the dispensation.
