I appreciate being able to influence the debate by speaking but I have some sympathy with my residents' view point that I am impotent in this debate when it comes to voting. As a councillor I do have other issues to deal with – for example I am active with Schools in the area, but this is by far the most important issue for my residents and in the Borough, as I stated earlier.
