#### (b) **Emergency Procedures For Meetings**

#### Fire

The fire evacuation alarm is a continuous Klaxon. On hearing this you should leave the building by the nearest safe fire exit. From the Brierley Room take the first available staircase. If this stairway is unsafe use either of the main staircase or the staircase at the

end of the corridor. Once outside the building please proceed to the fire assembly point outside the main entrance

An intermittent alarm indicates an emergency in nearby building. It is not necessary to evacuate the building but you should be ready for instructions from the Fire Warden.
