Task Group Members chose to visit either the East Barnby or Bewerley Park Outdoor Education Centers. This provided members with an excellent opportunity to meet and talk to the young people using the centers facilities.

# 3.0 <u>4Youth and Adult Services Post Implementation Review (PIR) Task</u> <u>Group</u>

The PIR Task Group set up by the Joint Sub Committee (Economic Development & Young People Overview & Scrutiny Committees) met with Officers on the 17<sup>th</sup> January and agreed the terms of reference for this post implementation review. Officers from both Adult Learning & 4Youth services will each produce a report for Members to consider at their next Task Group meeting arranged for mid March.

The first reports from Adult Learning and 4Youth Services are in the process of being considered at Area Committees. The Task Group agreed that at a

later date, it would be extremely useful to collate the comments and responses made by Area Committees and to use this information as a method of learning about provision and take up from a local perspective. This would be undertaken separately to the PIR but would inform the Task Group and contribute to its report.
