Background

2. In 2006 the Committee took a focussed look at the Sex & Relationship Education available to young people in North Yorkshire. It linked two important aspects of children's health together – namely reducing teenage conceptions and the importance of good sex and relationship education.

North Yorkshire continues to make progress in reducing teenage pregnancy and are the only local authority in Yorkshire and Humber region to have 'achieved or exceeded expected progress'. However, there remain hotspot areas within the County so it is important that the Committee continue to be involved in this particular area and monitor the Council's progress to achieving the 2010 target of a 50% reduction in teenage conceptions.

Presentations from the Teenage Pregnancy Strategic Coordinator and North Yorkshire & York PCT will provide Members with an update on implementation of the Scrutiny Reviews recommendations and developments in the National Teenage Pregnancy Strategy.
