Aiming High for Disabled Children; better support for families (AHDC)

The Background:

- Parliamentary Hearings on Services for Disabled Children
HM Treasury October 2006.
- Comprehensive Spending Review
£340 million in CSR Period.
- Every Disabled Child Matters Campaign.



Aims

- Access and Empowerment for Disabled Children and their families.
- Responsive Services and Timely Support offering prevention and not just in crisis.
- Improving Quality and Capacity of short break settings.

Where the money is going

- Engagement (i.e. Parents Forums) £5m
- Transition Support Programme £19m
- Accessible Child Care £35m
- Provision of Short Breaks £280m

All to form part of a Core Offer – still to be defined.

The Short Break Pathfinders

(Guidance)

‘To create a step - change in the provision of Short Break Services’

‘Transforming Short Break Services’

Pathfinder Programme. Up to 20 LA’s – actually 21

Run one year ahead of main programme.

From 1.4.2008 to act as forerunners.

- To
- Offer insight into challenges and opportunities.
 - Identify critical risks and success factors.
 - Provide learning and best practice to the national delivery programme (beginning 4/09).

Pathfinders must:

- Take a leadership role in the national delivery arrangements.
- ‘Maintain or improve their current expenditure on Short Break provisions across the next 3 years with the short Break programme funding.....providing additionality not substituting current resources’.
- This applies to both LAs and PCTs.



The Process

1. Expression of interest in becoming a Pathfinder
26.10.2007
2. Stage 1 Application (with PCT) 09.11.2007
3. Stage 2 Application (with PCT) 07.12.2007
4. Notification to successful areas 14.01.2008
5. Baseline and Planning Tools 30.04.2008

What we aim to do....

- The development of Contract Care; a fee based fostering service targeted at ASD/challenging behaviour and complex health needs.
- Development, with the PCT, in community/domiciliary nursing arrangements for severely disabled with complex health needs.
- Expansion in range of services offered by CRC's including nursing provision where appropriate to meet the needs of children who require invasive procedures.
- Expansion of sessional community services.
- Test the feasibility of transforming a residential special school to offer 52 week care to the most disabled children.

We want to..

- Maintain disabled children in their families, schools and communities.
- Provide increased access to a comprehensive range of Short Break opportunities.
- Prevent family breakdown by close collaborative work with schools and the PCT.
- Prevent children having to leave North Yorkshire in order to have their needs met.
- Improve transitions for children who can remain in their communities.
- Improve links with Integrated Services.
