2.0 Mid Cycle Briefing - 14th January 2011

Upper Wharfedale Review

- 2.1 Members received a detailed briefing in respect of the decision making and consultation processes undertaken concerning the review of school provision in the Upper Wharfedale area.
- 2.2 Members were made aware of the variety of approaches taken and the options which had been consulted on. It was noted that the consultation period opened on the 18th October and ended on the 17th December having been extended at the request of local stakeholders to allow further time for a considered response to be submitted.
- 2.3 Three Public consultations took place at Kettlewell, Armcliffe and Threshfield and were attended by approximately 280. A valid petition was received opposing the proposals and a debate was scheduled at the Craven area Committee on 6th January.
- 2.4 It was the considered opinion of the Chairman and Vice Chairman that the consultation processes had been thorough, fair and inclusive.
- 2.5 The report detailing the responses received on the Upper Wharfedale Primary Review was considered by the Executive on the 1sr February.
 - <u>Children and Young Peoples Service, Savings and Transformation Strategy Proposals for Project 4</u>
- 2.6 Officers attended to provide an update on moving forward the proposals set out in Project 4 of the Savings and Transformation Strategy and the new structure required for the new integrated Youth Support Service which is required to making savings of £1.35 million.

- 2.7 The Chairman requested that Members of the Committee receive a full update on the new Youth Support Service at their June meeting.
- 3.0 Your Chairman attended the **Childrens Trust Board** on the 2nd February as an observer and considered that the following matters would be of interest to Members of Committee who may wish to add them to their Work Programme:
 - Report on the Mid Year Review of the Children and Young Peoples Plan – to monitor the performance and remedial actions taken where necessary.
 - The progress being made to implement the Look after Children Health Strategy.
 - Youth Justice Service Funding 2011/12 Members to be aware of the very significant changes in how the Youth Justice Service is to receive funding from April 2011 and the significant uncertainties regarding the level of funding available.
- 4.0 The Committee will be interested to learn of the new **Drug Strategy 2010**, launched on December 8, which sets out the Government's approach to addressing the damage that drug and alcohol dependence causes on society. The strategy goes on to outline measures to prevent alcohol misuse amongst young people and to intervene early with those who need support. Education plays an important role in helping to ensure that young people are equipped with the information they need to make informed, healthy decisions and to keep themselves safe.

- 4.1 Members in the past have consider this to be an important area of work and with the approval of the committee this issue under the heading of 'Risky Behaviours' will be added to the work programme.
- 5.0 Members will also wish to be aware of Professor Eileen Munro's Interim Report The Childs Journey (the second report of her independent child protection review) published on the 1st February which signals a new approach on child protection and focuses on helping children rather than on the regulations, inspections and procedures which appear to have thrown the system out of balance.

5.1 The final phase of Professor Munro's review is to seek further help from each profession within the sector to develop the reforms proposed in the interim report. Following on from this will be the presentation of her final report and recommendations to Government in April.

5.2 Safeguarding and child protection issues remain a priority of the Committee and Members may wish to consider requesting a briefing following the publication of the final report in April. The purpose of the briefing will be to raise Members awareness of the recommendations and the implications for North Yorkshire County Council.

6.0 Triumvirate Meeting (Trig) with Executive Members + Corporate Director

- 6.1 Arrangements have been made for an informal meeting with Executive Members and the Corporate Director Children & Young Peoples Service following the rising of County Council.
- 6.2 The outcome of this meeting which is to consider the priorities and challenges facing the service and the value that overview and scrutiny can add to the process. A summary of this meeting will be included under this heading.
