1.0 Purpose of Report

2.0 Mid Cycle Briefing – 22nd July 2011 (Video Conferencing)

2.1 Supporting Young People into education employment and training

Officers briefed the Members on the progress against each of the recommendations outlined in the Supporting Young People into education, employment and training scrutiny review. It was reported that the current position with regard to the number of 16-18 year olds not in education, employment and training in North Yorkshire compares favourably with other parts of the Country but Officers are mindful of the present economic situation.

Members were pleased to learn that there is on-going engagement with the Federation of Small Businesses and good links have been established with the Construction Supply Chain Network – Build North Yorkshire - who has facilitated the provision of work placements (x13) and apprenticeships (x14).

Members noted the progress being achieved but also acknowledge that developments in Government Policy had changed the landscape and that the economic situation will no doubt put further pressure on the availability of jobs for young people.

They agreed to return to this issue next year.

2.2 North Yorkshire Safeguarding Board (NYSCB)

Members were provided with a briefing on the work of the North Yorkshire Safeguarding Children's Board and received a copy of the Annual Report which had been published in April 2011. The detailed report provides an assessment of the effectiveness of local arrangements to safeguard and promote the welfare of children and the importance of partnership working.

For your information your Chairman has arranged to meet with the Independent Chair of the NYSCB late September.

2.3 Green Paper - Support and Aspiration: A new approach to special educational needs and disability - North Yorkshire County Council's response to the Consultation

In March this year the Government announced a radical overhaul of how children with special needs and disabilities are treated in the English school system.

At the request of the Chairman a Senior Officer from the Children and Young Peoples Service attended to brief the Members on the key issues outlined in the Green Paper and also provide a copy of the North Yorkshire County Council Consultation Response.

Members noted the information set out in the Consultation Response document and were made aware that a further report (Project 17 of the CYPS Savings and Transformation Strategy) describing the progress in developing and implementing North Yorkshire's SEND Change and Integration Programme is due to be considered by Executive Members later this summer.

2.4 The Changing Face of School Governance - Local Authority Schools & Academies:

The Manager of the Governor Support Service attended the meeting at the request of Members to outline potential changes to school governance and the implications for governing bodies and local authority appointed governors

Members were advised that in the case where a school has begun the process to convert to Academy status they will be responsible for establishing the Academy Trust. Members of the Academy Trust have a strategic role in running the academy and will be responsible for appointing governors to the governing body of the academy.

2.5 Request from the Yorkshire Coast & Moors Area Committee

The Chairman explained that a request had been received from the Yorkshire Coast and Moors Area Committee which recommended that the outcome of a formal proposal to consult on federation by Caedmon School, Eskdale School and Whitby Community College is reported to the Young People Overview & Scrutiny Committee (YPOSC).

Officers were invited to explain the background to this formal consultation process and to provide a bit more detail around the amount of officer support given to all three governing bodies.

Members were disappointed that a unanimous conclusion had not been reached but considered this was not a matter that the Young People Overview & Scrutiny Committee could pursue. They concluded by saying that in their view it is important a way forward is developed which endorses the good partnership working that already exists between the schools and is in the best interests of children and young people of Whitby.

3.0 Next In-depth Scrutiny Review Young Peoples Participation

At a previous meeting the participation of young people was raised and the Corporate Development Officer was requested to research this area on behalf of the Committee.

The briefing paper attached at Annex B is a first draft scoping plan into the participation and involvement of young people in North Yorkshire.

Why is the participation of young people important? Well there are two main reasons – firstly it is a child or young persons right to be involved in the decisions which affect them and secondly it makes for the delivery of better, more efficient services which children and young people want and need.

Young people's participation and involvement has been taken forward in North Yorkshire with the setting up of 16 Local Youth Councils. These are made up of young people aged

13-19 and their aim is to represent the views and opinions of young people from across their local area. The North Yorkshire Youth Council (NYYC) set up at the end of 2009 brings together representatives from each of the Local Youth Councils to discuss and act on issues that matter to young people. And, currently there are three young people who represent North Yorkshire on the UK Youth Parliament (UKYP) and attended a debate in the House of Commons in October 2010 to discuss issues picked up young people.

Getting to know about the key issues that matter to young people and forming links with the North Yorkshire Youth Council are areas that your Chairman considers important for this Overview & Scrutiny Committee. Youth Councils have also now been actively running since 2009 so it is timely to consult with young people about the impact and benefits these youth councils are having and to enquire from elected members how aware and informed are they about Local Youth Councils in their areas.

Members are invited to comment, add and/or amend this draft paper and agree the membership of their next Task Group.

4.0 Next Meeting of the Committee

The next meeting of the Committee is scheduled for the 11th November 2011 at 10.30am.

There are 16 youth councils across North Yorkshire. Each youth council is made up of young people aged 13-19 and their role is to represent the views and opinions of young people from across their local area. There is also a Youth County Council made up of representatives from the area youth councils.

The youth councils meet to discuss and act on issues that matter to young people. They work to get young people's voices heard by decision makers (like the district and County Councils) and people who provide services to young people. The youth councils aim to influence the way things work for the better. It's **not** about sitting

It is about:

- having your voice heard;
- getting involved;
- influencing things for the better;
- having fun!

Working for the benefit of young people across North Yorkshire, the youth councils perform an important and often challenging role. As a youth councillor you meet and deal with all kinds of people. There are various meetings to attend, lots of planning and decisions to make, fun trips away, events to go to and speak at, radio broadcasts to do and much more!

Three examples of projects and activities that youth councils have been involved in are:

- Allocating grant money to youth projects and young people for 'things to do and places to go';
- · Being involved on interview panels for new youth workers;
- Planning and putting on youth events.



As an elected member you will get the chance to meet new people, make loads of friends, and have the opportunity to develop confidence and new skills. So if you have something to say about being a young person in your area, would like to help influence things for the better, and think adults should listen up to young people's views, now is the chance to stand up and be heard!

Other key roles:

- To be aware of and raise issues that affect young people locally, county wide and nationally;
- To work alongside adults, decision makers and providers of services (such as health, leisure, education etc.) to get young people's voices heard;
- To make contact with local youth groups/forums;
- To attend regular meetings and events;
- To be consulted by others, e.g. the County Council and people who have an interest in the needs and views of young people;
- To make things happen!

Meetings, events and activities

As part of your role you will be expected to attend and get involved in a number of events and meetings throughout the year. These meetings are an essential part of your job and although you are not expected to attend all of them, it is important you participate in at least 80%.

- 12 general youth council meetings Approximately once a month, around 2 hours long. Generally held in a building central to your area.
- 1 youth council residential This takes place over a weekend shortly after the elections. This is so everyone
 can get to know each other, have some fun, and get to grips with the role of youth councillors and role of the
 youth council.
- Regular small task group meetings In between general meetings, and to work on specific issues and
 projects set by the youth council. Not all youth council members will need to attend these, but these are where
 the real work of the youth council gets done.
- Consultation meetings/surgeries Visit local venues and youth projects to meet and consult with young people.
- Local meetings in your area Meet with young people and others in the community.

Travel and support

You will be expected to travel to meetings but transport costs can be repaid and help can be offered to organise this. Your work on the youth council will be supported by 4Youth youth workers.



Other activities

As well as these meetings there will be opportunities throughout the year to:

- Work on projects and ideas set by the youth council and its members;
- Attend events and conferences;
- Take part in team building activities;
- Meet the people that matter;
- Promote the youth council write new pieces for the website, press releases, design publicity etc.;
- Meet and consult with the young people of North Yorkshire;
- Do radio broadcasts, interviews, press releases... and much more!
