Scrutiny Review – Youth Participation

Interim Report of the Task Group

1.0 Purpose of Report

1.1 The purpose of this report is to update the Committee on the work of the Task Group to date and to ask them to note and comment on the information in this report.

2.0 Initial Meeting of the Task Group – 11th November 2011


The aim of this review is to consult with representatives of the North Yorkshire Youth Council and local Youth Councils; to learn about the impact Youth Councils are having on young people; how their key issues are developed; are Youth Councils representative of all young people aged 11-19; how could we improve the links between Youth Councils and the Young People Overview & Scrutiny Committee and raise the awareness of all elected members.

For our first meeting we were joined by two Officers from the Integrated Youth Support Service and a representative from the North Yorkshire Youth Council. They provided the Task Group with a presentation and background information on youth participation in North Yorkshire which included community engagement and a further presentation on the setting up of local Youth Councils across the County.

This helped us to understand the benefits of involving young people in the planning, delivery and evaluation of services, especially those than effect them which can promote citizenship and social inclusion. We also learned that participation is more than simply asking young people to take part in an activity. It refers specifically to the involvement in the process of identifying needs, exploring solutions, making decisions and planning action within communities and organisations that seek to support civil society.

In recent years there has been a significant move towards giving young people more opportunities to get involved and one method which has gained recognition, popularity and influence during the last few years is the Youth Council.

What we have learned so far about Youth Councils in North Yorkshire?



There are 16 youth councils across North Yorkshire. Each youth council is made up of young people aged 11-19 and their role is to represent the views and opinions of young people from across their local area; get young people's voices heard by decision makers (like the district and County Councils) and people who provide services to young people.

The North Yorkshire Youth Council (NYYC) is made up of representatives from each of the area youth councils. Its aims are to:

- o Present the views of young people to the appropriate authorities
- o Organise and run projects for and on behalf of young people
- Act as an accurate and honest consultative body in order for local institutions to research youth trends
- Involve young people in the community.

NYYC meet on the first Monday of the School Holiday at the Royal York Hotel between 10.00 - 4.00pm when they receive updates from each of the local Youth Councils, UKYP and officers.

They invite speakers to discuss relevant issues and undertaken consultations; work on campaigns; plan events; undertake training and most importantly have fun!

Current NYYC Campaigns.....



Fork Off Campaign is about 'healthy eating' with a focus on educating and encouraging young people to be independent and cater for themselves.

Fare Fairs – relates to young people under 18 having access to half price bus fares across North Yorkshire.





Get Plastered – young people learning more about first aid

In January 2011 three NYYC representatives were elected as Members of the United Kingdom Youth Parliament and they have campaigned for a young carers card that can be used within school to gain extra support and for fare fairs on public transport.

3. The Task Group's Consultation Meeting with the North Yorkshire Youth Council 21st December 2011

We had the pleasure of meeting with 18 youth representatives attending this meeting and two North Yorkshire County Council Officers.

As Chairman of the Task Group I was I asked to explain what the aims of the scrutiny review were about and why we wanted to consult with the Youth Councils.

We asked the young people present "what difference had youth councils made for them" and were advised that it had given them an opportunity to voice their opinions outside of the school environment, and share those opinions with young people with similar concerns.

It had also added to the experience gained from College mock elections and about the way a system works, but not necessarily youth politics.

They went on to explain how relationships on a local level work with MPs and Local councillors, but how the youth workers were an easier and more practical method of sharing information with NYCC.

Some described their closer links with District Councils and that they had local Councillors at every meeting, making things more efficient.

A few described the difficulties they had contacting Councillors and MP's and building relationships and had experienced general dismissal. An example they shared referred to plans to build a new supermarket – the Town Council had been contacted but the Youth Council had not. They felt that assumptions had been made that young people would want the development but in fact some had very different views. They also added the comment that as they had not voted they did not think their comments mattered.

One youth representatives said that it had given him the confidence to stand as a Town Councillor – he was elected.

It had provided the opportunity to attend a local meeting, learning how an organisation works, rather than them coming to the youth meetings.

What is their biggest concern?

Main issue at local, district and nationwide is transport. The costs of bus and train fares are too high for young people. Social lives suffer as a result leaving young people feeling isolated.

At a local level there may be different issues.

Also have the other two Campaigns – Fork Off and Get Plastered.

Fork Off Campaign – young people felt that the education side of food technology in School is more technical and scientific rather than simply teaching you how to cook. Went on to mention that Richmond Sixth Form provided life skills courses which provided education for young people about healthy eating.

What role does Social Media in play in our organisation?

They told us that Facebook has replaced texting in a lot of cases, especially where phone signal is particularly poor and that communication online is particularly efficient and so broadband is imperative. They often use Skype for meetings where there are fewer people needed to attend and for a shorter meeting.

A member of the Task Group suggested that they take a look at using DOODLE to arrange convenient times for meetings.

Are you achieving some or most of what you had hoped?

They all agreed that even just by being a part of the meetings they were being given the opportunity to be heard, and having a voice.

Would you be interested in being involved with the Young People Overview and Scrutiny Committee and perhaps this task group in particular?

Yes they would but it would depend on the times of meetings - not during the school day etc. They will need to discuss this in more detail and will hopefully get back at a later date.

A suggestion they put forward was whether the County Council might consider providing a number of candidates to be a 'named link' with the Youth Council.

Do the local youth councillors have access to information about local events/local councillors/town council meetings, area forums?

Not really - Often they find out that meetings have been held after the event in the local paper.

Their suggestion is that these events/committee meetings etc could be advertised using social media rather than the more 'old fashioned methods' that pass young people by.

Do Youth Councillors have training to be able to achieve their role?

They do have access to a variety of training days and conferences but perhaps they need to think about creating a portfolio to formalise this process.

4. Work to do

It is important that we make contact with the **Flying High Group** - young people with special needs and disabilities and the **Young Peoples Council** (children in care council) and this is underway.

The Task Group is due to meet again shortly when we will consolidate the findings to date, identify any gaps in our information under the remit of this scrutiny review and begin the process of drawing this together into a draft final report, hopefully with the help of young people from the North Yorkshire Youth Council.
