Work Programme Report

1.0 Purpose of Report

2.0 Mid Cycle Briefing – 15 June 2012

The following items were discussed at the last Mid-Cycle Briefing and are summarised below. The Chairman suggests if anyone requires a copy of any of the Briefing Reports to contact the Corporate Development Officer.

2.1 Briefing on Substance Misuse – Carly Walker

At the request of the Vice Chairman further information was sought on the current position relating to Substance Misuse and a short briefing note was circulated with the agenda papers.

The meeting was advised about the availability of drugs in the county and were also provided with an explanation on why it is used by young people. Members learned that drug misuse is addressed in conjunction with other risk taking behaviours as the Youth Support Service is careful not to raise the profile of any one particular substance. The briefing also included detail on the prevention work on-going in all schools for example how to raise the awareness of the issues and the dangers amongst young people together with guidance for schools on handling drug related incidents.

Members were advised that five schools in the coastal area are currently taking part in a risk taking behaviour project around drugs, alcohol and sex and relationship education.

The Youth Support Service deliver targeted work with young people in the coast around drugs and alcohol in youth clubs and other settings including outreach work on the streets, engaging young people in other activities; multi-agency work with the police and staff training.

From the 1st September 2012 'Compass' will be delivering the contract for substance misuse and this has been broadened to include risk taking behaviour.

The Chairman and Vice Chairman agreed that it would not be the right time to undertake a scrutiny review into drug abuse in the county. However they would welcome an opportunity to learn more about the service provider Compass (how performance is monitored and measured). This is an area they consider the Committee should return to in due course and request this matter is returned to the Work Programme.

2.2 North Yorkshire Local Safeguarding Children Board Annual Report 2012 – Susan Williams

In advance of the Mid Cycle Briefing the three spokespersons had received a full copy of the NY-LSCB Annual Report 2012.

The NY-LSCB Training Officer attended on behalf of the Chairman to provide further explanation and answer any questions in relation to the Annual Report. Members were reminded that the publication of an Annual Report is a statutory requirement for each LSCB and their comments are welcomed.

Members suggested that the Annual Report's Executive Summary was more like an expanded contents page rather than a summary of each of the sections; they also commented on the low number of agencies who completed an evaluation - 7 out of 27; and the low scoring for engaging with young people and their families. However, the Members acknowledged this is one of the Annual Reports recommendations and look forward to learning about the outcome of this development.

The Officer having listened to the Members comments advised the meeting that there will be a strengthening of the role of LSCBs following the Governments acceptance of the Munro Report. And it is anticipated the next Annual Report will incorporate and reflect Professor Munros recommendations and be more outcome focussed.

The Chairman asks the Committee to note that an interim appointment to the post of North Yorkshire Local Safeguarding Children Board Manager has been made. Dallas Frank becomes the new North Yorkshire LSCB Board Manager for a period of five months with effect from the beginning of August.

2.3 Accommodation and Homelessness – David Walker

Members were informed that the Young Peoples Accommodation Pathway for 16-25 year olds was launched on the 1 November and is now operating county-wide through hubs in Skipton, Harrogate, Northallerton, Selby, Malton and Scarborough. The hubs provide a single point of access to accommodation services for young people with a multi-agency team available to provide information, advice, assessment and mediation.

The success and prevention of homelessness has been good but is not without its challenges. In particular young people aged 16 and 17 who are returned to families or kinship may require support from specialist services outside of the Pathway if they are to not re-present in a few weeks or months as homeless when relationships might break down again.

Members commented that the Accommodation Pathways have made a good start and asked if demand for service is likely to increase further as benefit changes impact and the economic downturn continues. The officer advised the Members that there has already been a rise in the number of presentations and with the focus on prevention this has put the LA in good stead to deal with the increase. But the Pathway is already at it limits and with the continuing pressures on local authority finances it is essential for the Pathway to be able to identify the cost benefit of its services which initial assessment suggests is in the order of £3.7 million a year.

The Chairman felt it is important for the Committee to receive an update in due course and asked that this matter is put back on to the Work Programme for a progress report in 9-12 months.

2.4 Children & Young Peoples Plan (CYPP) 2011-14: Delivery Targets – David O'Brien

The Chairman had previously requested sight of the Delivery Targets which in part evidence the successful delivery of the Children and Young Peoples Plan 2011-14.

Two briefing papers were circulated the first "Thinking about Performance: Targets and other measures". This report provided the meeting with further insight into how targets, comparative data such as local trends, direction of travel and comparisons of performance to other local authorities are all considered and provide a fuller picture of North Yorkshire's own performance.

The second summarised that the Children & Young Peoples Plan (CYPP) 2011-14 includes 32 high–level success measures which demonstrate delivery of the plan. In addition, within the plan there are 249 individual actions against which progress can be monitored and evaluated. For example the positive impact of the CYPP would show: more children doing better at school, in terms of attendance, behaviour and attainment; fewer children entering and staying in social care, including fewer child protection plans and fewer looked after children; low levels of NEET young people/ higher rates of participation in education and training; lower levels of youth crime, antisocial behaviour and risky behaviours.

The Members were also advised that during September/October 2012, which is one year on from the commencement of the CYPP 2011-14 and in accordance with the performance management arrangements a 12 month progress review and evaluation will be carried out. This review and evaluation will include work to revisit and refresh the success measures, targets and baselines and will be presented to the YPOSC in due course.

The Chairman asked for the outcome of the CYPP Review and Evaluation to be added to the Work Programme.

3.0 Work Programme Schedule

The Work Programme Schedule is attached at Annex A and Members are asked to comment on the revised Work Programme and approve the content.
