## Work Programme Report

#### 1.0 <u>Purpose of Report</u>

- 1.1 This report asks the Committee to:

#### 2.0 Mid Cycle Briefing – 19 October 2012

The following items were discussed at the last Mid-Cycle Briefing and are summarised below. The Chairman suggests if anyone requires a copy of any of the Briefing Reports to contact the Corporate Development Officer.

#### 2.1 Risky Behaviours – Carly Walker

At the request of the Chairman and Vice Chairman further demographic information was sought on the current position relating to Young People engaged in Substance Misuse and this included the numbers of young people who have received specialist treatment and the length of time they have remained in treatment.

The meeting was advised that following the recent review of young peoples substance misuse service it was considered that the service should reflect the changing trends in young people's substance misuse, be broadened to include and focus on risk taking behaviour and include the provision of contraception for the young people accessing this service. The new model of service would be linked to the targeted youth support framework and thus provide earlier intervention. The aim being that fewer young people would require specialist treatment.

The new provider Compass – the Risk Taking Behaviour Service from the 1<sup>st</sup> September are providing a specialist service to help young people (11-19 and up to 25 for those with special educational needs or disabilities) who are engaged in risk taking behaviour. A representative from Compass in North Yorkshire was present at the briefing and answered Members questions on the range of services and the help available.

Members were also interested to know more about how performance and outcomes will be measured and monitored and were briefing on the 'Teen Star' outcomes tool and other approaches to be used.

The meeting felt that the Committee should return to this matter in due course and suggested that Young People Engaged in Risky Behaviours is added to the Work Programme for a Progress Report in approximately 12 months time.

#### 2.2 Domestic Abuse – Progress Briefing

Members were reminded that the Domestic Abuse Strategy for North Yorkshire and York 2009-2013 looks to tackle and reduce instances of abuse which remains a priority for partners across York and North Yorkshire. Members were also made aware that the

number of 'domestic incidents' recorded from April 2011-March 2012 was 7286 with 17% of all incidents recording children and young people present.

Since the Committee's Scrutiny Review in 2009/10 on Young People Affected by Domestic Abuse Members were advised by the progress report and briefing that services for young people affected by domestic abuse have moved forward since their final report for example therapeutic services in Scarborough, an Outreach Service and a comprehensive Training Programme. Also the Children and Young Peoples Plan is committed to reducing the impact of domestic abuse on children and young people by providing timely early intervention and sustainable education packages and training in all school settings.

An update was also provided on the work of the North Yorkshire & York Domestic Abuse Joint Coordinating Group which having completed an overview of current services for victims, perpetrators and children and young people affected by domestic abuse have developed a Domestic Abuse Joint Commissioning Strategy. This strategy sets out the framework by which North Yorkshire County Council, City of York and Partners will match the needs and aspirations of local communities, the agreed priorities and desired outcomes with the resources available to them. There are five outcomes to be delivered by this strategy and four priorities for change. Of particular note is the priority - 'Improve service pathways for children and young people affected by domestic abuse through enhancing existing provision.' Members remarked they would be interested to receive a progress report which covered this particular priority in due course.

#### 2.3 The Pupil Referral Service – Visit to Pupil Referral Unit in Northallerton

The Pupil Referral Service in North Yorkshire deals with all those pupils who, for some reason, are not attending mainstream educational settings.

Councillor Backhouse thanked Cllr Tony Hall for providing the opportunity for him and Cllr Caroline Seymour to visit the Northallerton Unit. He said that it was interesting to see how the Unit is managed and interacts with young people and their families. During their visit there were around 7 young people in attendance and Cllr Backhouse felt their visit provided an overview into the benefits of Pupil Referral Services for young people who are excluded from school, have significant health problems, are very introverted and lack self esteem.

#### 2.4 Next Scrutiny Review

Members will recall the previous Scrutiny Review into Health Visiting and School Nursing Services which left open an opportunity to follow up on the Department of Health's Review of the role of the school nurse and the subsequent publication in February of **Getting it** *right for children, young people and families-Maximising the contribution of the school nursing team: Vision and call to action.* (This document was circulated with the agenda papers for the previous meeting.) Members will have read that the government recognises the importance of school nursing role in public health in the school community.

It is proposed that it would be timely to re-convene a time limited Task and Finish Group that would consult on this document with the PCT Commissioners and Harrogate and District Foundation Trust to look into what this means for the Health Visiting and School Nursing Service in North Yorkshire.

The Chairman agreed to put this suggestion to the full Committee in November for their comment and approval.

#### 3.0 Work Programme Schedule

The Work Programme Schedule is attached at Annex A and Members are asked to comment on the revised Work Programme and approve the content.
