This was a benchmarking exercise to look at the overall make up of children currently accessing the CRC's and to consider how many children could be placed in foster care if it were available (with adaptations to properties where necessary). Moving forward if foster care was being proposed for a child – each child would be looked at individually.

- A. Yes. We considered this as part of our proposals.

We are investing in our inhouse fostering service which is well established and well regarded. There will be a targeted recruitment campaign to attract new foster carers.

Q: We already have Woodlands Hostel, but funding is reduced? Why not expand the services? Why not use Wellburn Hall School to offer short breaks?

A: There has been considerable previous discussion regarding the use of Woodlands Hostel and the funding of the Hostel. The Hostel can't be funded via the social care budget. Regarding Wellburn Hall School this currently doesn't provide short break services but we have noted the suggestion

A: We do a "random" receipts audit.



A: NYCC's Direct Payment Support Service can provide support. There are also managed direct payments available for families who need more support eg support with payroll and recruitment. There are agencies who can support families in this way and we can provide information as to who they are.

A: Families sign a "Direct Payment Agreement" which is a legal document which specifies what it is for. They have to send in returns to the council so it can be monitored.

A: Comment noted. There have been some barriers to disabled young people remaining in foster placement after 18 years, and some foster carers have been required to re-register as adult carers. It is hoped that disabled young people in foster care will be able to remain with their carers until the end of their education – post 18 years. This is being looked at.

- One attendee indicated that they had had a bad experience with a Direct Payment and had got behind with their paperwork leading to a repayment having to be made

- It is important to dispel the myths. People think they have to be self employed to be a DP support worker. They are properly employed. Parents can combine forces and share the employment of a worker to make up their hours to a living wage.

A discussion took place regarding the support that can be offered to parents carers in the management of direct payments either through the Authority's Direct Payment Support Service or through agencies like NYSIL.

One parent gave an example of using her Direct Payment to pay "companions" for her son with Autism, and asked him to comment. The young person said he liked having a "companion" male carer of younger age rather than someone older and more obviously a "carer"
