### Item of Other Business – Nomination of District Councils' Substitute on the European Structural and Investment Funds Sub-Committee

#### Report of the Honorary Secretary

#### **1.0 Purpose of the Report**

- 1.1 To invite the nomination of the District Councils' Substitute on the ESIF Sub-Committee, to fill a vacancy arising on the death of Councillor John Clark.

#### **2.0 Background**

- 2.1 LGNYY, at its Annual Meeting on 2 July 2021, made nominations to the European Structural and Investment Funds (ESIF) Sub-Committee. The nominations included Councillor John Clark as the District Councils' Substitute, to attend meetings of that Sub-Committee in the absence of Councillor Stephen Arnold (Ryedale District Council).

#### **3.0 Vacancy**

- 3.1 Members will be aware that Councillor John Clark sadly died in August 2021.
- 3.2 The District Councils are invited, at today's meeting, to make a new nomination of Substitute on the ESIF Sub-Committee, to serve until LGNYY's Annual Meeting on 1 July 2022.
- 3.3 Traditionally the District Councils' Member and Substitute on this Sub-Committee have been from the same Council.
- 3.4 Councillor Di Keal (Ryedale District Council) is happy to be nominated for the vacant position of Substitute. However, she is fine if another District Councillor would like to take the position.
- 3.5 Councillor Di Keal is unable to attend today's meeting of LGNYY. It is not clear, at the time of writing this report, whether an Elected Member from Ryedale District Council will be attending today's meeting.

#### **4.0 Recommendation**

- 4.1 That LGNYY agree the nomination of the District Councils' Substitute on the ESIF Sub-Committee to serve for the remainder of the year ie until LGNYY's Annual Meeting on 1 July 2022.
