# Department for Education Grant - Wraparound Childcare Programme Costs 2023-24, 2024-25 and 2025-26

### Report of the Corporate Director - Children and Young People's Service

### 1.0 PURPOSE OF REPORT

1.1 This report provides details of the grant funding for Wraparound Childcare Programme Costs 2023-24, 2024-25 and 2025-26 that was announced by the Department for Education (DfE) on the 27 October 2023. The Executive are requested to provide approval for the acceptance of the grant by the local authority.

### 2.0 BACKGROUND

2.1 In March 2023, in the Spring Budget, the Government announced £289 million in funding for the financial years 2023-24 to 2025-26, for a national wraparound childcare programme to ensure that all parents of primary school children who need it, are able to access wraparound childcare in their local area from 8am-6pm. The DfE expect that parents should see an expansion in the availability of wraparound care from September 2024.

### 3.0 WRAPAROUND CHILDCARE PROGRAMME COSTS GRANT

3.1 The DfE have confirmed that grant funding will be paid to North Yorkshire Council for the purposes of supporting the local authority to increase the supply of wraparound childcare places, to ensure or guarantee provision for all parents who may need it, meeting current demand and building further demand. Local authorities are expected to use the grant to work with and fund primary schools and private, voluntary and independent (PVI) providers, including childminders, to introduce or expand before- and after-school childcare provision in their area where there is a gap in availability. As part of this programme the government wants local authorities, schools and providers to test flexible approaches and gather evidence of what works. The grant funding allocations for North Yorkshire are as follows:

Financial Year	Wraparound Childcare Programme Costs Grant
2023/24	£38,507
2024/25	£2,935,184
2025/26 (Provisional Allocation)	£1,354,724
Total Grant Allocation (Provisional)	£4,328,415

3.2 The grant funding for each financial year will be made available in the form of a nonringfenced grant, contingent on the terms set out in the Memorandum of Understanding (MoU) for the programme and with reference to the programme handbook which includes the grant payment schedule. The terms in the MoU include:

- i. the Recipient must agree to the terms of the MoU before receipt of the first payment
- ii. the Recipient must submit, of sufficient quality for DfE approval, a costed capacity delivery plan before receipt of the second payment, a costed programme delivery plan before receipt of the third payment, and a delivery plan update for DfE approval before each subsequent payment
- iii. the Recipient must complete all required programme reporting and evaluation activity
- iv. the Recipient must complete a Statement of Grant Usage at the end of each financial year, by the required deadlines
- v. the Recipient must have and make available as required, a transparent process for allocating funding to suppliers and/or childcare providers
- vi. the Recipient must ensure they have sufficient capacity to deliver the programme requirements, using a reasonable proportion of the grant to cover the costs incurred
- vii. the Recipient must ensure that where funding is dispersed to private, voluntary or independent childcare providers, including childminders, all such childcare providers are registered with Ofsted to provide school-age childcare before childcare provision commences
- viii. the Recipient must have in place a process to monitor and mitigate the risk of childcare providers receiving double funding for the same activities.

## 4.0 WRAPAROUND CHILDCARE PROGRAMME OVERVIEW – ROLE OF THE LOCAL AUTHORITY

- 4.1 Local authorities are responsible, under the Childcare Act 2006 childcare sufficiency duty, for delivering on the primary objective of the wraparound programme in their local area. That is, to increase parent/carer access to the labour market by increasing the number of wraparound childcare places for primary-aged children available and taken up between 8am and 6pm (or equivalent, depending on local labour market patterns). The DfE consider that local authorities should use the funding available to them to create additional places and ensure existing places are available for the hours that are required, to:
  - meet current demand both in terms of number of places and hours available
  - ensure supply to build further demand; and
  - where required, as traditional models of wraparound may not support sustainable provision, test new approaches to identify what works in their local area and identify the level of risk.

The DfE expect local authorities to work collaboratively and in partnership with wraparound providers to deliver the programme.

- 4.2 In order for parents to the be able to access the provision from September 2024, or sooner, the DfE require local authorities to undertake the following key steps to deliver the programme:
  - 1. Ensure strong local leadership through a robust governance structure
  - 2. Allocate a designated wraparound lead and ensure appropriate resourcing
  - 3. Plan for delivery undertake supply and demand mapping, and identify delivery models for wrapround provision
  - 4. Complete and submit costed delivery plans local authority capacity and programme delivery plans
  - 5. Allocate funding to providers
  - 6. Work with providers to set up provision
  - 7. Promote the National Wraparound Childcare programme to providers and parents

4.3 Subject to approval for the acceptance of the Wraparound Childcare Programme Costs Grant, over the forthcoming period the local authority will be developing a delivery plan and implementing the identified actions.

### 5.0 ALTERNATIVE OPTIONS CONSIDERED

5.1 No alternative actions have been considered. The grant funding is an essential requirement in supporting the local authority to deliver its responsibilities associated with the DfE wraparound childcare programme.

### 6.0 IMPACT ON OTHER SERVICES/ORGANISATIONS

6.1 The receipt of the grant funding will enable the local authority to support childcare providers in the setting up and expanding of childcare provision and testing new models of operation.

### 7.0 FINANCIAL IMPLICATIONS

7.1 The costs and expenditure associated with the Wraparound Childcare Programme will be contained within the grant funding allocation. There is no direct impact on the Council's budget.

### 8.0 LEGAL IMPLICATIONS

8.1 No specific legal implications are identified as a result of the recommendations contained within this report.

#### 9.0 EQUALITIES IMPLICATIONS

9.1 An Equalities Impact Assessment process has been undertaken in relation to the grant acceptance decision. No specific equalities implications have been identified with the proposed acceptance.

#### **10.0 CLIMATE CHANGE IMPLICATIONS**

10.1 Climate Change Impact Assessments (CCIA) have been completed in respect of the grant acceptance decision. No specific climate change implications identified with the proposed acceptance of the grant.

#### 11.0 REASONS FOR RECOMMENDATIONS

- 11.1 The report recommendations are made:
  - To comply with grant acceptance requirements of the North Yorkshire Council Financial Procedure Rules
  - To support the local authority to deliver its responsibilities associated with the DfE wraparound childcare programme.

### 12.0 RECOMMENDATION(S)

The Executive is asked to:

- i. Note the DfE Wraparound Childcare Programme and the required role of the local authority in the delivery of the programme.
- ii. Provide approval for the acceptance of the Wraparound Childcare Programme Costs Grant which covers the financial years 2023/24 to 2024/25, with the provisional total grant funding allocation for the three years being £4.33m
