### **Amended plans**

Please note that the red line for the proposed development has been amended since the publication of the agenda. The red line has been amended to exclude the outbuildings (labelled store 1, store 2 and store 3) to the west of the site and land to the south of plot 3.

There is a typo at paragraph 3.2 of the report in the agenda. The date should read "15/11/2023" not "15/11/2024".

At paragraph 10.36, the report refers to "The Ouse and Derwent Drainage Board". However, Ainsty Drainage Board covers this area and were the IDB that were consulted. The paragraph should read:

10.36. Yorkshire Water and the Ainsty Internal Drainage Board and have been consulted on the proposals. Yorkshire Water made no comments to the proposal. The Ainsty Internal Drainage Board raised no objections to the proposals subject to a condition requiring a detailed scheme of drainage to be agreed.
