## Access to Information Procedure Rule 16 – Special Urgency

## Waltonwrays - General Maintenance Works - Award of Contract

# To the Chairman of the Transport, Economy, Environment and Enterprise Overview and Scrutiny Committee

The Council's Constitution provides that if a matter which is likely to be a key decision has not been included on the Council's Forward Plan for the requisite period, the decision may still be taken if an urgency procedure is followed.

Under Access to Information Procedure Rule 16:

- 16.1 Where the date by which a decision must be made makes compliance with Rule 15 (general exception) impracticable, then the decision can only be made if the decision maker (if an individual) or the Chairman of the body making the decision, obtains the written agreement of the Chairman of a relevant overview and scrutiny committee that the making of the decision is urgent and cannot reasonably be deferred. If there is no Chairman of a relevant overview and scrutiny committee, or if the Chairman of the relevant overview and scrutiny committee is unable to act, then the agreement of the Chairman of the Council, or in his/her absence the Vice-Chairman will suffice.
- 16.2 As soon as reasonably practicable after the decision maker has obtained agreement under Rule 16.1 above, s/he must make available at the Council's offices a notice setting out the reasons why the meeting is urgent and cannot reasonably be deferred and publish the notice on the Council's website.

It is anticipated that on 15 July 2024, the Assistant Director - Highways and Transportation, Parking Services, Parks & Grounds will consider a report seeking approval for award of contract for Waltonwrays - general maintenance works of £532,951 to PBS Construction Limited.

The intention to make the key decision is published on the Forward Plan however it has not been published on the Plan for the requisite 28 day period.

This matter requires a decision by the Assistant Director - Highways and Transportation, Parking Services, Parks & Grounds on 15 Jul 2024 and cannot reasonably be deferred, to enable the timely consideration and progress of this matter due to being impacted by environmental conditions and for co-operation with utility works, the contract needs to commence and complete within a very tight timescale and to avoid greater disruption.

In accordance with the provisions in the Access to Information Procedure Rules, I am, therefore, informing you as the Chairman of the relevant Overview and Scrutiny Committee that it is intended that this matter be considered by the Assistant Director - Highways and Transportation, Parking Services, Parks & Grounds on 15 July 2024 and I am seeking your agreement that the meeting and the making of the decision is urgent and cannot reasonably be deferred beyond this timeframe. If you agree that the meeting and the making of the decision is urgent and cannot reasonably be deferred and that this item should be considered on 15 July 2024, will you please so confirm in writing as soon as possible.
