Public Rights of Way Seasonal Vegetation Management 2024 Framework Procurement

Report of the Head of Countryside Access Services

1.0 PURPOSE OF REPORT

1.1 To undertake a procurement exercise to renew the framework for seasonal vegetation management on public rights of way starting April 2025 and finishing March 2027 with an option to extend for an additional two years to March 2029.

2.0 BACKGROUND

- 2.1 North Yorkshire Council requires a provider (or number of providers) to cut seasonal vegetation to maintain the public rights of way (PROW) across North Yorkshire. All specified routes are to be cut a minimum of once per annum with an additional second cut, if required. The framework will also include provision for spraying of obnoxious weeds.
- 2.2 The new framework agreement will commence from 1 April 2025.

3.0 CONTRIBUTION TO COUNCIL PRIORITIES

3.1 The Protection and maintenance of PROWs, including the cutting back of seasonal vegetation, supports the Councils' priorities to maximise the potential of natural assets and environment within North Yorkshire to improve physical and mental health as well as promoting and encouraging active travel.

4.0 ALTERNATIVE OPTIONS CONSIDERED

4.1 The service does not have capacity to undertake this work in house and therefore we need to seek external providers who can undertake this work on our behalf.

5.0 FINANCIAL IMPLICATIONS

5.1 The anticipated value of the framework is up to £300k over the life of contract. The framework will have no guarantee of spend each year and any spend will be funded through the Countryside Access Service revenue maintenance budget.

6.0 LEGAL & GOVERNANCE COMPLIANCE

6.1 The procurement exercise will be undertaken by the Council's Procurement and Contract Management Service, with a Gateway report will be considered in accordance with the Council's Procurement and Contract Procedure Rules.

7.0 EQUALITIES IMPLICATIONS

7.1 Seasonal Vegetation cutting of Public Rights of Way helps to maintain the surface of the routes as well as define routes which improves the accessibility to users. Please see EIA screening assessment in Appendix A. A full equalities impact assessment is not deemed to be necessary.

8.0 CLIMATE CHANGE IMPLICATIONS

8.1 The route cutting takes place on existing Public Rights of Way within the county and surrounding vegetation will be left untouched. Please see Climate Change screening assessment in Appendix B. A full climate change impact assessment is not deemed to be necessary.

9.0 REASONS FOR RECOMMENDATIONS

- 9.1 Authorisation to undertake a procurement exercise to renew the PROW seasonal vegetation framework is recommended because:
 - the existing framework is due to expire on 31 March 2025
 - the framework contributes towards NYC's statutory duty to protect and maintain the Public Rights of Way network.

10.0 RECOMMENDATION(S)

10.1 The Corporate Director – Environment is recommended to approve the establishment of a framework for the provision of the Seasonal Vegetation Cutting Programme for Public Rights of Way.
