Report of the Corporate director – Business and Environmental Services

1.0 Purpose of report

- 1.1 To explain the role of the North Yorkshire Consolidated Planning Policy Framework presented at Appendix 1 and the Schedule of Planning Policy Evidence Base Documents for North Yorkshire presented to Appendix 2.
- 1.2 To seek the approval of the Executive Member for the North Yorkshire Consolidated Planning Policy Framework document presented at Appendix 1 and the Schedule of Planning Policy Evidence Base Documents for North Yorkshire presented at Appendix 2 and for publication on the North Yorkshire Council's website as soon as is practicable.

2.0 Background

- 2.1 In preparing for Local Government Reorganisation (LGR) and the date of investiture for the new North Yorkshire Council, the Plans, Policies and Processes Sub Workstream agreed that it would be helpful to prepare the following two documents:
 - 1. A North Yorkshire Consolidated Planning Policy Framework (The Framework) (Appendix 1) which clearly sets out the statutory and non-statutory planning policy documents that have been prepared and adopted by the eight existing local planning authorities across North Yorkshire (referred to as predecessor councils in The Framework).
 - 2. A Schedule of Planning Policy Evidence Base Documents for North Yorkshire (The Schedule) (Appendix 2) which lists both core and local evidence base documents produced by all eight predecessor councils that have informed Development Plan Documents adopted by each council.
- 2.2 It is important that all users of the planning system, including officers, Members, local communities, applicants, developers, partners, and stakeholders have clarity about the set of planning documents and evidence base documents that will continue to guide development in their area following the date of investiture. Both the Framework and Schedule has been compiled with input from officers representing all current local authorities in North Yorkshire.
- 2.3 In addition to this input from individual officers, drafts of the Framework and Schedule were circulated to the Planning LGR Plans, Policies and Processes Sub Workstream in October 2022 and December 2022 for comment.

3.0 Outline of the issue

- 3.1 The Development Plan is at the heart of the planning system with the current legal requirement being that planning decisions must be taken in line with the development plan unless material considerations indicate otherwise. Therefore, decisions on planning applications and other development proposals must be considered against the Statutory Development Plan, together with other material considerations such as national planning guidance. Regard may also be had to other planning policy documents which may be material considerations, and which do not form part of the Statutory Development Plan, such as Supplementary Planning Documents and Development Briefs.
- 3.2 The Local Government (Structural Changes) (Transitional Arrangements) (No.2) Regulations 2008 (as amended) requires that a single tier council adopts a local development document (a Local Plan) under section 23 of the 2004 Planning & Compulsory Purchase Act to apply to the whole of its area within a period of five years starting with the date of re-organisation. Once adopted, the new North Yorkshire Council Local Plan will replace the existing district-wide local plans adopted by the predecessor councils and will form part of the development plan for those parts of North Yorkshire that are outside of the two national park authorities. However, on the date of investiture the Development Plan for North Yorkshire Council will comprise seven separate local plans alongside the Minerals and Waste Joint Plan, and any 'made' Neighbourhood Plans.
- 3.3 Therefore, up until the new North Yorkshire Council Local Plan is adopted, it is important to provide clarity to all users of the planning system by setting out which planning documents will continue to guide development in specific geographical areas of North Yorkshire together with a list of the evidence base documents that have informed these planning documents. The documents presented at Appendices 1 and 2 aim to provide this clarity.

North Yorkshire Consolidated Planning Policy Framework (Appendix 1)

- 3.4 The Framework includes schedules of policy documents, including date of approval by the preparing authorities and an indication of their relevance by both geographical coverage and spatial theme coverage. It is hoped that the Framework will act as an easy to use 'go to guide' for users to identify which statutory and non-statutory planning policy documents apply to a particular proposal development.
- 3.5 Section 2 of the Framework explains that it is made up of the following two sections:
 - Section A: documents that form the Statutory Development Plan, and
 - Section B: documents that do not from part of the Statutory Development Plan.
- 3.6 Sections A & B are then made up of the following parts:

 Part 1: Schedule of adopted statutory Development Plan Documents comprising: adopted Local Development Framework documents (including Core Strategies, site allocations documents, development policies and area action plans), adopted Local Plans (including minerals and waste), and any development plan policies 'saved' either through regulation or Direction by the Secretary of State. 	

Part 2:	Schedule of 'made' or adopted Neighbourhood Plans which form part of the Statutory Development Plan for North Yorkshire.
Section B	: documents that do not from part of the Statutory Development Plan
(non-state	utory documents)
Part 1:	Schedule of Supplementary Planning Documents (SPDs) and Statement of

Schedule of Planning Policy Evidence Base Documents for North Yorkshire (Appendix 2)

- 3.7 The Schedule lists evidence base documents produced by all eight councils that have informed adopted Development Plan Documents and is split into the following two parts:
 - Part 1 relates to core evidence; evidence which is common to all Development Plan Documents including local plans prepared and adopted across North Yorkshire e.g., Strategic Housing and Employment Land Availability Assessment, Strategic Housing Market Assessment, Strategic Flood Risk Assessments, Employment Land Review, Viability Assessment, Infrastructure Delivery Plan etc.
 - Part 2 relates to local/other evidence, which has been prepared to inform Development Plan Documents, including adopted development plan policies that are specific to a particular area or theme e.g., relating to housing mix and density, allocated site selection process, green infrastructure & biodiversity, Local Green Space, AONBs, water resources, gypsy & travellers, tourism etc.
- 3.8 It is important to note that both The Framework and The Schedule are living documents that will be updated when new planning policy documents, including a new Local Plan for the whole of the North Yorkshire area (excluding the designated National Parks), are adopted by North Yorkshire Council and as a new evidence base is prepared to shape this new local plan. The importance of updating The Framework and The Schedule is explained within each document. The ability to update them in this way will ensure that they represent an up-to-date picture of the statutory and non-statutory planning policy documents, and evidence base documents relevant to development proposals in a particular geographical area.

4.0 Conclusion

4.1 In order to provide clarity to users of the planning service provided by North Yorkshire Council from the date of investiture this report seeks approval for both the North Yorkshire Consolidated Planning Policy Framework presented at Appendix 1 and the Schedule of Planning Policy Evidence Base Documents for North Yorkshire presented at Appendix 2 to be made available on the North Yorkshire Council's website as soon as practicable.

5.0 Financial Implications

5.1 This report does not have any financial implications in implementation of the policies. Future delivery against the policies will be within existing planning budgets and does not require any additional resources.

6.0 Legal Implications

6.1 The Local Government (Structural Changes) (Transitional Arrangements) (No.2) Regulations 2008 (as amended) sets out at Regulation 19 that local development documents adopted by predecessor councils shall have effect after vesting as if they had been adopted by the new North Yorkshire Council for such parts of the area to which they relate. Although there is no legal requirement to provide the Framework and the Schedule their preparation should provide assistance to those involved with and using planning services as there is significant number of such documents across the authorities.

7.0 Climate Change Implications

7.1 Many of the planning policy documents listed in The Framework and The Schedule contribute to delivering the council's climate change ambitions. There are no known impacts resulting from the recommendations set out at Section 11 of the report. A Climate Change Impact Assessment is set out at Appendix 3.

8.0 Equalities Implications

8.1 Publication of the North Yorkshire Consolidated Planning Policy Framework and the Schedule of Planning Policy Evidence Base Documents, would provide clarity to all users, including those people with protected characteristics, on the planning policy documents that will continue to guide development in specific geographical areas of North Yorkshire prior to adoption of a new North Yorkshire Council Local Plan. There are no known adverse impacts on people with protected characteristics resulting from the recommendations set out at Section 11 of the report. An EIA to accompany this report is set out at Appendix 4.

9.0 Reasons for recommendations

9.1 It is considered appropriate to prepare a North Yorkshire Consolidated Planning Policy Framework and a Schedule of Planning Policy Evidence Base Documents for North Yorkshire to provide clarity to all users of the planning system by setting out which statutory and non-statutory planning documents will continue to guide development in specific geographical areas of North Yorkshire together with a list of the evidence base documents that have informed these planning documents, prior to adoption of a new North Yorkshire Council Local Plan.

10.0 Recommendations

- 10.1 That the North Yorkshire Consolidated Planning Policy Framework document presented at Appendix 1 to this report is approved and that it be published on the North Yorkshire Council's website as soon as practicable.
- 10.2 That the Schedule of Planning Policy Evidence Base Documents for North Yorkshire presented to Appendix 2 to this report is approved, and that it be published on the North Yorkshire Council's website as soon as is practicable.

10.3 That delegated authority is granted to Trevor Watson, Director for Economy, Environment and Housing Harrogate BC (Assistant Director for Planning at North Yorkshire Council from 1st April 2023) to make any necessary minor amends and update each document as and when necessary, before publishing to the North Yorkshire Council's website.

1. Introduction

- 1.1 In July 2021 the Government announced that North Yorkshire would be one of the areas within England where its local government structure would be changed, replacing the current two-tier system with a unitary council. On 1 April 2023, the unitary North Yorkshire Council will become the local planning authority for the area previously covered by the eight local planning authorities of Craven, Harrogate, Hambleton, North Yorkshire, Richmondshire, Ryedale, Scarborough and Selby. The City of York, the Yorkshire Dales National Park Authority and the North York Moors National Park Authority are not part of Local Government Reorganisation and remain local planning authorities for those areas.
- 1.2 In the past, each of these local planning authorities produced its own set of planning documents to guide development in their area. As the eight local authorities have come together, there is the need to establish the relevant planning policy documents for the new Council and the geographical area which these relate to. These documents form the Consolidated Planning Policy Framework for North Yorkshire, which relate to both statutory and non-statutory planning documents. The aim of this Framework is to provide clarity for applicants, potential developers, Councillors, and officers on which statutory and non-statutory planning documents planning documents planning applications will be considered against once the new unitary North Yorkshire Council is formed on the 1 April 2023.
- 1.3 This Consolidated Planning Policy Framework for North Yorkshire is accessible to prospective applicants, developers, and other interested parties via HERE [include NYC Website link]

2. The Development Plan Context

2.1 The Development Plan is at the heart of the planning system with a requirement set in law that planning decisions must be taken in line with the development plan unless material considerations indicate otherwise. Development Plans set out a vision and a framework for the future development of the area, addressing needs and opportunities in relation to housing, the economy, community facilities and infrastructure – as well as a basis for conserving and enhancing the natural and historic environment, mitigating and adapting to climate change, and achieving well designed places.

- 2.2 Local Development Documents are the collective term for development plan documents (DPDs), supplementary planning documents (SPDs) and statements of community involvement (SCIs). Development Plan Documents¹ are planning policy documents which make up the statutory Development Plan for an area and can include:
 - adopted Local Development Framework documents, including Core Strategies, site allocations documents, development policies and area action plans;
 - adopted Local Plans (including minerals and waste);
 - any development plan policies 'saved' either through regulation or Direction by the Secretary of State; and
 - made Neighbourhood Plans.
- 2.3 Through the Localism Act 2011, the Government introduced a new tier of plans called 'Neighbourhood Plans'. These are prepared by Town and Parish Councils or by specifically designated neighbourhood forums in areas without a Parish. However, there is no statutory requirement to prepare Neighbourhood Plans. The scope of Neighbourhood Plans is determined by the Town and Parish Council/neighbourhood forum in consultation with their communities. Neighbourhood Plans must take account of national planning policy and be in general conformity with the Local Plan. Once made or adopted, Neighbourhood Plans form part of the Statutory Development Plan for the area.
- 2.4 The Planning and Compulsory Purchase Act 2004 sets out that each local planning authority must identify their strategic priorities and have policies to address these in their development plan documents.
- 2.5 Decisions on planning applications and other development proposals must be considered against the Statutory Development Plan, together with national planning guidance. Other specific planning policy documents which do not form part of the Statutory Development Plan, such as Supplementary Planning Documents and Development Briefs, may also be given due consideration in assessing development proposals.

3. Consolidated Planning Policy Framework for North Yorkshire

- 3.1 The Consolidated Planning Policy Framework for North Yorkshire comprises two sections:
 - Section A Schedule of Planning Policy Documents which form the Statutory Development Plan
 - Section B Schedule of Planning Policy Documents which do not form part of the Statutory Development Plan

The Consolidated Planning Policy Framework for North Yorkshire was approved by the Executive Member For Planning For Growth on 13th March 2023. The Consolidated Planning Policy Framework for North Yorkshire is a living document and will be updated when new planning policy documents are adopted by the new North Yorkshire Council.

¹ As defined by Regulation 5(I)(a)(i), (ii) or (iv) or 5(2)(a) or(b) of the Town and Country Planning (Local Planning) (England) Regulations 2012 and updated versions of these Regulations.

Section A: Schedule of Planning Policy Documents which form the Statutory Development Plan

- 3.2 Section A comprises of two parts:
- 3.3 <u>Part 1</u> a schedule of adopted statutory Development Plan Documents comprising adopted Local Development Framework documents, adopted Local Plans and any development plan policies 'saved' either through regulation or Direction by the Secretary of State.
- 3.5 <u>Part 2</u> a schedule of made Neighbourhood Plans comprising the Neighbourhood Plans which form part of the Statutory Development Plan for North Yorkshire.

Section B: Schedule of Planning Policy Documents which do not form part of the Development Plan

- 3.7 Section B comprises of three parts:
- 3.8 Part 1 Adopted Local Development Documents which are not part of the Statutory Development Plan, including Supplementary Planning Documents (SPDs) and Statement of Community Involvements (SCIs). As a result of the Local Government (Structural Changes) (Transitional Arrangements) (No 2) Regulations 2008 and Local Government (Structural Changes) (Further Transitional and Supplementary Provision and Miscellaneous Amendments) Regulations 2009, the previous Statements of Community Involvement prepared by the district and county councils are no longer applicable and North Yorkshire Council will prepare a new Statement of Community Involvement for the area.
- 3.9 <u>Part 2</u> Non-statutory planning policy documents prepared by predecessor councils to provide guidance and advice to developers and the local planning authority in considering and determining planning applications. Whilst these documents may have been prepared by predecessor councils, they were approved by the North Yorkshire County Council's Executive Member For Planning For Growth on the 13th March 2023 for the purposes of bringing together all the relevant planning policies for the NYC.
- 3.10 <u>Part 3</u> Non-statutory documents prepared by other organisations and bodies which assist the delivery of development and were approved by the North Yorkshire County Council's Executive Member For Planning For Growth on the 13th March 2023.
- 3.11 Where policy documents were originally adopted some time ago, it is likely that material considerations, in particular the emergence of new national and local policy, will have greater weight when planning applications are determined. In addition, there may also be new evidence which will also have greater weight when planning applications are determined.

3.15 Details of the relevant planning policy documents, both statutory and non-statutory which constitute the Consolidated Planning Policy Framework for North Yorkshire, are set out in Section A and Section B of this document. The schedules include a bibliography of the policy documents, including date of approval by the preparing authorities and an indication of their relevance by geographical coverage and spatial theme coverage. - 4.1 The Consolidated Planning Policy Framework for North Yorkshire is a living document and will be updated when new planning policy documents are adopted by North Yorkshire Council.
- 4.2 Whilst all efforts have been made to ensure the information within the attached schedules is correct, it is not intended to amount to advice or authority on which reliance should be placed. The information is provided as a general guide and it will be necessary for prospective applicants, developers, and other interested parties to review documents in order to identify relevant policies and guidance in relation to proposed development. Prospective applicants, developers and other interested parties are advised to contact the relevant council officers to discuss development proposals where necessary.
- 4.3 It should be noted that a Schedule of Planning Policy Evidence Base Documents For North Yorkshire has also been prepared. It lists both core and local evidence base documents produced by all eight predecessor councils that have informed Development Plan Documents adopted by each council. Information included in this schedule may be relevant to prospective applicants, developers and other interested parties and can be viewed here [include weblink]

Spatial Theme Definitions Each document listed in the schedules below have been categorised into the following spatial themes.

	edules below have been categorised into the following spatial themes.
General development principles	may include development / locational strategy, the location and scale of new development, settlement hierarchy, sequential approach to development, settlement boundaries, green belt designation, development in the open countryside, general design principles and sustainability criteria such as flood risk, erosion, land instability, pollution and contaminated land. These general overarching policies will often apply to all forms of development and can cut across all the other spatial themes.
Housing	may include overall housing land supply provision, housing land allocations, housing mix & density, previously developed land, provision of affordable housing, provision for gypsies and travellers, provision of specialist housing e.g., or older people, residential development in town, district & local centres, conversions, existing housing stock, extension and alterations to existing housing.
Economic development and tourism	may include overall employment land supply provision, employment land allocations, cultural and tourism development, visitor accommodation including camping and caravanning, tourist attractions, the rural economy and farm diversification.
Retail and Town Centres	may include distribution of growth in retail floorspace and other town centre uses, vitality and viability of towns and villages centres, retail hierarchy, primary and secondary shopping areas, edge-of-centre and out-of- centre retail or related development, town centre development opportunities, underused floorspace in retail areas, open air retailing and farm shops.
Built environment	may include historic and built environment, conservation areas, listed buildings, archaeology, other heritage assets (scheduled monuments, parks and gardens, battlefield sites etc), public realm and public art.
Natural environment	may include countryside & landscape relating to sites of international and national importance for nature conservation, sites of local or regional nature conservation significance, protection of species, biodiversity and geodiversity sites, wildlife networks, green infrastructure networks, green wedges, Local Green Space designations, landscape character, areas of high landscape value, best and most versatile agricultural.
Design	May include design guides and design codes, general layout and design principles, sustainable design and construction, ensuring development is accessible, designing out crime, shop fronts and advertisements etc.
Recreation and open space	may include parks and gardens, provision of new open space, sport and recreational facilities, children's play, strategic open spaces, golf courses, countryside activities, recreational footpaths, cycleways, bridleways and waterways.
Transportation	may include road network, road schemes and major road improvements, minor road improvements, traffic management, rail services, and freight, provision for buses, cyclists and walking, traffic implications of new development, parking standards and highway directional signage.
Community facilities and infrastructure	may include community centres, meeting halls, educational establishments, public houses, religious buildings and libraries, healthcare facilities, utilities infrastructure such as electricity, sewerage, gas and water supplies, telecommunications development and planning conditions and obligations.

climate change, flooding and coastal change	may include flood risk, drainage and sustainable drainage systems, water resources & supply, water quality and ground water, land and air quality, renewable and low carbon energy, reducing greenhouse gas emissions, coastal changes, risk of overheating from rising temperatures,
Minerals	may include strategy for minerals development, environmental protection, coal, aggregate minerals, sandstone, peat, clay, oil and gas, site management and operations, reclamation and reworking of mineral wastes
Waste	may include strategy for waste, type and volume of waste to be managed, waste management facilities, environmental protection, waste minimisation and reuse, recovering waste, disposal, other waste issues such as scrap yards, power station ash, special waste and anaerobic digestion, site reclamation and site management.

1. Introduction

- 1.1 This document provides a schedule of both core and local evidence base documents produced by all eight predecessor councils that have informed adopted Development Plan Documents. The Schedule of Planning Policy Evidence Base Documents for North Yorkshire was approved by the Executive Member For Planning For Growth on the 13th March 2023.
- 1.2 This schedule may be useful to prospective applicants, developers and other interested parties in providing guidance and advice relevant to planning applications, and in assisting planning officers in assessing development proposals.
- 1.3 The schedule comprises of two parts:
- Part 1 relates to core evidence. That is evidence that is common to all Development Plan Documents including local plans prepared and adopted across North Yorkshire e.g., Strategic Housing and Employment Land Availability Assessment, Strategic Housing Market Assessment, Strategic Flood Risk Assessments, Employment Land Review, Viability Assessment, Infrastructure Delivery Plan etc.
- Part 2 relates to local/other evidence. That is evidence that has been prepared to inform Development Plan Documents, including adopted development plan policies that are specific to a particular area or theme e.g., relating to housing mix and density, allocated site selection process, green infrastructure & biodiversity, Local Green Space, AONBs, water resources, gypsy & travellers, tourism etc.
- 1.4 Web links to each evidence base document is provided within the tables below. In addition, web links to general evidence base webpages, where they exist for each North Yorkshire predecessor authority is provided at the end of the document.
- 1.5 Whilst all efforts have been made to ensure the information within the schedule is correct, it is not intended to amount to advice or authority on which reliance should be placed. It is important to note that as some of the evidence listed is several years old, it should not necessarily be relied upon for making decisions. Users of this schedule are advised to contact the relevant council officers to discuss specific development proposals as necessary.
- 1.6 North Yorkshire Council is required to prepare a new Local Plan for the whole of the North Yorkshire area (excluding the designated National Parks). A new evidence base will need to be prepared to shape this new local plan. This schedule is important as the existing evidence base listed below will be the starting point for and feed into this new local plan evidence base. The Schedule of Planning Policy Evidence Base Documents is a living document and will be updated as the evidence base for the new North Yorkshire Local Plan is prepared and published.

1.7 It should be noted that a North Yorkshire Consolidated Planning Policy Framework has also been prepared. The aim of this Framework is to provide clarity for applicants, potential developers, Councillors, and officers on which statutory and non-statutory planning documents planning applications will be considered against once the new unitary North Yorkshire Council is formed on the 1 April 2023. The Framework should be read alongside this Schedule and can be viewed here [include weblink]

2. Spatial Theme Definitions

Each document listed in the schedules below have been categorised into the following spatial themes.

General development principles	may include development / locational strategy, the location and scale of new development, settlement hierarchy, sequential approach to development, settlement boundaries, green belt designation, development in the open countryside, general design principles and sustainability criteria such as flood risk, erosion, land instability, pollution and contaminated land. These general overarching policies will often apply to all forms of
	development and can cut across all the other spatial themes.
Housing	may include overall housing land supply provision, housing land allocations, housing mix & density, previously developed land, provision of affordable housing, provision for gypsies and travellers, provision of specialist housing e.g., or older people, residential development in town, district & local centres, conversions, existing housing stock, extension and alterations to existing housing.
Economic development and	may include overall employment land supply provision, employment land allocations, cultural and tourism
tourism	development, visitor accommodation including camping and caravanning, tourist attractions, the rural economy and farm diversification.
Retail and Town Centres	may include distribution of growth in retail floorspace and other town centre uses, vitality and viability of towns and villages centres, retail hierarchy, primary and secondary shopping areas, edge-of-centre and out-of- centre retail or related development, town centre development opportunities, underused floorspace in retail areas, open air retailing and farm shops.
Built environment	may include historic and built environment, conservation areas, listed buildings, archaeology, other heritage assets (scheduled monuments, parks and gardens, battlefield sites etc), public realm and public art.
Natural environment	may include countryside & landscape relating to sites of international and national importance for nature conservation, sites of local or regional nature conservation significance, protection of species, biodiversity and geodiversity sites, wildlife networks, green infrastructure networks, green wedges, Local Green Space designations, landscape character, areas of high landscape value, best and most versatile agricultural.
Design	May include design guides and design codes, general layout and design principles, sustainable design and construction, ensuring development is accessible, designing out crime, shop fronts and advertisements etc.
Recreation and open space	may include parks and gardens, provision of new open space, sport and recreational facilities, children's play, strategic open spaces, golf courses, countryside activities, recreational footpaths, cycleways, bridleways and waterways.

Transportation	may include road network, road schemes and major road improvements, minor road improvements, traffic management, rail services, and freight, provision for buses, cyclists and walking, traffic implications of new development, parking standards and highway directional signage.
Community facilities and infrastructure	may include community centres, meeting halls, educational establishments, public houses, religious buildings and libraries, healthcare facilities, utilities infrastructure such as electricity, sewerage, gas and water supplies, telecommunications development and planning conditions and obligations.
climate change, flooding and coastal change	may include flood risk, drainage and sustainable drainage systems, water resources & supply, water quality and ground water, land and air quality, renewable and low carbon energy, reducing greenhouse gas emissions, coastal changes, risk of overheating from rising temperatures,
