# **Relocation of Harrogate Tourist Information Centre**

## Report of the Corporate Director [Community Development].

## 1.0 PURPOSE OF REPORT

1.1 To approve the relocation of the Harrogate Tourist Information Centre to the Royal Pump Room Museum.

#### 2.0 SUMMARY

2.1 This report outlines a proposal to relocate the existing Tourist Information Centre in Harrogate, to the Royal Pump Room Museum. This will enable longer, more reliable opening hours and reduce staffing demand.

#### 3.0 BACKGROUND

- 3.1 The Tourist Information Centre (TIC) in Harrogate is currently located at Royal Baths, Crescent Rd, Harrogate. The Royal Pump Room Museum is located at Crown Pl, Harrogate, approximately 150metres away. The Pump Room is well located close to a number of other tourist sites and to the town centre. Both sites are currently staffed by Visitor and Experience Assistants who works across these two venues in addition to The Mercer Art Gallery and Knaresborough Castle. It is challenging to provide adequate staffing cover across all sites within the current staff numbers available and there have been a number of occasions when staff have had to work alone and where sites have been closed due to a lack of staff to cover.
- 3.2 The TIC has experienced reduced numbers of visitors in recent years. This is in line with national trends and changes in the way customers access tourism information, with more use of digital content and mobile devices to access information. The centre typically attracted around 135,000 visitors pre-Covid in 2019, dropping to 68,000 last year.
- 3.3 Visitor insight data suggests that a large number of visitors visit both sites, with 65% of those visiting the Pump Room Museum also visiting the TIC on the same trip.
- 3.4 It is common in other parts of the County for TIC facilities to be located within visitor attractions, rather than at standalone sites. Craven Museum in Skipton recently underwent a major refurbishment and now incorporates both a TIC function and services for visitors alongside the museum front of house.

#### 4.0 ASSESSMENT AND FINDINGS

4.1 An assessment of options has been undertaken and the preferred proposal is that the current Tourist Information Centre relocates to the Royal Pump Room Museum. This will enable more efficient use of staffing resources and reduce lone working.

- 4.2 There should be minimal impact on customers, the Royal Pump Room Museum is located a short distance away and the opening hours are similar, with slightly longer hours available at the Pump Room Museum.
- 4.3 The TIC in the Pump Room Museum will be staffed by the Visitor and Experience Assistants who work across the TIC and cultural sites in Harrogate, as is currently the case. The proposal is a more efficient use of resources, given the reducing number of visitors to TIC's and frees up the current building for alternative uses, with potential for additional income generation through letting the space for an alternative use.

#### 5.0 CONSULTATION UNDERTAKEN AND RESPONSES

- 5.1 The proposal has been discussed with affected staff who are supportive of the proposal.
- 5.2 The portfolio holder for Culture, Cllr. Simon Myers has been consulted and is supportive of this proposal.

#### 6.0 CONTRIBUTION TO COUNCIL PRIORITIES

6.1 Tourism contributes to supporting a strong economy – a key Council priority. The retention of a local TIC service in Harrogate supports the principles of locality working by providing local access and services.

#### 7.0 ALTERNATIVE OPTIONS CONSIDERED

7.1 Alternative options considered were:

Option one: No Change

- 7.2 To maintain the status quo was not considered an efficient use of resources and unless additional staffing resource were allocated would continue to result in difficulties in staffing leading to occasions when the site was closed at short notice and periods of lone working.
  - Option 2: close the site (and not relocate)
- 7.3 This is not recommended. Whilst visitor numbers are declining it is felt important to maintain access to the service to support tourism within the area and to provide services for those who are unable or prefer not to use digital services.

#### 8.0 IMPACT ON OTHER SERVICES/ORGANISATIONS

- 8.1 This proposal releases a building currently occupied by the TIC, which is owned by the Council. There is flexibility to seek an alternative use/tenant for the site which can generate additional income for the Council.
- 8.2 TIC services will continue to be maintained so there should be minimal impact on other services or organisations.

## 9.0 FINANCIAL IMPLICATIONS

- 9.1 Currently NYC cover the costs of the service charges, energy supply, maintenance, waste collection, cleaning costs & rates for the unit. The annual cost of this provision (minus general maintenance other contingency costs) is £24,300.
- 9.2 The estimated rental value of the unit, should we vacate the TIC and lease the unit out to a third party, is between £30-40k per annum. There would be some one-off costs e.g. minor

refurbishment, marketing etc. associated with preparing to lease the property. As a Listed Building there would be no rates payable by the Council during any vacant period between tenants.

9.2 This proposal will utilise existing staff, so there is no saving on existing staffing budgets, however, in the event that the standalone TIC remained this would have resulted in a need for additional staffing resources to maintain reliable service and address lone working concerns.

#### 10.0 LEGAL IMPLICATIONS

10.1 No implications.

#### 11.0 EQUALITIES IMPLICATIONS

11.1 An Equalities impact screening has been undertaken. The Royal Pump Room Museum is an accessible venue and there are no impacts for people with protected characteristics. See Appendix A.

#### 12.0 CLIMATE CHANGE IMPLICATIONS

12.1 A climate change screening has been completed. This proposal does not warrant a full CCIA to be undertaken at this stage. The proposal will have a negligible impact on climate change. See Appendix B.

#### 13.0 PERFORMANCE IMPLICATIONS

13.1 This proposal will improve the Tourist Information Service by co-locating with another visitor attraction. The ability to deploy staff in a more effective manner will also mean longer opening hours for visitors as below:

The TIC previously opened 10:00 – 16:00 Wednesday – Sunday

From April 2024 the TIC service based at the Royal Pump Room Museum will be open 09:30 – 17:00 Tuesday to Sunday

#### 14.0 POLICY IMPLICATIONS

14.1 No direct implications.

#### 15.0 RISK MANAGEMENT IMPLICATIONS

15.1 This proposal reduces service risk. It provides for a more efficient way of operating and reduces the incidence of lone working for staff.

# 16.0 HUMAN RESOURCES IMPLICATIONS

16.1 No specific implications. The proposals have been discussed with affected staff who are supportive of the proposals.

#### 19.0 CONCLUSIONS

19.1 The relocation of the Harrogate TIC to the Royal Pump Room would result in no loss of service for customers, would enable services to be delivered in a more efficient way, and would result in a saving to the council of £24,300 from energy and service charge costs. There would also be opportunity to lease the unit externally, generating additional income for NYC.

#### 20.0 REASONS FOR RECOMMENDATIONS

- 20.1 To provide a more efficient model for the delivery of TIC services in Harrogate, taking into account reducing visitor numbers, changing patterns of use and the current level of staffing resource.
- 20.2 To provide savings efficiencies for NYC.

## 21.0 RECOMMENDATION(S)

i) That the Executive Member approves the relocation of the Harrogate Tourist Information Service to the Royal Pump Room Museum.
